Sub: Partial modification on Standard Operating Procedure (SoP) for the contribution of ULB share in Infrastructure Development (ID) Work for State Share release under Housing for All (U) -Banglar Bari, West Bengal
Sir/ Madam,

In continuation with the previous Standard Operating Procedure (SoP) for the contribution of ULB share in Infrastructure Development (ID) Work for State Share release under Housing for All (U) -Banglar Bari, West Bengal (Vide Letter No. SUDA-624/2020/9508 dated 24.02.2020), infrastructure development is one of the components of the Housing of All (U) – Banglar Bari programme wherein 10% of the total project cost of a particular year is the allocation for the infrastructure development works of the project area. ULBs make a contribution of 5% and State makes the balance contribution of 5%. with a unit cost of 3.68 lakh for a Dwelling Unit (DU) the allocation for the ID is Rs.36,800/- @Rs.18,400 as the contribution for ULB & the State.

In view of the Covid-19 pandemic, it is understood that the revenue collection has been significantly affected. Therefore, on submission of different ULBs and on careful consideration with the approval of the UD&MA department ULBs are permitted to utilize 14th / 15th Finance (Untied Grants) or any other untied grant as ULB contribution for the Infrastructure Development (ID) works. On receipt of the payment certificate duly authenticated by the Executive Officer, Finance Officer & Chairperson/ Commissioner of the ULB's the proportionate State Share of the ID works to be released from SUDA.

The SoP is to be followed for entitlement to receive allotments for ID work under the Housing for All (U) - Banglar Bari Programme.
