## Sir/Madam,

Apropos the captioned subject, the State Level Sanctioning and Monitoring Committee (SLSMC) chaired by the Chief Secretary reviewed the 'Banglar Bari' Scheme on 17th September, 2021. It was decided at the meeting to ascertain the residual demand for dwelling units for 'Banglar Bari' Scheme under the BLC vertical. To reiterate the prospective beneficiaries fulfilling the following conditions to be entitled for sanction of dwelling unit.

- i) Prospective beneficiary not having Puccua House across the country
- ii) Having land to construct Dwelling units with minimum 32.18 sqm. build up area.
- Monthly family income does not exceed Rs. 10000/iii)

You are requested to prepare & submit DPR in consultation with Nodal SLTC for the prospective beneficiaries after fully ascertaining the fulfilment the above conditions by the beneficiaries, most importantly clear title of land.

The submission of DPR should not be treated as the confirmation of sanction for dwelling units. As you are aware the sanction will be finally accorded by the Central Sanctioning and Monitoring Committee (CSMC) of the Ministry of Housing & Urban Affairs, Govt. of India with recommendation from the SLSMC.

DPRs may kindly be submitted within 31.12.2021.
