Sir/ Madam,

Apropos the captioned subject, as you are aware as a matter of policy payments for all centrally sponsored schemes including the Banglar Bari scheme are now mandatorily made through the Public Fund Management System (PFMS). While all ULBs have started processing payments through the PFMS but some operational issues have been identified. In this regard beneficiary reflection while validation by the PFMS server is taking upto 15 – 30 minutes but validation from the Bank in some cases is taking more than 48 hours even upto 10 days or more. To address this issue, all ULBs are hereby advised to register beneficiaries due for payment / to be due for payment of instalment(s) under the Banglar Bari Scheme within 15th March, 2022 for Dwelling Units grounded and ongoing for projects sanctioned upto the year 2019-20.
