Sub: Service Condition of Health Officers appointed in different Urban Local Bodies in West Bengal.

Sir.

I, on behalf of our Association draw your kind attention to the following facts: -

- 1. In 1994, 60 Health Officers have been appointed by Government of West Bengal against permanent post vide different urban local Bodied under section 60 of W. B. Municipal Act, 1993 (Previously Sec. 66 of Bengal Municipal Act, 1932) by a Competent Selection Committee under Chairmanship of Directors of local Bodies.
- 2. The Health Officers have rendered Yeoman's Service to the people and govt. of W. B. by Implementing All National Health Programme like Pulse Polio, Leprosy, T. B. (Dots), Filaria, School Health Check up Prog. etc. apart from routine Public Health works including Birth & Death Registrations, Conservancy food Licencing etc. vide job chart of Municipal Affairs Deptt., Govt. of West Bengal No. 155/ MA/0/C-9/2A-5/96 dt. 6.11.1998 under section 53(1) of West Bengal Municipal Act., 1993.
- 3. Despite being whole time employees against permanent Post for 12 years service the Health Officers are not yet absorbed into a permanent Cadre and were compelled to continue their service at a paltry consolidated pay of Rs. 4,000/- p.m. which was marginally increased to Rs. 5,000/- p.m. as contract service w.e.f. 1.4.1998 and subsequently Rs. 8,000/- p.m. w.e.f. 1.6.2004 It is to be noted here that entry level scale of pay of any Doctor in W. B. Health Service or Kolkata / Howrah Municipal Corporation stands at Rs. 8,000-275-13,500 p.m. More ironical is the fact that the Medical Officers employed under Municipalities and working under our direct supervision enjoy the above scale of pay.

It is also worthy to mention here that the Health Officers, Prior to our recruitment, used to enjoy a commensurate timescale of Pay, Prevalent at that respective time.



Under section 53(1) of West Bengal Municipal Act, 1993, Government in the Department of Municipal Affairs, Government of West Bengal, is empowered to appoint Health Officers in Municipalities. But in the absence of any specific duty chart for Health Officer, Municipalities have been facing difficultires to allot work to the Health Officers appointed for the management of work of municipalities, In view of the circumstances, the undersigned is directed to say that the Governor has been pleased to prescribe the following duties and responsibilities for the Health Officers appointed by this Department in different urban local bodies.

-)1) He_will wesponsible for proper execution of all public health measures, adopted by the concerned municipality;
- 02) He should arrange for systematic inspection and enquiry in respect of sanitary condition an municipal areas through the employees appointed for such work and take stops or advise the municipality for their effective improvement;
- 03) He will take steps for prevention and control of endemic communicable diseases and health hazards as well in the areas of municipality;
- 04) He will arrange for regular inspection of water supply condition and sal of foods sold at various sources/consumer ends and arrange for their analytical/clinical examination to avoid health hazards. He will inspect from time to time the sanitary conditions of cinema halls, hotels, astaurants, nursing homes etc. within the jurisdiction of municipality;
- 305) He will cormulate schemes for improvement of health of the residents of the municipal area;

- He will exercise supervision and administrative control of all personnels working under health wing of the municipality;
- 07) He will advise municipal authority on all health matters of the municipality;

- 08) He will supervise from time to time places of disposal of dead bodies and take effective steps for such disposal to prevent
- 09) He will act as Registrar of Pirth and Death for all events of birth and quath in munic that area and arrange for issuing the cirtificates of all events as per existing Covernment Rules;
- 10) He will have a control over all offensive trades and recommend for licence for such trace;
- 11) He will implement health based programmes like ICDS, CUDP,
- 12) He will perform such other duties as assigned by the Chairman from time to time;
- 13) In course of discharge of his duties, he may consult Medical Officer and/or an officer in the Health Wing, if any, in the same municipality.
