Sir.

Uniform HMIS format and family schedule have recently been developed for all ongoing community based Urban Health Improvement Programmes.

A training programme to re-orient all grass root level health functionaries on the new HMIS format will-special emphasis on service components is being organized by the CMU, KUSP very soon for all 40 KMA ULBs leaving aside Kolkata Municipal Corporation being a non KUSP beneficiary local body. Since the uniform HMIS format is to be introduced to CUDP-III, CSIP & IPP-VIII under KMC, all grass root level health functionaries working in these programmes will have to be imparted re-orientation training also.

As there is no allotment of funds for organizing training programmes under UHIPs being implemented by KMDA, you are requested to include KMC for such training as is being planned for other 40 KMA ULBs by the CMU.
