Guideline for accessing for KUSP fund under Health component during 2007-2008

- ➤ The allotment for 5 years which will be available to ULBs in KUSP programme has been communicated vide memo no. CMU-146/2004(Pt. II)/2080(40) dt. 16.02.2006. The total available fund in 5 years under Health component is Rs. 1750.00 lakhs, out of which 90% i.e. Rs. 1575.00 lakhs will be made available to the ULBs on the basis of population (2001 census) and 10% i.e. Rs. 175.00 lakhs will be made equally available to the first 10 (ten) ULBs based on performance in Health sector to be judged in a few simple parameters. The list of first 10 (ten) ULBs will be intimated in due course.
- The ULB-wise allotment for FY 2007-08 is enclosed at Annexure I. This allotment will be available only after "Mid Term Funding Block" is lifted by DFID.
- An indicative list of Health activities which can be taken up from KUSP fund is given below:
 - Capacity building of Health functionaries.
 - Strengthening of health services provision at various level i.e. Sub-Centre, Health Administrative Unit, ESOPD, Maternity Home, Diagnostic Centre and referral.
 - Implementation of Public Health Programmes.
 - Special health care services like adolescent care, geriatric care, child to child care, health insurance and the like.
 - IEC
 - HMIS
- For utilization of KUSP Health fund, the following steps have to be followed:
 - Preparation of Detailed Project Report (DPR) of the scheme as per provision made in the KMPC approved DDP (Draft Development Plan) and ADP (Annual Development Plan) of 2007-08 prepared by ULB.
 - The ADP prepared in accordance with approved DDP shall be sent with the scheme to the Project Director, KUSP latest by 12.06.2007.
 - The Detailed Project Report for each of the schemes shall include the following
 - a) Cover Page
 - b) List of Contents
 - c) List of Annexure, if any
 - d) List of abbreviation, if any

- e) Executive Summary (1 page) : Amongst others it shall contents reference of the provision made in the DDP (Financial Plan) and ADP (Financial Plan) in terms of Volume no. / Chapter no. / Page no. etc.
- f) Project Details

 - (iii) No. of beneficiaries indicating coverage of poorer & marginalized ones
 - (iv) Justification
 - Activities to be undertaken for implementation of project and by whom

- A maximum of 60% of total project cost can be utilized for construction activities and / or procurement of ambulance. Rest 40% of project cost can be utilized for procurement of equipment, furniture, medicine, conduct of training programmes, delivery of primary health care services and IEC activities.
- In the case of construction activities, the drawing, design and cost estimate is to be approved by the Engineering Expert of CMU.
- Fund can not be utilized for purchase of land, vehicle (excepting ambulance).
- CMU will accord Administration Approval & Financial Sanction (AA & FS) to the ULBs for taking up activities based on Detailed Project Report after verification with DDP & ADP.
- CMU will not provide any additional fund, beyond the AA & FS amount. If the project expenditure exceeds the AA & FS, the ULB is to accommodate the additional amount from its own resources.
- The Health activities under KUSP can only be started after receipt of Administrative Approval & Financial Sanction from CMU.
