



Implementing Central and State Government Health programmes in the urban area, as primarily been, the role of the municipality in the area of Public Health. In addition, there are other health services, which the municipality provides, under the aegis of the West Bengal Municipal Act, 1993. These services include preventive measures for checking the spread of dangerous disease (vector control), providing immunisation including public vaccination and inoculation, registering an event of birth and death, construction, maintenance and operation of dispensaries, ambulance services, issue of food licence, to name a few.

There is a Sub Divisional Hospital within the Basirhat municipal boundary which serves not only the residents of Basirhat Municipality but also people from surrounding panchayat areas. There are some private nursing homes rendering satisfactory services to that part of population who can afford the cost. At present, Matri Sadan has total 12 nos. of bed and 2 G.N.M. nurses. Free Immunization Camps are conducted every Thursday at 10:00 AM to 2:00 PM.

At present the following benefits are extended to the patients:-

- 1. i) ECG ii) USG iii) Pathology iv) Indoor with Bed v) OPD -Medicine, General, Surgical, Gynecology + obstetric, Eye and Dental, Pediatrics, Cardiology, Dermatology.
- 2. Daily average OPD patients are around 150.
- 3. Indoor 6 bed permission & 6 beds Emergency.

4. Indoor capacity is found to be insufficient to demand. So long local general physicians and specialist doctors of the above wings have kind enough to render their service almost honorary.
