





#### MEMORANDUM

Sub: Engagement of Health Officer under CBPHCS Scheme

Clarifications on a number of points in connection with this Department Notification No. 451/MA/C-10/3S-55/2005 Pt. dated 22.4.2008 regarding the captioned subject, were sought by different ULBs from time to time.

The Govt. in this Department is pleased to clarify the points raised as follows

- The contractual remuneration to be reckoned as indicated in the said Notification, may however differ from time to time arising out of difference of the rate of D.A. admissible on the date of contractual engagement or date of renewal of contractual engagement of a H.O. but in no way it will include M.A. or H.R.A. or N.P.A or increment in Pay or other allowance or benefit. However, total contractual remuneration will remain unaltered for one year counted from the date of contractual engagement.
- Contractual engagement will be made for one person for one ULB for 1(one) calendar 2. year and thereafter if found satisfactory, it may be renewed for further 1(one) year with a gap of atleast 1(one) day between two contracts and so on, until any communication is made in the meantime, otherwise.
- 3... The contractual remuneration to the Health Officer is to be paid out of the fund allotted on account of CBPHCS Scheme.
- Reservation of post for SC/ST/OBC shall be Governed by the existing Circular of the Govt. But there is no mandate to reserve a post for any category having single contractual employee of that post.
- The maximum age limit for contractual engagement of a candidate for the first time is fixed at 32 years on the last date-of-birth subject to the relaxation as per Govt. rules for candidates belonging to SC/ST/OBC categories
- The Health Officer so engaged shall be entitled to leave as admissible under Rule 213 of the West Bengal Service Rules, Part-I of the Govt of West Bengal.
- The Chairman of the concerned ULB or any person designated by him for the purpose shall act as the leave sanctioning authority. In case of any dispute as to the leave, the matter will be settled by the DLB., West Bengal.

- 5. This order entails discontinuation of the same time of Medical Officer who are now continuing in the Urban Local Bodies on contractual pay of Rs.300- per day subject to a maximum of Rs.6000- p.m.

#### **MEMORANDUM**

Sub: Engagement of Health Officer under CBPHCS Scheme

Clarifications on a number of points in connection with this Department Notification No. 451/MA/C-10/3S-55/2005 Pt. dated 22.4.2008 regarding the captioned subject, were sought by different ULBs from time to time.

The Govt. in this Department is pleased to clarify the points raised as follows

- 1. The contractual remuneration to be reckoned as indicated in the said Notification, may however differ from time to time arising out of difference of the rate of D.A. admissible on the date of contractual engagement or date of renewal of contractual engagement of a H.O. but in no way it will include M.A. or H.R.A. or N.P.A or increment in Pay or other allowance or benefit. However, total contractual remuneration will remain unaltered for one year counted from the date of contractual engagement.
- 2. Contractual engagement will be made for one person for one ULB for 1(one) calendar year and thereafter if found satisfactory, it may be renewed for further 1(one) year with a gap of atleast 1(one) day between two contracts and so on, until any communication is made in the meantime, otherwise.
- 3.. The contractual remuneration to the Health Officer is to be paid out of the fund allotted on account of CBPHCS Scheme.
- Reservation of post for SC/ST/OBC shall be Governed by the existing Circular of the Govt. But there is no mandate to reserve a post for any category having single contractual employee of that post.
- 5.. The maximum age limit for contractual engagement of a candidate for the first time is fixed at 32 years on the last date-of-birth subject to the relaxation as per Govt. rules for candidates belonging to SC/ST/OBC categories
- 6.. The Health Officer so engaged shall be entitled to leave as admissible under Rule 213 of the West Bengal Service Rules, Part-I of the Govt of West Bengal.
- 7. The Chairman of the concerned ULB or any person designated by him for the purpose shall act as the leave sanctioning authority. In case of any dispute as to the leave, the matter will be settled by the DLB., West Bengal.







- 9. That your petitioner states that, your petitioner have made a representation dated 09.02.2009 before the respondent No.5 which was duly received by the said respondent authority vide Memo No.155 dated 16.02.2009 with the payer of continuation as 'Health Officer' after consideration for

relaxation of age bar for your petitioner vide SUDA adv vide SUDA advertisement dated 02.02.2009.

prescribed responsibilities mentioned therein, will cause preparation of monthly working statement and remuneration bill timely & regularly in respect of all of the above stated workers as well as of the F.T. Ss., H.H. Ws. deployed under CBPHCS Programme and will furnish the same to the Accountant of this Municipality duly been authenticated by the Medical Officer, at the end of each month for payment of the monthly remuneration through the Accounts Assistant.

This order will take immediate effect and will continue until further order."

Xerox copy of the aforesaid Memo dated 06.03.2009 is annexed hereto and is marked as Annexure "P-9".

- 12. That your petitioner state that the job responsibilities of a Medical Officer and the health Officer are same and identical but the respondent authorities without considering the representation dated 09.02.2009 and 27.02.2009 of your petitioner are all set to take steps in regard to fresh recruitment for the post of 'Health Officer' on the basis of Circular vide SUDA advertisement dated 02.02.2009, which is highly illegal and violation of natural justice.
- 13. That in any event the respondents officials are public officials and they are binding by the statute. Their acts and actions should be non-discriminatory, reasonable and rational basis. But in the instant case the acts and actions of the

respondents authorities are not only illegal but also arbitrary and violation of Article 14 of Constitution of India.

- 14. That your petitioner is legally entitled to continue in the service in the said post because petitioner has been rendering service to the said post for last one year and your petitioner is also entitled to get pay scale of Rs.8,000/- to Rs.13,500/- according 5th pay commission report framed by the Finance Departments, Government of West Bengal.
- 15. That being aggrieved by and dissatisfied with the impugned recruitment notification for the said post (Annexure P-5 to this petition) your petitioner begs to move this application in the following amongst other:

#### **GROUNDS**

For that in any event your petitioner is working as Medical Officer to the said post since 1st February, 2008 continuously without any break with the fullest satisfaction of the respondents authorities more than one year and as such question of further holding of interview for the said post for the Sainthia Municipality does not arise at all. From the aforesaid facts and circumstances it is crystal clear that the impugned recruitment notification for the post of Medical Officer for community based primary health care service under Sainthia Municipality can not be sustained in the eyes of law and the same is liable to be set aside and/or quashed.

That unless an order is passed to cancel and/or quash the impugned notification for recruitment to the post of Health Officer for community based Primary Health Care Service under Sainthia Municipality and directing the respondent authorities to allow the petitioner to work and continue in the said post, otherwise your petitioner will suffer irreparable loss and injury.
  - 17. That your petitioner states that the balance of convenience and inconvenience as prayed for the interim orders are absolutely in favour of the petitioner.
  - 18. That the respondent authorities is going to take interview for recruitment to the said post. Considering the urgency your petitioner is praying for an

interim order for stay the operation of the impugned recruitment notification for the post of Medical Officer for community based primary health care service under Sainthia Municipality and not to hold interview for the said post under Sainthia Municipality and your petitioner want to move this application within the prayers for obtaining exparte interim orders by dispense with the Rule 26 of the Appellate Side Rules.

- 19. That no other application on the self same cause of action is filed by the petitioner earlier.
- 20. That your petitioner has no other alternative same and except to file this writ petition for ventilating his grievance and for get the remedy.
- 21. That the records and documents of this case are laying at the offices of the respondents which are within the Appellate Side Jurisdiction of this Hon'ble Court.
- That this application is filed for bonafide and for the ends of justice.

- Mandamus commanding the respondents their men, agent, servant each one of them particularly the respondent No.4 & 5 herein to give the pay scale Rs.8,000/- Rs.13,500/- as admissible according to 5th pay commission report of the Finance

Department, Government of West Bengal.




