

AGREEMENT


This Agreement made this day of 21st August 2000, between the Adviser(Health), SUDA, Calcutta, having its office at ILGUS Bhavan, HC Block, Sector-III, Salt Lake City, Calcutta-700091 for and on behalf of the State Urban Development Agency (here in after referred to as SUDA), "the Purchaser", the one part and M/S Parijat Printers, carrying of business at 7, Gurudas Dutta Garden Lane, Calcutta-700 067, (hereinafter referred to as "the Supplier" of the other part).

1.WHEREAS the Purchaser is desirous that FAMILY SCHEDULE shoul be provided by the Supplier and has accepted a quotation for the supply of said item of materials. Brief particulars of the materials which shall be supplied by the Supplier are as under:

2. NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- i) In this agreement words and expressions shall have the same meaning as are respectively assigned to them in the conditions of the contract referred to.
- (ii) The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.,
 - (a) the General Terms and Conditions of the Contract. Annexure I
 - (b) the Special Conditions of the Contract. Annexure II
 - (c) the Purchaser's Notification of Award Annexure III
- 3. In consideration of payments to be made by the purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the items of Materials of Contract and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Purchaser hereby covenants to pay the Supplier in consideration of the provisions of the items of Materials of contract and remedying of the defects therein, the Contract price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
- In the event of unresolved dispute, the same shall be referred to the Central Tender Committee, Health wing, SUDA, and its recommendations shall be final and binding on the parties.
- 6. Time Schedule as will be specified in the supply order shall be reckoned as the essence of this Agreement, in case of, breach of any of the covenants of this Agreement, SUDA in its discretion shall be at liberty to terminate this Agreement and forfeit the entire amount of security deposit.

General Terms & Conditions of the Contract

- 1. If the supplier shall be hindered in the supply of the materials so as to necessitate an extension of the time allowed in the Quotation Notice, he shall apply in writing to the Adviser, Health, SUDA who shall grant it in writing if reasonable grounds be shown for it, and without such written authority of the Adviser, Health, SUDA, applied for and obtained prior to the expiry of the original date provided for in the Quotation Notice, the supplier shall not claim exemption from the fine leviable as mentioned in Clause 1- Special Conditions of the Contract.
- The supplier should remain bound to allow purchasing authority/ or authorised persons
 or agents to inspect items at any time during the process of manufacture or finishing
 before acceptance of supply.
- 3. All damages payable by the Supplier under the terms of this contract may be deducted from Security Deposit and / or any other sums due or which become due to him by SUDA.

Special Conditions of the Contract

- 1. The supplier is to deliver the materials on or before the dates mentioned in the Quotation Notice, failing which the supplier shall be bound to pay or allow one percent on the total amount of the contract for every day not exceeding ten days that the supplier shall exceed the time for delivery and by way of liquidated damages. Provided, however, that the Adviser, Health, SUDA may in his discretion reduce, in such cases as he may think fit, the said amount to such smaller amount as he may decide and his decision in writing in that respect shall be final.
- 2. In every case, in which the payment or allowance mentioned in clause 1 shall have been incurred for ten consecutive days, the Adviser, Health, SUDA shall have power either to annal the contract altogether, or to have the supply completed without further notice at the supplier's risk and expense as he may deem best suited to the interest of SUDA, and the supplier shall have no claim for compensation for any loss that he may incur in any way.
- The materials shall be strictly in accordance with the specifications and the supplier shall receive payment for such materials only after acceptance and approval by the competent Authority.
- 4. In the event of the material being considered by Adviser, Health, SUDA found to be inferior to that described in the specification, the supplier shall on demand in writing, forthwith remove the same at his own charge and cost, and in the event of his neglecting to do so within specified period, such rejected materials to be removed at the supplier's risk and expense, the expense incurred being liable to be deducted from any sums due or which may become due to the supplier.
- The decision of the Adviser, Health, SUDA shall be final, binding and conclusive on all questions relating to the meaning of the specification.

Total No. of 18 bidders participated in the Bidding procedure. CTC members examine the bidding document submitted by the bidders, reports of bid opening, evaluation of bids and drug wise comparative statement of rates.

It's found that out of 105 required pharmaceutical, the rates of 79 items bidded by one or more bidders, but no rate for 26 items have been quoted.

The recommendation of the Central Tender Committee are as below:

1. The lowest rate for 61 items for which two or more bidders quoted the rate have been recommended by the committee.

2. The committee has examined the guideline as laid down by the World Bank for acceptance of rate of single bidded items and recommended the rates of single bidded items.

3. The committee also examined the papers for procurement of 50,000 copies of Family Schedule for RCH- Sub Project Asansol and recommended the rate of M/s. Parijat Printers who is the lowest bidder of out of three quotations in this regard.


