10. Your petitioners state that pursuant to such letter dated 13.7.2006 the petitioners duly went to attend the said final selection on 25.7.2006 at 12-00 Noon in Unnayan Bhawan at Salt Lake but on that scheduled date on final

permanent post took place due to the reason best known to the respondents. However, it is was intimated to the petitioners that fresh interview letters will be issued for final selection of the petitioners from temporary post to permanent post later on.

dated 24.7.2006 the respondent authorities intimated the petitioners that the final selection for the post of the W. Hony. Health Workers will be held on 2.8-2006 in Unnayan Bhawan, at Salt Lake, Kolkata instead of 25.7.2006.

without allowing the petitioners to participate in the said selection process the respondent authorities called for the said interview only for the purpose of direct selection in the said post from the outside of the job workers with a view to ignoring the claim of the petitioners for permanent absorption in the said post.

- in the said interview hall but they were not allowed to participate in the said examination by the concerned respondents only to select the candidates of their own choice who are not job workers at all which is totally illegal and unwarranted in the eye of law.
- alternative the petitioners including other 27 (Seven)

 Honorary Health Workers made a joint representation
 before the concerned respondents, on 31,0,2006 ventilating

their

their grievances therein it was specifically mentioned in the said representation that the Municipality Authority after considering the candidature called for the petitioners along with other 7(seven) candidates to participate the examination but unfortunately some of the candidate's eligibility criteria were rejected on the ground of age bar and others were not allowed to participa in the said examination only with a view to accommodate the candidates of their own choice by giving appointment in the said post, Accordingly those 10 (ren) Candidates requested the concerned respondents to consider the said representation sympathetically by which they can be permanently absorbed in the post where they are working for a long time and as they were appointed in the said post before a long , the ground of non-absorption on permanent basis cannot be denied on the ground of age bar.

16. Your petitioners state that in spite of rendering continuous service in the said post the concerned respondents are denying to allow the permanent status of the petitioners

in the said post, their status ought to have been declared as regular employee under the respondent authorities but the concerned authorities like anything is still ignoring such status of the petitioners in any manner whatsoever.

Your petitioners state that until and unless the status of the petitioners are being declared by the respondent authority, they are not entitled to give any fresh appointment to other candidate on permanent basis and the judicial pronouncement so far made by the Hon'ble Apex Court of India and the Hon ble High Court at Calcutta provide that such action of the State Authority are highly contrary to law and by conduct the temporary nature of service of the petitioners have been changed like anything rather they have already worked more than 9 years continuous service in the said post and the respective Appointing authority ought to have been considered on different footing and/or angle and thereby the petitioners are claiming to be absorbed in the permanent post having a necessary scale of pay including all other benefits

and

and subsequent to that namely after super-annuation the retifial benefits are required to be released which a permanent employee is entitled to get the same.

Your petitioners state that they have been 18. discharging their duties in the said post from their respective appointments getting appointment letters from the competent Authority and their status are required to be considered as regular employee under the concerned authority but the concerned respondents without considering the case of the petitioners are trying to give appointment in the said post to the candidates of their own choice in place of the petitioners herein on permanent basis. Unless this Hon'ble Court interferes into the matter and restrained the concerned respondents from taking any step and/or further steps from giving appointment to other candidates on permanent basis, your petitioners will be seriously prejudiced in as much as they will permanently loose their service for ever in spite of having discharged long service in the said post.

19. Your petitioners state that it is surprising enough that the concerned respondents have been utilising the service of the petitioners for a long time for which they are entitled to be protected under certain service rule but the concerned respondents as yet have not laid down any service condition of the petitioners and more to say their status as temporary in nature are not being taken into consideration because they have already rendered more than 9 years service and the authorities have forced the petitioners to uncertainty which is not permisible under the law and although the same is being done by the concerned respondents by treating the petitioners as temporary employee and also trying to oust the petitioners from their service but the situation has changed altogether because of the subsequent event namely the long rendering of their service under the supervision and control of the concerned respondents. It is to be noted here that the manner and procedure in which the respondents are acting in order to oust the petitioners from the zone of consideration

is violating

is violating of Article 14, 16 and 21 of the Constitution of India and apart from this the petitioners are also being deprived of getting their equal pay for equal work which hits the provisions of Article 39 of the Constitution of India.

- conduct of the respondent authorities that there is mo seturity, safety as well as protection of service of the petitioners and as a matter of fact the concerned respondents are making attempt to oust the petitioners from the said service; as a result of which the petitioners will out of employment at any day and the manner and procedure the concerned authorities is intending to oust the petitioners from the said post by engaging other candidates of their choice is contrary to the act and rules and the concerned respondents being the model employer cannot do so.
- 21. Your petitioners state that they are performing their service since a petty long time as such the said service

service should be regularised with immediate effect by introducing proper scale of pay and till such regularisation is made, their service should not and cannot be disturbed in any manner whatsoever but the concerned respondents are going to appoint other candidates in place of the petitioners at their sweet will and choice in their place resulted thereby the petitioners will be without any employment with immediate effect thereafter. It may be stated herein that after doing the job for a long time in the said post, the respondent authorities cannot snatch away the service of the petitioners at their sweet will and their choice, the petitioners recently came to know that as per interview for final selection held on Ist august, 2006 in the chamber of the OSD and in the said interview the petitioners were not allowed to participate the concerned respondents have already prepared a panel of the candidates of their choice and they have taken steps to appoint those candidates in place of the petitioners herein. As soon as the petitioners came to know about the said facts they made representations before the concerned respondents
