

It is to mention here that training of the HHWs is completed on 15.06.2007 and the regular HHWs have been engaged with effect from 28.06.2007. At present the HHWs are carrying out Baseline Health Survey. The ULB has already identified 2 Sub-Centres.

Apropos order of Dept. of Municipal Affairs with regard to sanction of personnel of M & S Cell this ULB is not entitled to have Medical Officer as their population is below 40,000 as per 2001 census. Moreover, post of Health Officer to 63 ULBs has not yet been sanctioned. As a result, the service activities such as ANC / PNC clinic, Immunization clinic, growth monitoring clinic and general treatment clinic will not be possible to organize by the ULB. It may be appreciated that not only service activities but also monitoring & supervision of day to day work of HHWs, scrutiny of Health survey data, Family Schedule and technical guidance on distribution of medicine at the door-step of the beneficiaries by HHWs are being jeopardized.

To tide over this critical situation, suggestion of the Chairman of the ULB and Municipal Level Health & FW Committee in terms of utilizing services of (i) a local Doctor at a daily fee of Rs. 400/- per day not exceeding 15 days in a month and (ii) one Nursing personnel at a daily fee of Rs. 80/- per day not exceeding 15 days in a month may be considered for till engagement of Health Officer.

This Urban Local Body is a small Municipality having only 9 wards with 12000 (approx) populations. We are implementing the Community based Primary Health Care Programme through our Municipal Level Health and Family Welfare Committee successfully since engagement of 9 HHWs on 28.6.2007.

The Government has kindly sanctioned posts of Sanitary Inspector, Health Assistant, Computer Assistant, Store-keeper and Accounts Assistant at the rate of one post in each category to be engaged on contract basis and we are preparing for finalizing their engagement, which we expect to do so by September, 2007. We have also selected the site for establishing two Sub Centres and expect to open the Sub Centres by end of this month. But without help of a qualified Doctor, it is not clear to us how the required medicines can be purchased and various clinics such as ANC/PNC clinics, immunisation clinics, growth monitoring clinic, general treatment clinics etc. can be organized. The help and cooperation of the nearest Sub Divisional Hospital is very uncertain as we have experienced. If we depend on them, we have to be sure that, entire Programme will be a failure and a time will come when mothers & children shall be demotivated not to come to the clinics. It is therefore requested to kindly sanction one part time Medical Officer for this Municipality at a remuneration of Rs. 400/= per day for 15 day's engagement and one nursing attendant at a monthly remuneration of Rs. 1200/= per month for both the Sub Centres to help the Doctors in the clinics as well as on other days of general outdoors treatment.

The president extended his warm welcome to members and initiated the discussion.

The Executive Officer informed the Committee that the sites for establishing two sub Centres in rented buildings, one at a place in the middle of ward no. 4,5 & 6 and another in the middle area of ward no. 7,8 & 9 have been selected. The Municipal Level community based primary Health care services committee (MLCBPHCS) gave formal approval to these sites and authorized the E.O. to communicate the same to the Health wing of SUDA for release of fund for purchase of equipments and furnitures and also the rent of the sub Centres.

This ULB has no Health Officer and accordingly only one Sanitary Inspector is in charge of entire Health related functions. We have been permitted to engage one Sanitary Inspector, One Accounts Assistant, One Computer Assistant, One Multipurpose clerk-cum-storekeeper and one Health Assistant on contract basis. The applications for these posts have already been received but the selection of candidates for these 5 (five) posts are yet to be done. It is resolved that since no post of Health Officer is existing in this ULB, one post of Sanitary Inspector as has been sanctioned will be engaged on contract in addition to the existing permanent post of Sanitary Inspector to take the load of extra job in health related all kinds of functions including public health and conservancy etc. The Health wing of the SUDA will be requested to give formal approval of this decision.

Another point came for discussion is that, since the ULB has a total population of not more than 12000, as per norm, is not entitled to engage any Medical Officer on contract. But the difficulty exists that while running the several clinics in the sub Centres and for purchase of required drugs and medicines within the list provided by SUDA, services of a Medical Officer is indispensable and also the service of a nursing attendant to help the M.O. along with the first tier supervisor of Sub Centre will be required. Moreover the services of the Medical Officer of the Local Sub Divisional Hospital is very uncertain and possibilities of their help is bleak as has been found in the last few months. It is therefore resolved that, the Health wing of SUDA will be moved by the Chairman to sanction engagement of one part time M.O. at a remuneration of Rs. 400/- per day for 15 days in a month and one nursing attendant at a remuneration of Rs. 1200/- per month for smooth running of clinics in the Sub Centre.

I like to draw your kind attention to the Memo No. HFW/CFW/331/HS-1003/07 dt. July 31, 2007 of the project Director, HSDI, Commissioner, Family Welfare and special Secretary, Govt of West Bengal addressed to CMOH, Cooch Behar, a copy of which is enclosed for your kind reference.

We have already formed Municipal Level Health and Family Welfare Committee to which you are one of the members. We have engaged female HSWs in 9 wards of this Municipality after imparting 45 days training to them. We have decided to open two Sub Centers during this month to provide preventive Health Care to all people and curative health care only to BPL populations of this Municipality through regular clinics to be organized in this Sub centers.

We propose to organize following clinics in these two sub centers from the month of February 2008 onwards:-

1st Week - Two treatment clinics in two sub centers and two Ante Natal/ Post natal and FW clinics in two sub centers.

2nd Week - Two Immunization clinics and two treatment clinics in two sub centers.

3rd Week - Two Growth Monitoring clinics and two treatment clinics in two sub centers.

4th Week - Two treatment clinics in two sub centers.

In the 4th week two Health Awareness Programme are also required to be organized.

We are trying to well equip the Sub centers with required medical equipments and medicines/ drugs, etc. but would be in a very difficult position unless we receive logistic support and assistance in the matter since this local body has no Health Officer at the present moment.

I request you therefore, to provide logistic i.e. Immunization Materials (Vaccine, Syringes, Immunizations Cards etc.), Vaccinator, FP Materials, ORS, Vit- A in Oil, IEC materials etc. and also to render all necessary assistance in CU-T insertion, MTP, Ligation, Hospital delivery, Diagnostic facilities etc.

Also I request you to kindly arrange that the services of Doctors and trained Nurses are available in the clinics. It would be appreciated if you kindly depute a competent Doctor to our Health Services in the third week of the month to finalize the calender for organizing clinics in these two sub centers.

Enclosed copy of communication of the Chairman, Mekligani Municipality bearing no. 669/X-HHWs/07-08 dt. 12.09.2007.

It is to mention here that training of the HHWs is completed on 15.06.2007 and the regular HHWs have been engaged with effect from 28.06.2007. At present the HHWs are carrying out Baseline Health Survey. The ULB has already identified 2 Sub-Centres.

Apropos order of Dept. of Municipal Affairs with regard to sanction of personnel of M & S Cell this ULB is not entitled to have Medical Officer as their population is below 40,000 as per 2001 census. Moreover, post of Health Officer to 63 ULBs has not yet been sanctioned. As a result, the service activities such as ANC / PNC clinic, Immunization clinic, growth monitoring clinic and general treatment clinic will not be possible to organize by the ULB. It may be appreciated that not only service activities but also monitoring & supervision of day to day work of HHWs, scrutiny of Health survey data, Family Schedule and technical guidance on distribution of medicine at the door-step of the beneficiaries by HHWs are being jeopardized.

To tide over this critical situation, suggestion of the Chairman of the ULB and Municipal Level Health & FW Committee in terms of utilizing services of (i) a local Doctor at a daily fee of Rs. 400/- per day not exceeding 15 days in a month and (ii) one Nursing personnel at a daily fee of Rs. 80/- per day not exceeding 15 days in a month may be considered for till engagement of Health Officer.

The expenditure required for the purpose may be met out of the A/C Head -"Operating Cost".

Madam,

This Urban Local Body is a small Municipality having only 9 wards with 12000 (approx) populations. We are implementing the Community based Primary Health Care Programme through our Municipal Level Health and Family Welfare Committee successfully since engagement of 9 HHWs on 28.6.2007.

The Government has kindly sanctioned posts of Sanitary Inspector, Health Assistant, Computer Assistant, Store-keeper and Accounts Assistant at the rate of one post in each category to be engaged on contract basis and we are preparing for finalizing their engagement, which we expect to do so by September, 2007. We have also selected the site for establishing two Sub Centres and expect to open the Sub Centres by end of this month. But without help of a qualified Doctor, it is not clear to us how the required medicines can be purchased and various clinics such as ANC/PNC clinics, immunisation clinics, growth monitoring clinic, general treatment clinics etc. can be organized. The help and cooperation of the nearest Sub Divisional Hospital is very uncertain as we have experienced. If we depend on them, we have to be sure that, entire Programme will be a failure and a time will come when mothers & children shall be demotivated not to come to the clinics. It is therefore requested to kindly sanction one part time Medical Officer for this Municipality at a remuneration of Rs. 400/= per day for 15 day's engagement and one nursing attendant at a monthly remuneration of Rs. 1200/= per month for both the Sub Centres to help the Doctors in the clinics as well as on other days of general outdoors treatment.

The president extended his warm welcome to members and initiated the discussion.

The Executive Officer informed the Committee that the sites for establishing two sub Centres in rented buildings, one at a place in the middle of ward no. 4,5 & 6 and another in the middle area of ward no. 7,8 & 9 have been selected. The Municipal Level community based primary Health care services committee (MLCBPHCS) gave formal approval to these sites and authorized the E.O. to communicate the same to the Health wing of SUDA for release of fund for purchase of equipments and furnitures and also the rent of the sub Centres.

This ULB has no Health Officer and accordingly only one Sanitary Inspector is in charge of entire Health related functions. We have been permitted to engage one Sanitary Inspector, One Accounts Assistant, One Computer Assistant, One Multipurpose clerk-cum-storekeeper and one Health Assistant on contract basis. The applications for these posts have already been received but the selection of candidates for these 5 (five) posts are yet to be done. It is resolved that since no post of Health Officer is existing in this ULB, one post of Sanitary Inspector as has been sanctioned will be engaged on contract in addition to the existing permanent post of Sanitary Inspector to take the load of extra job in health related all kinds of functions including public health and conservancy etc. The Health wing of the SUDA will be requested to give formal approval of this decision.

Another point came for discussion is that, since the ULB has a total population of not more than 12000, as per norm, is not entitled to engage any Medical Officer on contract. But the difficulty exists that while running the several clinics in the sub Centres and for purchase of required drugs and medicines within the list provided by SUDA, services of a Medical Officer is indispensable and also the service of a nursing attendant to help the M.O. along with the first tier supervisor of Sub Centre will be required. Moreover the services of the Medical Officer of the Local Sub Divisional Hospital is very uncertain and possibilities of their help is bleak as has been found in the last few months. It is therefore resolved that, the Health wing of SUDA will be moved by the Chairman to sanction engagement of one part time M.O. at a remuneration of Rs. 400/- per day for 15 days in a month and one nursing attendant at a remuneration of Rs. 1200/- per month for smooth running of clinics in the Sub Centre.

With reference to above, the following activities are to be undertaken by your ULB:

- The names of regular candidates (Nine nos.) only is to be listed and put up in the notice board of ULB, asking them to function as HHW with effect from 28th June, 2007 and inform Director, SUDA accordingly with regard to date of joining of HHWs.
- The Chairman of the ULB is to allocate the area of operation for each HHW.
- One HHW will cover a population not exceeding 1,000 BPL contained in a single ward. A ward having less than 1,000 BPL population will have one HHW.
- The HHW shall be responsible for Primary Health Care of BPL families under her jurisdiction and be responsible for both public health and health statistical data collection for the entire population within the ward
- The ward Councillor will monitor and supervise the activity at ward level.
- HHW Kit bag along with contents provided by SUDA is to be given to all the regular HHWs only.
- To start with, HHW will conduct baseline survey of the allotted BPL families as per the proforma already provided by SUDA, to be checked and scrutinized by HO / MO / SI, who will compile the data ward-wise and ULB-wise.
- Job responsibility of the HHW (working hours 12-00 Noon to 4-00 P.M. of each working day) is :
 - fortnightly home visit to each BPL families,
 - motivate the community to avail health services collection of data and filling up of Family Schedule.

These rental charges will only be applicable for the Sub-Centre accommodated in Club / CBO accommodation. There will be no rental charges for the Sub-Centre accommodated in municipal / community accommodation.
