A Report

The said meeting was chaired by the DM, Murshidabad and were participated by the ADM, SDO, CMOH, Dy, CMOH III, ACMOHs, BMOHs, Superintendents &other officials of District Health Office, and representatives of ULBs of Murshidabad District including the undersigned.

DM Murshidabad invited the Chairman of all ULBs along with Health Officer / Medical Officer Of CBPHCS, SI of The ULBs to attend the said meeting.

Out of seven ULBs, none from Murshidabad Municipality were present. Vice- Chairman & CIC-Health of Berhampore Municipality only attended the meeting. Out of seven HOs and Two MOs, only Medical Officer of Jiaganj- Azimganj Municipality was present. Each ULB excepting Murshidabad were represented by other staff.


At the outset, a presentation was made on the present status of ULBs relating to IPPI last round and RI.

The following issues were discussed:

- Involvement of Health workers in the team for implementation of IPPI is 92% in Berhampore Municipality and Nil in Jiaganj Azimganj Municipality, in other ULBs it is 100%. On looking back to the process of micro planning for IPPI, it came into focus that the planning are being done by the respect BMOH of District Health Office and they took lead to involve the Health workers. It is not that the ULBs are reluctant to include the Health Workers.
- Issue at Jangipur Municipality regarding involvement of additional man-power in the forthcoming SNID round was discussed. Health Dept. will not provide fund for involvement of additional manpower.
- Strengthening of Routine Immunisation activities Minutes of the meeting along with recommendation will be forwarded.
- A plan will be chalked out by the Dy. CMOH III to visit each of the seven ULBs for preparation of micro planning to strengthen RI.
- Stress was given for monitoring of RCH activities at ULB by the Municipal level Health & FW
 Committee once in a month at a fixed date.
- Need for more service centres at Dhuliyan Municipality and IEC to aware the community to accept the services.
- The undersigned stated that more no. of service centres may be accommodated under Urban RCH which will be coming shortly and Training of Health workers on RI for 25 days will be taken at District Nursing School wef mid-July,2012

The meeting ended with vote of thanks to the Chair.

DTF for June SNID, 2012 round was held on June 8, 2012 at the Conference Room of Old Circuit House office at 4-30 PM. DM, ADM(D), Dy. CMOH-II & Dy. CMOH-III, OC (Health), Various District Level Officers, ACMOHs, Superintendents of Subdivisions & Rural Hospitals, all BMOHs, SMOs (NPSP), Representatives of UNICEF, Rotary & Ambuja Cement has attended the meeting.

the DM & CMOH-in-Charge. Murshidabad has presided over the meeting. The meeting was interactive and action points discussed for each issues.

At the Beginning of the meeting Dr. Entekhab Alam (BHMS), Informer of AFP Surveillance has been felicitated by the DM & CMOH-in-Charge, Murshidabad for his exemplary contribution in the strongest pillar of Polio Eradication (Reported 70 AFP cases in 2010 & 97 in 2011).

Salient Action Points:

- 1. DM, Murshidabad has expressed his concern for quality of RI & IPPI status at Dhuliyan Municipality & has called for a special review meeting on 14th June 2012 inviting chairman of all urban bodies.
- 2. No leave of all categories of staffs will be allowed during IPPI activities without permission of CMOH, Murshidabad.
- 5 DM & CMOH-in-Charge has emphasised to sustain Active participation from all stakeholders. He instructed the Superintendents/BMOHs to take measures at Municipality/Block level involving Chairman/Sabhapati, BDO & CDPO to resolve any quality gap & boycott issues.
- ADMs will directly supervise IPPI activity of each Sub-division. One ADM to be deputed for each Sub-division. One Deputy Magistrate to be deputed for each block.
- GP wise MO distribution list for Training, Supervision & Monitoring to be submitted by 11th June 2012 to the Dy. CMOH-III. List of MO, area wise/ GP wise/ CDPOs/ Dy. Magistrate to be shared with DM before round.
- Letter to be issued by DPO, ICDS after consulting with DM, Murshidabad stating specific Instructions to CDPOs & AWWs.
- 7. All the Superintendents, BMOHs & MOICs are instructed to submit signed copy of Action plan in proper format by 12th June, otherwise IPPI fund will not be processed.
- Increase in XRs at Farakka & persisting Refusal at Suti-II has been highlighted along with refusal pockets at Non HP areas has been pointed as a threat to the high quality of activity achieved by the district in previous rounds. All the BDOs & PRI member has been requested to actively participate in conversion drives. Also Medical Officers from BPHCs. PHCs. RHs. SDHs & DH are strictly instructed to be proactive in their involvement.
- MO conversion data and HRA coverage data should be shared with the district with the final report from the block. Fund allotted for daily MO conversion, 2nd Day conversion in HP areas & Mobile teams for Migratory settings will only be released after receiving proper reports.
- III. Among the non High priority Blocks: Low X generation has been determined as a serious cause for concern & concerned BMOH's are instructed to take care of this.
- Superintendents, BMOHs, MOICs are instructed to send the Medical Officers and Supervisors with quality gap on 26/06/12 at 12 noon at CMOH chamber for necessary action.
- [2] All MOs must be present in evening meetings along with BDO, BMOH & CDPO.
- 15. Special Street survey on 23rd June 2012 to be done by Supervisors (Order sent earlier).

A Report

The said meeting was chaired by the Mayor, Asansol MC and were participated by the Commissioner, Asansol MC; Health Officer; Medical Supervisor; Public Health Nurse of Asansol MC; ACMOH, District Health Office and Supervisor of ICDS including the undersigned.

CMOH, Burdwan also participated at the end of the meeting as desired by the Mayor. The following issues were discussed:

- Inclusion of Municipal Maternity Home under RSBY it was stated that MH at Ward No. 28 conduct only normal delivery as there is only one Residential Medical Officer (RMO) existing for whom it is almost impossible to render 24 x 7 service without any break. Due to low remuneration it is difficult at local level to get service of the RMO. Furthermore, cesarean section could not be held at MH as there is no Gynaecologist and Anaesthesist. It was stressed by the Commissioner that at least an Administrative Official may be engaged out of Municipal fund initially to liaise with the beneficiary, TPA, Doctors & technicians and others for empanelment under RSBY. The proposal is under consideration of the Mayor.
- Strengthening of Routine Immunisation activities at present 50 immunisation sessions are being conducted weekly and there is a further need of 10 to 14 outreach sessions per week to cover the entire area of the Corporation including slums. It was stated that the First Tier Supervisors (FTSs) used to receive Rs. 50/- per session as alternate vaccine delivery fee relating to carrying of vaccines from the ILR to the vaccination site i.e. Sub-Centre. That funding had been provided by the District Health Authority ones. For the last one year there is no funding support from District Health Authority. CMOH, Burdwan stated that there is no such fund available at present. The Mayor decided to pay the due fund to the Health functionaries out of user fee fund of RCH Sub-Project. The Municipal Corporation would place a proposal to SUDA for such funding.
- Requirement of minor repair of Health facilities i.e. 13 HAUs, 2 ESOPD cum MH and 1 Central Medical Store as all this facilities was constructed at least 12 years back. The Municipal Corporation would send a proposal in PWD schedule to SUDA for obtaining fund.
- Enhancement of honorarium to HHWs & all other Health functionaries the Health functionaries placed a deputation for enhancement of honorarium to cope up with the market inflation. The undersigned stated that a Committee has been constituted by the Department of Municipal Affairs for examining the issues related to filling up the vacancy for different posts as well as enhancement of remuneration and the report of the said Committee would be submitted very shortly for consideration by the Department.

The meeting ended with vote of thanks to the Chair.
