Tier Supervisor(FTS) of IPP-VIII Unit III. The Ex-Chairman gave us the Approval
Letter on 08.04.08, but we did not get our rights and post of Supervisors till
now.

Respected Sir / Madam,

We, the Honarary Health Worker of IPP-V III Unit –III of Titagarh Municipality, here by request you to look upon the matter of not given post and rights of Supervisor to us till now while we had received the Approval letter for the post of Supervisor by Ex- chairman on 08.04.08. The reasons behind it was the settlement between some of our office co- workers and some members of Board of Council against of us .The harassments and the sufferings we had suffered due to the conspiracy of some Board of Councilors, Dr. G. L. Sharma and some of our co-workers ,who never wanted us to take the post . As follows:--

- We got our official permission letter for the training of 1st Tier Supervisor at Unnayan Bhavan by Titagarh Municipality on 18.02.02, which was handed over to us by Dr. G.L. Sharma. The training period was from 19.02.02 to 27.02.02.
- We submitted our original certificate of successful training to the Ex-chairman on 28.02.02 for issuing us the Approval Letter for the joining of new post of FTS. (Certificate no. – 496(55) / K.M.D.A. / IPP-VIII /T.22)
- 3. On 02.03.02 Dr. G.L. Sharma told us that we will get our Approval Letters after few days.

- 4. Suddenly, on 03.04.08 Tukun Dey of Unit -Ii was unlawfully posted as STS(Second Tier Supervisor)in our Unit-III.{ Note-The rule of posting in STS is that the promotion should be made of 2 FTS out of 7 FTS for the post of STS. This is the only rule of promotions followed by all the III-units }
- 5. We talked to Dr. Sharma and Ex- Chairman for our Approval Letter and in result we got our Approval Letter
- 6. On 10.04.08 all of us visited the K.M.D.A. Office for the submission of Approval Letter and to get an official receipt copy of it. But the OSD officers told us "Dr. G.L. Sharma had just called us by phone and commanded that not to receive any Approval Letter from Titagarh." On 11.04.08 Dr. Sharma threatened us that he would stop our salary and attendance in the office register if we did not return the Approval Letter given by Ex-Chairman .But we did not return him our Approval Letter.
- 7. On 11.04.08 we asked the Board of Councilors the reason of returning the Approval Letter .As a result we were called for a meeting with Board of Council and opposition members ,who never wanted us to be Supervisor, on 16.04.08.All the accusations became baseless. We were said that we would get our post within or after seven days. [Meanwhile, the opposition member s of our office played a very bad trick with us. They showed a paper signed by all the co- workers of us to Ex-Chairman saying that all the workers are against us. While the paper was only was an attendance sheet of our daily office routine. They misused that one day's attendance sheet without the knowledge of any of our co-workers for their personal gain.]

Note:- The 4 candidates who got hteir training of STS in September,2007 are named as Tukun Dey, Tapati Biswas, Chinta upadhyay and Malini Basu all these candidates had been posted for STS in March 2008. And all of us who got the training in February 2002 are still out of Post till now.

We informed our presiding Chairman about all these matter. Our presiding Chairman, Executive Officer and Shivani Chatterjee visited SUDA office for the enquiry of the fact. The SUDA officials directed them to send the vacant position list and the KMDA trained FTS candidate's name & Certificate papers. And they have send the necessary documents in this month as the direction of SUDA.

We hope that you will help us in getting our lawful right and post back as soon as it is possible.

On 11.04.08 Dr. Sharma threatened us that he would stop our salary and attendance in the office register if we did not return the Approval Letter given by Ex-Chairman .But we did not return him our Approval Letter.
- 7. On 11.04.08 we asked the Board of Councilors the reason of returning the Approval Letter .As a result we were called for a meeting with Board of Council and opposition members ,who never wanted us to be Supervisor, on 16.04.08.All the accusations became baseless. We were said that we would get our post within or after seven days. [Meanwhile, the opposition member s of our office played a very bad trick with us. They showed a paper signed by all the co- workers of us to Ex-Chairman saying that all the workers are against us. While the paper was only was an attendance sheet of our daily office routine. They misused that one day's attendance sheet without the knowledge of any of our co-workers for their personal gain.]

Our presiding Chairman, Executive Officer and Shivani Chatterjee visited SUDA office for the enquiry of the fact. The SUDA officials directed them to send the vacant position list and the KMDA trained FTS candidate's name & Certificate papers. We hope that you will help us in getting our lawful right and post back as soon as it is possible.

Existing Procedure

Selection of HHW under IPP-VIII:

- · Preserably married women.
- Age group 35 to 45 years.
- Residing in the same community or project block, if not available may be selected from adjacent project block.
- Educational qualificatio n
 —Class VIII standard.
- Selection by Central Selection Committee constituted by KMDA.

Selection of HHW under CBPHCS:

- Same as above excepting age group which is 25 to 35 years.
- Selection by Municipal Level Health
 Family Welfare Committee
 (MHFWC).


