

We have already circulated the above guideline to Habra & Santipur Municipality (copy of the communication to Habra Municipality enclosed).

But for local journey within the jurisdiction of the municipality such as from one Sub-Centre to other, from ULB to Sub-Centre or local Health Office or DM office and the like, clarification in respect of entitlement has been requested by the ULBs.

On receipt of clarification in respect of entitlement of leave rules and TA within the jurisdiction of the Municipality, all the 63 ULBs may be intimated accordingly including TA & DA beyond municipal jurisdiction. Necessary advice may kindly be given in this regard.


