Sub. : Proposal for utilization of services of Shri S.K. Lahiri relating to training, monitoring & supervision of Health Management Information System (HMIS) under Urban Health Programmes in the ULBs / SUDA.

This is to state that in addition to existing Urban Health Programmes in the ULBs of State of West Bengal, a new Programme namely Urban RCH has been launched on 28.08.2012 in 99 ULBs. Out of 22 no. of sanctioned manpower under Community Based Primary Health Care Services only 05 no. of manpower (PO - 1, APO - 2, FO - 1, Computer Asstt. - 1) are in position. It is almost beyond reach to visit to the ULBs for training, monitoring & supervising HMIS. It is mostly required to do the job at ULB level as there are a number of grassroot level functionaries who need training on HMIS both at class room and at beneficiary's field.

This is to highlight that in the present context of manpower at Health Wing, SUDA, immediate service to the field of HMIS at ULB level is required. In the mean time, proposal has been sent to the Department w.r.t. strengthening of manpower at Health Wing, SUDA. Pending approval to the said proposal and engagement of manpower, services of Shri S.K. Lahiri may be utilized for the present for the 126 ULBs.

In this context this is to state that Shri Lahiri had worked as Statistician under Department of Health & Family Welfare and under IPP-VIII (Extn.) at SUDA upto 30.06.2009 (copy of order of Director, SUDA vide no. SUDA-81/2000/912 dt. 27.04.2009 is enclosed for ready reference). Though he was posted under IPP-VIII (Extn.), he rendered services to all the ULBs. Thereafter, services of Shri Lahiri was utilized for implementation, monitoring & supervision of activities under Health component of KUSP (copy of Notesheet approved by the then Project Director dt. 13.07.2009 is enclosed for ready reference) upto March, 2011.

Services of Shri S.K. Lahiri may be utilized as and when requirement basis on a payment of Rs. 500/- (Rupees five hundred) only per day. Mobility support may also be extended for his visit to the ULBs.
