Comprehensive Note.

- Shri Tarank Nath Das, Councillor & Opposition Leader lodged a complaint on 02.07.2007 to the Director, SUDA regarding irregularities in the process adopted by the Chairman, Habra Municipality for engagement of personnel in different posts for Management & Supervision Cell under CBPHC. Similar complaint on 04.07.2007 had also been received from Smt. Tapati Dutta, Councillor & Ex. Chairperson of Habra Municipality, Ex. MLA, Habra.
- Copies of the said complaints were forwarded to the Chairman, Habra Municipality on 02.07.2007 & 04.07.2007 respectively with the request to put up the matter before the meeting of Board of Councillors (BOC) and forward their views.
- The Chairman submitted on 06.07.2007 an extract copy of earlier BOC meeting held on 29.06.2007 along with copies of appointment letter issued on 02.07.2007 for the posts of Medical Officer, Accounts Assistant, Health Assistant, Sanitary Inspector, Computer Assistant and Multipurpose Helper cum clerk cum Storekeeper.
- 7 nos. of Councillors visited office of SUDA on 10.07.2007 and reiterated their complaints and handed over a copy of such complaint dt. 01.07.2007 addressed to the Hon'ble MIC, MA & UD.
- As per instruction of the Principal Secretary, Dept. of Municipal Affairs, the Director, DLB was requested to depute one officer to enquire into the complaints and submit a report.
- Shri Badri Narayan Kar, WBCS (Exe), Asstt. Director of Local Bodies was
 entrusted with the task of enquiry on the complaints. Shri Kar visited Habra
 Municipality on 22.08.2007 for enquiry on the complaints lodged by the

 - The Municipal Level Heath & FW Committee has been entrusted with the responsibilities of selecting the personnel.
 - 4. All the members of the selection Committee were intimated about the dates of interview by the Chairman through a communication dt. 22.06.2007.

5. Out of 9 members of Municipal Level Health & FW Committee, only 3 members i.e. Chairman, CIC Health, Health Officer were present in the interview Board along with Executive Officer. Sir,

With due respect I would like to take the opportunity to let you know that the way through which engagement of personnel for the community based Primary Health Care Services in Habra municipality have been made recently. It may be stated that the entire process was not only wrong but also unethical Improper and illegal.

The subject was never discussed thoroughly in any of the Board Meetings of the councilors. It is noteworthy that the Board meeting is not convened regularly as per Bengal Municipal Act 1993. [The date of last two Board Meeting is convened on 23|2107, 29|6|07 respectively]. The entire matter was kept in hide for a long time and the engagement process has been completed in a hurried way without communicating the same to the opposition members of the Board.

Practically the process of engagement of personnel was completed ignoring the government guidelines. I would request you to look into the matter immediately so that the proper judgment may be effected in favor of deserving candidates.

Moreover the formation of the panel for interview board for the engagement was not as per government guideline's (eg Local Committee Secretary of C.P.I.(M) was included in the interview board as representative of Local MLA). How funny it was? Can we expect proper Judgment in this way? Can a person take an interview, award marks or ask questions or be an expert, who is not competent enough in all respects.

An objection describing the details was placed before the state Urban Development Agency (SUDA) Health wing ILGUS Bhawan Salt Lake Kolkata, who has been entrusted to supervise the entire matter with a request for taking necessary action. But it is a matter of regret that the entire process has been completed without responding to our protest.

Under these circumstances I would like to request you to look into the matter giving an utmost priority for abandonment of such evil practice of the present authority of Habra Municipality.
