In this connection this is to state that NUHM has been launched in MC during the financial year 2013-14. Engagement of clerk is most essential at each UPHC level for online reporting of HMIS which is lacking only in Asansol MC. This issue may be brought in the notice of the Principal Secretary, UD & MA Dept. for necessary intervention, if deemed appropriated.
