You are aware that under the World Bank assisted RCH Programme, 24 RCH Sub-Projects (17 District Sub-Projects and 7 City Sub-Projects) are under implementation in 17 States w.e.f. September, 1997. These Sub-Projects are to conclude on 31<sup>st</sup> March, 2004. Though the progress of these RCH Sub-Projects have been monitored and evaluated from time to time as an impact of these Sub-Projects projects vis-à-vis achievement in comparison to the Baseline Survey. The provision for conducting End-line Survey already exists in all the Sub-Projects.

To carry out these Surveys, this Ministry has prepared the Terms of Reference which have to approval of the World Bank. A copy of the same is enclosed. As only four months are left in the completion of the project implementation period, I request you to kindly get the Endline Survey conducted in Asansole & Murshidabad Sub-Projects under implementation in Your State as per the Terms of Reference enclosed by identifying an agency on sole source basis. To appoint the agency on sole source basis, the State has to give full justification alongwith the CVs agency having the experience doing the work of Base-line, District Household Survey, Mid-term Evaluation and similar study may be given preference.

As the results of the End-line Survey are also to be used in identifying weaknesses and strengths of the programme so as to facilitate better designing of similar projects and in facilitating Implementation Completion Reports, adequate care may please be taken in selection of the agency, quality of data and completion of the report within the given time frame. It may also be ensured that data on all important indicators such as IMR, CBR, TFR, CPR, immunization status, institutional delivery, safe delivery and other pertaining to the activities undertaken in the Sub-Projects also become available from the End-line Survey and their behaviour over a period of time by comparing them with the Base-line data. It will be pertinent to mention that no other is to be conducted at this stage except End-line Survey.

## Terms of Reference for End-line Survey of World Bank assisted RCH Sub-Projects

#### Background:

Under the Local Capacity Enhancement component of RCH Programme, 24 district/city RCH sub-projects are under implementation in 17 States since September/October 1997 with World Bank assistance. One of the purposes of the Local Capacity Enhancement component was to address equity through providing targeted additional support to 24 poorest districts so as to bring these to the level of the district average. The total approved cost of these sub projects is Rs.283.88 crores (Rs.105.51 crores for civil works and Rs.178.37 crores for other recurring and non-recurring expenses). The main objective of these sub projects is to address the gaps in the delivery of Family Welfare and Health Care services in selected Districts/Cities so as to enable such Districts/Cities to achieve an overall RCH status equivalent to the average for that State. The support under these Sub-Project is for civil works (both new and repair/upgradation/renovation); procurement of equipment, furniture and drugs; IEC; NGOs/innovative scheme; additional staff and mobility. These sub projects funded by Government of India on cent percent basis are to close on 31.3.2004.

However, the implementation status of these sub projects is not uniform and varies from State to State. A review of the health status improvement in districts where comparable RCH district survey round I & II data is available shows that the average district performance in terms of various RCH indicators has generally improved except for the few indicators such as "Full Immunization Coverage", "Full ANC" etc.

Though the function of the RCH Sub-Projects have been monitored and evaluated from time to time as an inbuilt system, it becomes imperative to carry out the final End-line Evaluation to determine the effectiveness, outcome and impact vis-à-vis achievements in comparison to the baseline survey. The End-line Survey will also help in finding out the weaknesses and strengths of these projects, factors (both positive and negative) which affected the implementation of these projects, main lessons learnt, assessing the impact of these projects over a period of time (component-wise) and based upon that recommendations for implementing similar projects in future for better efficiency and effectiveness. The End-line Survey will also look into the outcome (qualitative & quantitative) of the objectives based on activities undertaken during the project and also by comparing the results available from Base-line Survey, Phase-I & Phase-II of the RCH Rapid Household Survey and performance report.

## Objectives of the Survey:

The overall objective of the survey will be

- (i) To assess the impact of the project based on the input and process indicators supplemented by outcome indicators available from the Baseline Survey, End-line Survey, performance reports and other surveys and studies.
- (ii) To identify important program and institutional strengths and weaknesses to facilitate better designing of similar projects.
- (iii) To critically review the physical progress of the project of all components viz. civil works, procurement, training, IEC activities, innovative schemes.
- (iv) To identify the inputs critical to making improvements in implementation and outputs for poor performing districts and cities, including demand side interventions.
- (v) To assess the changes in management structure and its institutionalization in the overall health system, which led to improvement in project implementation..
- (vi) To assess access, availability and utilization of Health & Family Welfare services by the community.
- (vii) To identify the innovations to increase access, especially in regard to public-private partnership.
- (viii) To assess financial management, funds flow, utilization of funds, sustainability of the activities.
- (ix) To review the data from Phase I and II of the RCH rapid HH Surveys, to see the status change from one survey to the other as of June 2003, in terms of health outputs.

## Tasks to be carried out by Agencies:

- (i) Review of the project documents, Base-line Survey reports, RCH Household District Survey Reports Phase-I & Phase-II and other related studies, if any.
- (ii) Development of the survey schedules and finalization of input process and impact indicators in consultation with the nodal agency.
- (iii) Conducting the End-line field Survey for impact assessment to meet the objectives referred to above.
- (iv) To prepare the End-line Survey Reports covering all details as referred to in the objectives covering (a) project wise improvements in output/outcomes with specific reference to RCH Indicators; (b) detailed process documentation along with listing of activities carried out; (c) linkage between activities and objectives and document the same preferably in a Log Frame Matrix leading to outcomes; (d) examination of the time frames of activities so as to conclude whether these were reasonable for specific impacts observed; (e) innovations carried out under the project in meeting the objectives; (f) best practices, strengths & weaknesses and lesson learnt.

All the above tasks will be done through the End-line Survey, a review of data from the RCH Household and Facility survey data of both Phases; interview of the district health management officials, the Project Directors/CEOs of the Subprojects including those who were in the position earlier and would be available for discussions, service providers from all levels, including the NGOs, local government authorities, community and the service recipients.

#### Coverage

The Survey would be carried out in all the 24 District/City Sub-Projects by an independent external agency to be appointed by the respective State Governments on sole source basis.

#### **Time Frame**

Finalization of the survey design and preparation of instruments and its approval by GOI and World Bank - 30days.

Pre-testing, finalization of instruments and training of field investigators – 10 days Field data collection – 30 days

Analysis of draft report - 15 days.

Comments from the State Governments- 15 days

Final report submission to GOI/State Government - 15 days.

Total duration: 115 days.

## Services to be Provided by the Client

The State Government/Project Director will provide relevant data/records and extend necessary support to the survey agency during the field visits including facilitation of interviews and focus group discussion with key stakeholders. The State Government will also provide information on areas/ indicators to be examined. The State Government will also provide access to facilities/additional Information which may be required for the survey.

Data from the two phases of the RCH HH and Facility based surveys will also be provided by the Statistics Division, MOHFW, GOI.

## Outputs Expected from the Survey Agencies -Deliverables

# Terms of Reference for End-line Survey of World Bank assisted RCH Sub-Projects

#### Background:

Under the Local Capacity Enhancement component of RCH Programme, 24 district/city RCH sub-projects are under implementation in 17 States since September/October 1997 with World Bank assistance. One of the purposes of the Local Capacity Enhancement component was to address equity through providing targeted additional support to 24 poorest districts so as to bring these to the level of the district average. The total approved cost of these sub projects is Rs.283.88 crores (Rs.105.51 crores for civil works and Rs.178.37 crores for other recurring and non-recurring expenses). The main objective of these sub projects is to address the gaps in the delivery of Family Welfare and Health Care services in selected Districts/Cities so as to enable such Districts/Cities to achieve an overall RCH status equivalent to the average for that State. The support under these Sub-Project is for civil works (both new and repair/upgradation/renovation); procurement of equipment, furniture and drugs; IEC; NGOs/innovative scheme; additional staff and mobility.
