> Sub :- Tremendous Problem created in Health Service in Baidyabati Municipality for shortage of Health Workers

Sir.

I am to draw your attention to the above noted matter and to say that under Baidyabati Municipality there are 17 (Seventeen) Health Sub-centres for which the total no. of Health Workers (HHWS) existed 85 previously. Now the no. of Health Workers (HHWS) has been gradually reduced to 38 and naturally these few numbers of Health Workers have to look after all the woks relating to field survey, vaccination, various projects under National Level, UHND's meetings and daily works in the health centre and in two Urban Primary Health Centres (UPHCS) along with 17 Health Sub-centres.

It is to be noted that the said few number of Health Workers (38) will be reduced to a negligible number within few years and the existing health service, which is being somehow maintained through our limited capacity, will be devastated, if no recruitment is made in vacant posts of 47 out of existing posts of 85. The vacant posts may be filled up by the retired health workers through re-engagement upto 65 years and their experience may be utilized.

I would, therefore, request you to take necessary action to fill up the above noted 47 posts so that the health service in this Municipality may run smoothly and the tremendous pressure as imposed on the existing Health Workers may be released and normalcy in Health Service may be restored, though normal condition is being maintained through tremendous pressure.
