MEMORANDUM

The Maternity Homes set-up under the IPP-VIII Health Programme in different municipal bodies and are otherwise ready in all respects cannot be made functional as yet for want of properly supportive staff. As a result satisfactory Maternity & Health Care Services envisages under the IPP-VIII Programme cannot be rendered there.

In order to overcome such a situation and to make the Maternity Centres so ready to function effectively, the question of engagement of properly supportive staff in the Maternity Homes was under consideration of the project authority for some time past. A proposal accordingly, was placed before the Apex Committee of the Family Welfare (Urban Slums) Project - IPP-VIII in its 7th meeting held on 16.2.2000. The Committee directed that the Municipal Affairs Deptt. will take necessary action for creation of the following posts :-

Medical officer - 2 (in 12 hrs. shift per day); Nurse - 3; Laboratory Technicians - cum- Store-keeper - 1 for each Maternity Home. This is in consonance with the staff pattern of Maternity Homes as indicated in the administrative approval issued by the Ministry of Health and Family Welfare vide their No. L - 19012/7198 - A/S (Vol. III) dt. 27.1.2000. Project, however, may engage the personnel on daily basis until formal sanction is received to continue functioning of the units.

In conformity with the above direction of the Apex Committee and the staff pattern indicated in the Govt. of India's letter mentioned above the project has decided to the engagement of the following categories of personnel on contract on daily wage as indicated against each :-

2. Now a question has been arisen as regards drawal of Dearness Pay, opening of Service Books, deduction of G.P.F. and G.I.S. etc. of the newly appointed Health Officers.
Reply.
3. After careful consideration of the matters the Governor has been pleased to order the following :
 - (a) The Health Officers like regular Govt. employees shall be entitled for drawal of Dearness Pay in terms of relevant orders of the Finance Deptt. of this Government.
 - (b) The Service Books of the Health Officers shall be opened and maintained by the SDO concerned.
 - (c) Upon allocation of G.P.F. No. the G.P.F. deduction at the minimum prescribed rate. If GPF No. is not allotted within the prescribed period the SDO concerned may deduct G.P.F. subscription at the minimum prescribed rate on ad hoc basis after keeping proper record.
 - (d) Deduction of GIS shall be made at the usual rate from salary of the first month after joining.
 - (e) The SDO concerned shall sanction all kinds of leave (except casual leave which shall be sanctioned the Chairman of the ULB concerned) on recommendation of the Chairman of the ULB concerned. The confidential Assessment Report shall be initiated by the Chairman of the ULB concerned as Reporting Officer, the SDO concerned shall be the countersigning Officer and the District Magistrate concerned shall endorse the CAR as Head of the Department.
 - (f) The Health Officers shall submit their annual Assets Statement to the SDO concerned.



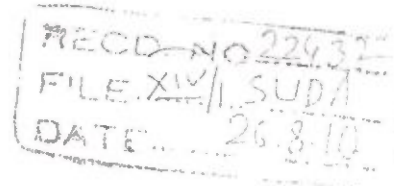

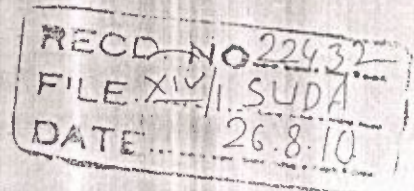
