It appears that in many of the RDCs all the posts have not yet been filled up although considerable time has elapsed. As such, the RDCs are not functioning to the desired level so as to generate surplus fund to support the municipal health activities and cater to the needs of the urban poor.

North Barrackpore and Uttarpara-Kotrung have not submitted any claim for remuneration of the RDC staff since its inception, as it appears from office records.

Dum Dum has so far submitted claim for remuneration for one attendant only although several posts were approved for Dum Dum Municipality vide this office letter no.120/KMDA/A-28/UHIP(IPP-VIII)/02 dated 28.04.2004.

Uttarpara-Kotrung Municipality has not been furnishing break-up of the patients between Beneficiary and non-beneficiary in its monthly report which needs immediate rectification.

Rajpur-Sonarpur had no USG and ECG case during 2003-04 although necessary equipments were provided to the municipality.

It is high time that the deficiencies noted above be rectified and requisite staff as sanctioned by the M.A. Deptt. be deployed immediately with the approval of KMDA in order to enable RDC to function to its optimum capacity for generation of sufficient surplus fund to support the ULB in its health activities and extend the benefits of pathological and radiological investigations to the urban poor at cheaper rates.

This may kindly be treated as most urgent.
