Sir,

I am to refer to Memo No. SUDA-Health/451/12/317(85) dated 04.02.2013 of S.U.D.A wherein it has been stated that an advertisement for recruitment of Medical Officer, ANM/GNM under RCH Programme has been published on 02.02.2013. In the operational guideline annexed with the said Memo vide Annexure-I it is found that the Medical Officer to be appointed under RCH Programme will report to and will work in consultation with and under the supervision of the Health Officer of the Municipality.

It may be mentioned here that the post of Health Officer was created by the Municipal Affairs Deptt. Vide Notification No. 451/MA/C-10/35-53/2005 Pt. dated 22.04.2008 for successful implementation of C.B.P.H.C. Service in 63 Non-KMA Urban Local Bodies and selection of Health Officer was entrusted to the respective Urban Local Bodies. Accordingly this Municipality published Notice in Bengali and English Daily on 05.12.2008 inviting application for the said post. Two applications were received.

Subsequently, S.U.D.A published similar Notice in the Daily Newspapers on 01.02.2009 for the said post. Thereafter another three Candidates applied for the post of Health Officer. Total application thus received were (2+3) = 5.

All the five candidates were called for interview on 04.08.2009. Two of them appeared in the Interview Board; but no one could be selected due to age bar of 32 yrs.(upper age limit).

Since then the post of Health Officer is remaining vacant. The C.B.P.H.C. Programme is running and other workers engaged for the Programme are acting without the guidance/supervision of the Health Officer.

You are, therefore, requested to kindly look into the matter and arrange for recruitment/posting of a Health officer to this Municipality for successful completion of C.B.P.H.C/R.C.H. Programme.

 - fortnightly home visit to each BPL families,
 - motivate the community to avail health services collection of data and filling up of Family Schedule,
 - treatment of minor ailments at door step, distribution of drugs for three days maximum,
 - registration of pregnancy within 12 weeks,
 - identification of danger signs of pregnancy and its referral,

- After completion of training only the regular HHWs are to be engaged.
- No. of Sub-Centres as specified in the table are to be identified more or less centrally to the BPL population to be served under that particular Sub-Centre to facilitate easy access.
- FTSs for Sub-Centre are to be selected for amongst the HHWs working at least for six (6) months. Detail guideline will be issued in due course.
- Working hours of grass root level manpower will be from 12 Noon to 4 P.M.
