The humble Petition on behalf of the
Petitioners above named-

Most Respectfully Sheweth:

- That the Petitioners are Law abiding citizens of India, having their respective permanent residences as mentioned in the Cause Title herein above.
- 2. That the Respondent No. 1 is the State of West Bengal. For smooth operation and to effect the functionaries of Public Administration it creates Several Bodies under it amongst whom the Respondent Nos. 2, 3, 4 and 5 are the creatures of the statute and time to time they have been following relevant Rules and Regulations enacted for their operational purposes. The Respondent Nos. 6, 7 and 8 are

the Body Corporate having been framed under the relevant provisions of the West Bengal Municipal Act, 1993 providing administrative assistance in respect of welfare of the people to the people of the society at large. It is needless to mention that the aforesaid Respondents having financially, administratively and functionally control and thus they are autonomous bodies. Hence, all of their actions are amenable to Writ Jurisdiction of this Hon'ble Court. The said Respondents are therefore all 'State' within the meaning of Article 12 of the Constitution of India and 'Person' or 'Authority' within the meaning of Article 226 of the Constitution of India thereof.

- The facts of the instant case are chequered and a cursory glance to those same is germane herein below.
- 4. That the Petitioners are the Health Workers who were engaged by the concerned Authority of the Respondent Municipality being the Respondent No. 8 hereof pursuant to a scheme of the Department of Health and Family Welfare for the purpose of and to take care of the health of the people of the Society as well as to make them aware about maintaining their health in Order to keep their family

members free from various viral disease and thereby to create a hygienic atmosphere in the Society for the benefit of each and every person.

5. That the Petitioners state that pursuant to the scheme of the Health and Family Welfare Department, the recruitment of honorary health worker given to effect some time on and from 1985 whereby the Petitioners were recruited as honorary health workers by virtue of an oral interview conducted by the concerned Authority attached with Respondent Municipal being Respondent Nos. 6, 7 and 8 hereof whereby the honorary health workers like Petitioners hereof used to render their honorary service in their locality but none of the Respondents issued any formal Appointment Letter to any of the honorary health workers including your Petitioners but a Register is maintained in the Office of the concerned Municipality for maintaining daily attendance of the honorary health workers including the Petitioners as well as about their honorarium. It is needless to mention since the aforesaid Register is maintained by concerned Municipality, entire record of the said Register lying with the

Respondent Municipality. It is further pertinent to mention that the Petitioners hereof have been working as honorary health workers for over a period not less than 30 (Thirty) years as on date.

6. That the Petitioners state that it is a matter of utter surprise to them albeit they are regular honorary workers and have been rendering their services towards the people of the society within the ambit of Uttarpara-Kotrung Municipality successfully by making people aware about hygienic part to maintain their health by campaigning door to door vaccination, aiding first and as well as medical services during viral fever as well as extending their services to pregnant women but the concerned Authorities attached with concerned Municipality being Respondent Nos. 6, 7 and 8 hereof initially did not provide them any identity card to such honorary health workers but due to repeated insistence by the Petitioners and other honorary health workers, the concerned Authorities attached with Respondent Municipal Authorities issued identity card to some of the honorary health workers including the Petitioners.

Photocopies of said identity cards are annexed herewith and collectively marked as Annexure P-1.

7. That the Petitioners state that the Audit Branch of Finance Department of Government of West Bengal have issued a Government Order being No. 9008- F (P) dated 16.09.2011 wherein interalia declared some benefits in favour of casual/ daily rated/ contractual workers who have remained engaged in various Government Establishments for a considerable period of more than 10 (Ten) years in connection with implementation of various schemes/ projects of various Departments of the Government. It is pertinent to mention in terms of the aforesaid Government Order, all casual/ daily rated /contractual workers alike Petitioners hereof who have rendered 10 (Ten) years of service continuously with at least 240 (Two Hundred Forty) days attendance in work each year may remain engaged in the same status as was on 01.08.2011 and shall have capacity to continue till their attaining the age of 60 (Sixty) years and be entitled at entry point basic pay in PB-1 i.e. Rs. 6600.00 (Rs. 4900.00 + Rs. 1700.00) per month.

Photocopy of the said Memorandum being No. 9008- F (P) dated 16.09.2011 is annexed herewith and marked as Annexure P-2.

8. That the Petitioners state that Department of Municipal Affairs issued another Government Order being No. 1154/ MA/ C- 10/ 35- 30/ 2012 dated 09.12.2013 whereby all the concerned Respondents hereof have been directed that the terms of engagement of contractual health-workers who have attained 60 (Sixty) years of age or more if any or likely to attain 60 (Sixty) years of age before 01.01.2014 shall be terminated on 31.12.2013. It is pertinent to mention that the Respondent Municipality being Uttarpara-Kotrung Municipality following the directions of the aforesaid Government Order was pleased to stop a good number of honorary health-workers who attained age of 60 (Sixty) years from continuing their job without proper appreciation of both the Government Order dated 16.09.2011 and Government Order dated 09.12.2013.

Photocopy of the Government Order dated 09.12.2013 is annexed herewith and marked as Annexure P-3.

- Government Policy regarding their honorarium against their services but being poor and needy they used to accept the honorarium as used to be paid by the concerned Authorities attached with the Respondent Municipality being Respondent Nos. 6, 7 and 8 hereof at their sweet will. It is a matter of surprise to the Petitioners that the quantum of the honorarium paid by the Respondent Nos. 6, 7 and 8 are much less than the daily wage earners. It is further pertinent to mention that the said honorarium has been received by the health-workers alike Petitioners hereof by putting their respective signatures on the vouchers and record of such payment are lying with the office at the Uttarpara-Kotrung Municipality.
- 10. That the Petitioners state that after having come to know about the Government Order dated 16.09.2011 they time and again approached the concerned Respondents being Respondent Nos. 6, 7 and 8 hereof for giving effect to the Government Order dated 16.09.2011 but more of the aforesaid Respondents considered the requests of the Petitioners which compelled your Petitioners

Seeking few informations related with effect of the aforesaid Government Order dated 16.09.2011 and their benefits in terms of the said Government Order through the Applications under R. T. I. Act, 2005 to the Chairman cum Public Relation Officer being the Respondent No. 6 hereof.

Photocopies of the said Applications are annexed herewith and collectively marked as P-4.

under R. T. I. Act 2005 made by the Petitioners the concerned Executive Officer cum S. P. I. O. being the Respondent No. 8 hereof vide letter dated 18.08.2015 under Memo No. 1861 (28) gave a common reply wherein albeit the Respondent No. 8 categorically admitted that Unit- I of the C. W. D. P.- III Project started functioning from the year 1985 while Unit II of C. W. D. P.- III came into effect from 1990, the Petitioners were/ are engaged as such in the said projects since its inception which tantamount to the fact that the Petitioners have been working as honorary health workers since 1985 and therefore they have been working as honorary health workers with nonorarium not less than 30 (Thirty)

years continuously and thus they come within the scope and ambit of benefits of Government Order No. 9008- F (P) dated 16.09.2011. It is needless to mention that save and except aforesaid informations the concerned Executive Officer cum S. P. I. O. expressed his inability to provide information to the rest of the queries made by the Petitioners in their Applications under R. T. I. Act, 2005 and categorically stated about their ignorance regarding the Government Order mentioned by the Petitioners in their Applications under R. T. I. Act 2005.

Photocopies of replies dated 18.08.2015 are annexed herewith and collectively marked as Annexure P-5.

12. That the Petitioners state that since the reply dated 18.08.2015 issued by the Executive Officer cum S. P. I. O. being the Respondent No. 8 hereof reflects that according to the Respondent Municipal Authorities that selection of health-workers made by C. M. D. A. and thus the Appointment and procedures are not known to them for which the Petitioners attempted to get those informations from the concerned Project Officer of SUDA being Respondent No. 5 hereof through Applications under R. T. I. Act,

2005 by repeating and reiterating their queries pertaining to their benefits in terms of Government Order No. 9008-F (P) dated 16.09.2011.

Photocopies of the said Applications are annexed herewith and collectively marked as P-6.

- 13. That the Petitioners state that the concerned SPIO of SUDA vide its letter dated 24.09.2015 under Memo No. SUDA- 43/ 2005 (PT- II) directed the concerned Executive Officer, SPIO being the Respondent No. 8 hereof for supplying information direct to the Petitioners hereof since the matter is related to Uttarpara-Kotrung Municipality but it is curious enough that none of the Respondent Municipal Authorities being Respondent Nos. 6, 7 and 8 till date furnished any information against the queries of the Petitioner pertaining to their Applications under R. T. I. Act, 2005 in compliance with the directions dated 24.09.2015.
 - Photocopy of the letter dated 24.09.2015 is annexed herewith and marked as Annexure P-7.
- 14. That the Petitioners submit that albeit Respondents hereof are the implementing Authority of health project who admittedly recruited

honorary health workmen for implementation of various health projects of the Government of West Bengal but deliberately ignored the queries of the Petitioners by intentionally not providing the information pertaining to the benefits of the honorary health workers alike Petitioners hereof in order to deprive the Petitioners from their legitimate benefits in spite of the fact that the concerned Department of the Government allotted funds for providing monetary benefits to the honorary health-workers alike Petitioners hereof.

15. That the Petitioners submit that in terms of Government Order No. 9008- F (P) dated 16.09.2011 Petitioners are entitled for a recommendation to the tune of Rs. 6600.00 (Rupees Six Thousand Six Hundred) only per month because of the fact admittedly they have been working for 30 (Thirty) years and then as on 01.08.2011 they rendered service more than 10 (Ten) years continuously and then each of them are entitled for an amount of Rs. 23,76,000.00 (Rupees Twenty Three Lac Seventy Six Thousand) only till 2015 after adjusting the amount already paid by the Respondent Municipality till date.

- Respondents hereof with an intend to frustrate the legitimate claim of the Petitioners in a motivated manner did not answering the queries of the Petitioners mentioned in their Applications under R.

 T. I. Act 2005 which act of Respondent Municipalities dehors the mandate provisions enshrined under the said R. T. I. Act, 2005.
- 17. That the Petitioner further submits that the impugned act and action of the Respondent Authorities, more particularly, of the Respondent No. 8 hereof who in spite of direction of SUDA vide dated 24.09.2015, did not care to provide informations to the queries of the Petitioners mentioned in their Applications under R. T. I. Act, 2005, give rise cause of action of the Petitioners to move this Application before this Hon'ble Court interalia seeking Judicial interference of this Hon'ble Court to issue a Writ in the nature of Mandamus by directing the Respondents to disburse the financial benefits of the Petitioners pertaining to their arrear honorarium in terms of Government Order No. 9008- F (P) dated 16.09.2011 further without any further delay.

18. That being aggrieved by and dissatisfied with the impugned act and actions of the Respondents who deprived the Petitioners from their legitimate honorarium against rendering their service for last 30 (Thirty) years in terms of Government Order No. 9008- F (P) dated 16.09.2011, your Petitioners beg to prefer this Application on the following amongst others:-

GROUNDS

- I) FOR THAT the concerned Respondent Authorities do not give effect to the Government Order being No. 9008- F (P) dated 16.09.2011 without any apt and cogent reasons thereof.
- II) FOR THAT the concerned Authorities attached with Respondent Municipality, more particularly, the Respondent No. 8 hereof is under statutory obligation to give reply to all the questions made by the Petitioners through their Applications under Right to Information Act, 2005.
- III) FOR THAT the Respondent No. 8 in its reply dated

 18.08.2015 categorically admitted that the

Petitioners have been working for a continuous period of 30 (Thirty) years as Honorary Health Workers under Uttarpara-Kotrung Municipality and thus they are entitled for the financial benefits in terms of Government Order No. 9008- F (P) dated 16.09.2011.

- IV) FOR THAT the Respondent being Respondent No. 8 hereof is under statutory obligation to act in compliance of the directions dated 24.09.2015 issued by the concerned S. P. I. O. of SUDA.
- V) FOR THAT none of the Respondents have any right to deprive the Petitioners from their legitimate benefits against their service as Honorary Health Workers for last 30 years in terms of G. O. No. 9008- F (P) dated 16.09.2015.
- VI) FOR THAT the impugned act and actions of the

 Respondents have been deliberately infringed the

 fundamental rights of the Petitioners enshrined

under Article 14, 19 and 21 of the Constitution of India.

- VII) FOR THAT the Respondents ought to have considered that the Petitioners have been rendering their jobs as Honorary Health Workers since last 30 (Thirty) years and thereby extending their cooperation to give effect of various projects of the Health Department of Government of West Bengal.
- VIII) FOR THAT the concerned Respondents being Respondent Nos. 6, 7 and 8 hereof is under statutory obligation to compute the financial and monetary benefits of the Petitioners who have been working as Honorary Health Workers for last 30 (Thirty) years in terms of Government Order No. 9008- F (P) dated 16.09.2011 and disburse the same forthwith without any further delay.
- IX) FOR THAT the impugned act and actions of the respondents are nothing but glaring example of gross negligence on the part of the Respondents hereof

which warrants interference of this Hon'ble Court for issuance of appropriate directions upon the Respondents by issuing a Writ in the nature of Mandamus and/ or any other appropriate Writ or Writs like in nature to ensure the fundamental rights of the petitioners.

- 19. That the Petitioners state and submit that until and unless Order, as prayed for herein, is passed, the Petitioners will suffer irrepable loss and injury.
- 20. That the Petitioners state that the Petitioners have not moved before any Court of Law on the self same cause of action.
- 21. That the Petitioners state that there is no other efficacious, alternative remedy available to the Petitioners other than to move the instant Writ Petition.
- 22. That the Petitioners submit that the Petitioners being laywomen having no idea about the procedure and thus after knocking door to door he was able to gather some knowledge for seeking reliefs/ remedial action and on account of that there has been some unavoidable delay caused to move this Writ Petition which is hot

intentional latches on the part of the Petitioners and for same his right should not be infringed.

Under the aforesaid facts and circumstances your Petitioners most humbly prays that Your Lordships would graciously be pleased to issue:

a) a Writ of and/ or in the nature of Mandamus do issue commanding the Respondents, more particularly, the Respondent No. 8 hereof and its men, agents and subordinates and each one of them to show cause as to why the Respondent No. 8 should not be directed to provide the information asked by the Petitioners through their Applications under R. T. I. Act,

2005 in compliance with the directions issued by the state Urban Development Authority vide letter dated 24.08.2015 forthwith without any further delay;

nature of Mandamus do issue commanding the Respondents, more particularly, Respondent No. 6 hereof and its men, agents and subordinates and each one of them to show cause as to why the Respondent No. 6 should not be directed to disburse including interest arrear financial benefits, in favour of the petitioners in terms of Government Order No.

forthwith without any further delay;

- a further Writ of and/ or in the nature of Mandamus do issue commanding the Respondents, more particularly, Respondent No. 6 hereof and its men, agents and subordinates and each one of them to show cause as to why the Respondent No. 6 should not be directed to pay the honorarium in favour of the Petitioners in terms Government Order No. 9008- F (P) dated 16.09.2011 forthwith without any further delay;
- d) a Writ of and/or in the nature of

 Certiorari do issue directing the

 Respondent concerned and each

agent to transmit the entire record of the case to this Hon'ble Court without any further delay for satisfying the same and after being satisfied do the conscionable justice to the Party that may be administered;

- e) Rule N. I. S. I. in terms of prayer

 (a), (b), (c) and (d) above;
 - Respondents, more particularly,
 the Respondent No. 6 hereof to
 compute and disburse the
 arrear financial benefits on
 account of honorarium to the
 Petitioners in terms of

MEMORANDUM

In order to provide security of tenure, appropriate emoluments and certain terminal benefits subject to fulfillment of certain onditions to the casual / daily rated / contractual workers who have remained engaged in various Government establishments for a considerable period of more than 10 years in connection with implementation of various schemes / establishments for a considerable period of more than 10 years in connection with implementation of various schemes / projects of various Departments of the Government two memorandums vide No. 2966-F(P) dated 23.04.2010 and No. 11794-F(P) dated 22.12.2010 were issued by the Government in Finance Department.

The question of making the provisions of the two aforesaid orders more effective and suitable to the convenience of the Government Establishments / Organizations has been under active consideration of the Government for some time past.

After careful consideration of the matter an din suppression of the aforesaid orders and all other orders issued by other Departments in the matter, the undersigned is directed by order of the Governor to say that the casual / daily rated / contractual workers, who are remaining attached to various establishments of the Government Departments / contractual workers, who are remaining attached to various establishments of the Government Departments / Directorates / Regional Offices / Other Organizations for not less than 10 years continuously as on 01.08.2011 and have rendered service for at least 240 days each year will be allowed the following benefits:

i) The casual / daily rated / contractual workers who have rendered 10 years of service continuously with at least 240 days attendance each year may remain engaged in the same status and capacity till their attaining the age of 60 years.

The Continuity of service shall have to be certified by a competent officer not below the rank of Assistant Secretary in the case of a secretariat Department, Director in the case of a Directorate and Assistant Engineers / SDO / BDO in the case of Regional Offices. The concerned officer, who certifies may be advised to exercise extreme precautions and take assistance of an office of WBA & AS, if necessary.

- ii) An entry point basic pay in PB-I i.e. Rs. 6600/- (Rs. 4900 + 1700) p.m. will be admissible to casual / daily rated / contractual Group 'D' workers as consolidated remuneration, similar entry point pay (entry point pay in the Pay Band plus Grade Pay) will be admissible to casual / daily rated / contractual Group 'C' worker and an employee of any other category, if he / she fulfils the required condition will be entitled to a monthly remuneration which will be minimum entry level pay of Pay Band and Grade Pay corresponding to his / her category and the remuneration may be determined in consultation with the Finance Department in the same manner as mentioned above.
- iii) When such casual / daily rated / contractual workers are allowed the entry point basic pay, they will not get any other allowances like dearness allowance, house rent allowance etc. However, their basic pay will be enhanced by 5% after every three years and the three years will be counted by treating the period from 1st August 2011 to 1st July 2012 as completed year for giving effect to 5 per cent increase in basic pay.
- iv) The remuneration of casual / daily rated / contractual workers who have not yet completed 10 years service will be equivalent to 75% of the remuneration admissible under sub-para (ii) above subject to a minimum of Rs. 5000/- p.m.
- v) Those casual / daily rated / contractual workers who will complete 10 year service on 1st July every year will come under the purview of this Order provided no such workers if engaged after 01.04.2010 will come under the purview of this Order.
- vi) A casual / daily rated / contractual workers who will fulfil the conditions as laid down in sub-para (i) above will continue to be engaged in such a manner till he / she attains the age of 60 years when he / she will be paid an amount of Rs. I lakh as one time cessation of engagement benefit.
- vii) A casual / daily rated / contractual worker may be allowed 30 (thirty) off days a year and a female such worker may be allowed Maternity Leave of 180 (one hundred eighty) days in addition to 30 days off as mentioned hereinbefore.
- viii) A casual / daily rated / contractual worker who is engaged in two different Government Departments but has rendered services for 10 years without a break will come under the purview of this Order.
- ix) It is reiterated that Officer / Officers responsible for any further engagement of such casual / daily rated / contractual worker will be personally liable for violation of this Order. However, having regard to the exigencies of situation and in order to facilitate smooth running of any project / administration or for serving academic interest where it is absolutely

necessary contractual engagement may be made for a very limited period not exceeding 1 (one) year. This engagement shall be made on strict observance of recruitment rules and against sanctioned vacancies. Simultaneously steps should be taken to fill up the vacancies on regular basis following recruitment rules. Such contractual engagement may be renewed from time to time, but not exceeding a total period of 6 (six) years. No claim to regularization of this contractual service in terms of GO No. 8305-F dated 26.09.2005 read with GO No. 642-F dated 24.01.2006 shall lie.

- x) The provisions of this Order will not be applicable where contractual engagement has been made without any sanctioned post and for any specific project for a very temporary period up to a maximum 6 (six) years or finishing up the project whichever is earlier. Thus in such cases steps will not be required to be initiated for filling up the posts through regular appointments as per the Recruitment Rules, since the posts are temporary by nature.
- xi) During the period of engagement, the service of a casual / daily rated / contractual worker may be terminated because of involvement in criminal case / misconduct / delinquency / incapacitation etc. Or if the concerned worker intends to opt out of the engagement on his / her own.
- xii) The benefit of this Memo will be applicable mutatis mutandis to the Panchayat Bodies / ULBs / Statutory Bodies.
- xiii) The casual / daily rated / contractual workers who have already got the benefit with reference to 1st April, 2010 as cut off date will continue to get the benefit in terms of F.D. Memo No. 2966-F(P) dated 23.04.2010 and No. 11974-F(P) dated 22.12.2010, while the others will be covered in terms of provisions of this Memo.

The undersigned is further directed to reiterate that henceforth no further engagement of Group 'D' employees, who are engaged in the manner as laid down in F.D. Memo No. 3727-F(P) dated 20.05.2009 and paid out of contingency, will be done, on or after 01.04.2010. Officer / Officers responsible for such engagement will be personally liable for violation of this Order.

- xiv) The final approval will be given by the ACS / Principal Secretary / Secretary as the case may be, of the concerned department, after exercising necessary checks & balances & ensuring that any ineligible person does not get the benefits of this order.
- xv) A proforma statement is bereby annexed for supplying information by the respective appointing authority to the Administrative Department.







It has come to the notice of the Government for some time past that for implementation of various schemes/projects of the various Departments of the Government the controlling authorities have been compelled to engaged casual, daily rated workers. In many cases, these employees render service for a substantial period of time even for more than 10 years remaining attached to various Departments of Government. The issue of security of tenure, appropriate emoluments and certain retirement benefits in respect of these employees so engaged on long term basis has been under consideration of the Government for some time past.

After careful consideration of the matter the Governor has now been pleased to order that these casual/daily rated workers who are remaining attached to various establishments of the Government Departments/Directorates/Regional Offices for not less than 10 years as on 01.04.2010 and have rendered service for at least 240 days each year will be allowed the following benefits –

- 1. These casual/daily rated workers may remain engaged till their attaining the age of 60.
- 2. They will be paid remuneration which will be the minimum pay with corresponding category of workers of Pay Band 1 (PB-1) i.e. Rs. 6,600/- p.m. with enhancement @ 5% every 3 (Three) years. They will not be entitled to any other allowances.

 An employee of any other category, if he/she fulfils the required condition will be entitled to a monthly remuneration which will be minimum entry level pay of Pay Band and Grade Pay corresponding to his/her category and the remuneration may be determined in consultation with the Finance Department in the same manner as mentioned above.
- After the period of engagement of such an employee ceases on his attaining 60 years of age, he/she will be paid an amount of Rs. 1 lakh as one time cessation of engagement benefit
- 4. During the period of engagement, the service of such an employee may be terminated because of involvement in criminal case/misconduct/delinquency/incapacitation etc. or if the employee intends to opt out of the engagement on his own. The enhanced remuneration will be paid w.e.f. 01.06.2010.
 The detailed modalities will be worked out soon for implementation of this order.
- From the date of issue of this order no further engagement of such casual/daily rated worker shall be entertained. Officer/Officers responsible for any further engagement of such casual/daily rated worker will be personally liable for violation of this Government order.

MEMORANDUM

For implementation of this Department's Memo No. 2966-F(P), dated 23.04.2010 under which it has been decided to give some financial and other benefits to the Casual/Dailyrated/Contractual Workers who are rendering service for a substantial period remaining attached to various Government Establishments the undersigned is directed by order of the Governor to prescribe the following modalities for due observance of all concerned:

1) The benefits detailed at Sl. Nos. 1 to 4 of the aforesaid order will be available w.e.f. 1st January, 2011 to those casual, daily-rated, contractual workers who have rendered at least 10 years of service as on 01.04.2010 with 240 days of work each year.

The continuity of service shall have to be certified by a Competent Officer not below the rank of Assistant Secretary in case of a Secretariat Department, Director in case of a Directorate and Assistant Engineer / S.D.O. / B.D.O. in case of regional offices. The concerned Officer who certifies may be advised to exercise extreme precautions and take assistance of an Officer of WBA&AS, if necessary.

As entry point basic pay in PB-1 i.e. Rs. 6,600/- p.m. will be admissible to casual, daily rated, Gr. - 'D' workers as consolidated remuneration, similar entry point basic pay plus Grade Pay will be admissible to Casual, Dailyrated Group - 'C' worker and other categories of Casual Workers as consolidated remuneration, if they fulfill the prescribed conditions.

When such Casual Workers are allowed the entry point basic pay, they will not get any other allowances like dearness allowance, house rent allowance etc. However, their basic pay will be enhanced by 5% after every 3 (three) years.

The benefit of the G.O. No. 2966-F(P), dated 23.04.2010 will be applicable mutatis mutandis to the Panchayat Bodies / ULBs / Statutory Bodies etc.

6) A Casual / Dailyrated / Contractual Worker who will fulfill the conditions as laid down in para (1) above will continue to be engaged in such a manner till he or she attains the age of 60 years.

7) A Casual / Dailyrated Worker when given a security of tenure may be allowed a benefit of 30 (thirty) off days a year.

8) Maternity Leave to the Female Workers may be allowed in addition to 30 (thirty) off days a year.

9) A Casual / Dailyrated Worker who is engaged in two different Government Departments but has rendered services for 10 years without a break will come under the purview of the G.O. No. 2966-F(P), dated 23.04.2010.

The benefit of the G.O. No. 2966-F(P), dated 23.04.2010 will be a one time benefit for the Casual / Dailyrated Workers who have completed 10 (ten) years of service as on 31.03.2010.

11) It is reiterated that such Casual Workers will continue to remain in the status of Casual Workers.

The undersigned is further directed to say that henceforth no further engagement of Gr.-'D' employees who are engaged in the manner as laid down in Finance Department's Memo No. 3727-F, dated 20.05.2009 and paid out of contingencies will be done. Officer / Officers responsible for such engagement will be personally liable for violation of this Government Order.

A proforma statement is hereby annexed for supplying information by the respective appointing authorities to the Administrative Departments who will examine the same and forward it to this Department for approval.

MEMORANDUM

In order to provide security of tenure, appropriate emoluments and certain terminal benefits subject to fulfilment of certain conditions to the casual/daily rated/contractual workers who have remained engaged in various Government Establishments for a considerable period of more than 10 years in connection with implementation of various schemes/projects of various Departments of the government two Memorandums vide No. 2966-F(P) dt. 23-04-2010 and No. 11794-F(P) dt. 22-12-2010 were issued by the Government in Finance Department.

The question of making the provisions of the two aforesaid orders more effective and suitable to the convenience of the Government Establishments/Organization has been under active consideration of the Government for some time past.

After careful consideration of the matter and in supersession of the aforesaid orders and all other orders issued by other Departments in the matter, the undersigned is directed by order of the Governor to say that the Governor, has now been pleased to order that the casual/daily rated/contractual workers, who are remaining attached to various establishments of the Government Departments/ Directorates/Regional Offices/other Organizations for not less than 10 years continuously as on 01-08-2011 and have rendered service for at least 240 days each year will be allowed the following benefits:

(i) The casual/daily rated/contractual workers who have rendered 10 years of service continuously with at least 240 days attendance each year may remain engaged in the same status and capacity till their attaining the age of 60 years.

The continuity of service shall have to be certified by a competent officer not below the rank of Assistant Secretary in the case of a Secretariat Department, Director in the case of a Directorate and Assistant Engineer/S.D.O/B.D.O in the case of Regional Offices. The concerned officer, who certifies may be advised to exercise extreme precautions and take assistance of an office of WBA & AS, if necessary.

(ii) An entry point basic pay in PB-I i.e. Rs. 6600/- (Rs. 4900 + 1700) p.m. will be admissible to casual/daily rated/contractual Group 'D' workers as consolidated remuneration, similar entry point pay (entry point pay in the Pay Band plus Grade Pay) will be admissible to casual/daily rated/contractual Group 'C' worker and an employee of any other category, if he/she fulfils the required condition will be entitled to a monthly remuneration which will be minimum entry level pay of Pay Band and Grade Pay corresponding to his/her category and the remuneration may be

determined in consultation with the Finance Department in the same manner as mentioned above.

- (iii) When such casual/daily rated/contractual workers are allowed the entry point basic pay, they will not get any other allowances like dearness allowance, house rent allowance etc. However, their basic pay will be enhanced by 5% after every three years and the three years will be counted by treating the period from 1st August 2011 to 1st July 2012 as completed year for giving effect to 5 per cent increase in basic pay.
- (iv) The remuneration of casual/daily rated/contractual workers who have not yet completed 10-year service will be equivalent to 75% of the remuneration admissible under sub-para (ii) above subject to a minimum of Rs. 5000/- p.m.
- (v) Those casual/daily rated/contractual workers who will complete 10 year service on 1st July every year will come under the purview of this Order provided no such worker if engaged after 01-04-2010 will come under the purview of this Order.
- (vi) A casual/daily rated/contractual worker who will fulfil the conditions as laid down in sub-para (i) above will continue to be engaged in such a manner till he/she attains the age of 60 years when he/she will be paid an amount of Rs. 1 lakh as one time cessation of engagement benefit.
- (vii) A casual/daily rated/contractual worker may be allowed 30 (thirty) off days a year and a female such worker may be allowed Maternity leave of 180 (one hundred eighty)days in addition to 30 days off as mentioned hereinbefore.
- (viii) A casual/daily rated/contractual worker who is engaged in two different Government Departments but has rendered services for 10 years without a break will come under the purview of this Order.
- (ix) It is reiterated that Officer/Officers responsible for any further engagement of such casual/daily rated/contractual worker will be personally liable for violation of this Order. However, having regard to the exigencies of situation and in order to facilitate smooth running of any project/administration or for serving academic interest where it is absolutely necessary contractual engagement may be made for a very limited period not exceeding 1 (one) year. This engagement shall be made on strict observance of recruitment rules and against sanctioned vacancies. Advertisement shall be published in newspaper and applications shall be invited from eligible candidates to fill up those temporary vacancies. Simultaneously steps should be taken to fill up the vacancies on regular basis following recruitment rules. Such contractual engagement may be renewed from time to time, but not exceeding a total period of 6 (six) years. No claim to regularization of this contractual service in terms of G.O. No. 8305-F dt. 26-09-2005 read with G.O. No. 642-F dt. 24-01-06 shall lie.
- (x) The provisions of this Order will not be applicable where contractual engagement has been made without any sanctioned post and for any specific project for a very temporary period upto a maximum 6 (six) years or

ang up of the project whichever is earlier. Thus in such cases steps will not be required to be initiated for filling up the posts through regular appointments as per the Recruitment Rules, since the posts are temporary by nature.

- (xi) During the period of engagement, the service of a casual/daily rated/contractual worker may be terminated because of involvement in criminal case/misconduct/delinquency/incapacitation etc. or if the concerned worker intends to opt out of the engagement on his/her own.
- (xii) The benefit of this Memo will be applicable *mutatis mutandis* to the Panchayat Bodies/ULBs/ Statutory Bodies.
- (xiii) The casual/daily rated/contractual workers who have already got the benefit with reference to 1st April, 2010 as cut off date will continue to get the benefit in terms of F.D. Memo No. 2966-F(P) dt. 23-04-2010 and No. 11974-F(P) dt. 22-12-2010, while the others will be covered in terms of provisions of this Memo.

The undersigned is further directed to reiterate that henceforth no further engagement of Group 'D' employees, who are engaged in the manner as laid down in F.D. Memo. No. 3727-F dt. 20-05-2009 and paid out of contingency, will be done, on or after 01-04-2010. Officer/Officers responsible for such engagement will be personally liable for violation of this Order.

- (xiv) The final approval will be given by the ACS/Principal Secretary/Secretary as the case may be, of the concerned Department, after exercising necessary checks & balances & ensuring that any ineligible person does not get the benefits of this order.
- (xv) Λ proforma statement is hereby annexed for supplying information by the respective appointing authority to the Administrative Department.
