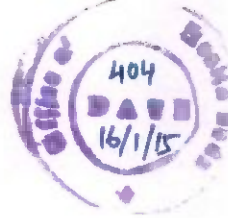

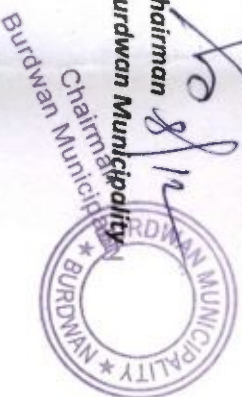

In view of above this is to request you to kindly allow us to fill up the vacant post of FTS as stated above.



This to inform you that while the undersigned visited Burdwan Municipality on 12.02.2009 to attend meeting of MIC, MA & UD; the Vice-Chairperson & CIC-Health handed over copy of communication of the Chairman, Burdwan Municipality bearing no. 1667/XII-II dt. 05.03.2008 along with communication no. 184/XII-II dt. 14.06.2006, 469/XII-II dt. 09.09.2006 and copy of resolution of BOC meeting dt. 21.02.2008.

It may be seen that Chairman, Burdwan Municipality requested Dept. of MA and DLB for placement of Health Officer as the existing one retired on 31.10.2006. In absence of response received by the Department, the ULB has engaged Dr. Debabrata Roy to act as Health Officer w.e.f. 03.11.2006 on contract with consolidated pay which was duly approved by BOC in its meeting held on 21.11.2006 to continue emergency public health services as well as primary health care services effectively. Afterwards Board of Councillors in its meeting held on 21.02.2008 unanimously resolved to continue the services of Dr. Debabrata Roy in the post of Health Officer in pay scale w.e.f. 1st March, 2008.


We must require new Health Officer for the Municipality w.e.f. 1st Nov. 2006 to continue the public Health Services without fail.




