- 1. We have been engaged in the year 1998 as FTS and HHW for successful implementation of the Scheme, IPP VIII (EXTN) for English Bazar Municipality, Malda.
- We have been performing our assigned duties satisfactorily since November, 1998 within the jurisdiction of English Bazar Municipality taking a negligible amount of Honoraria per month.
- 3. We have not been paid our Ad-hoc Bonus for the year 2009-10 having eligible to get the same in terms of the GO No.8751-F(P) dt.27-08-2010, issued by the Finance Department, Audit Branch, Government of West Bengal [Annexure-A].
- 4. It is needless to say that we have been paid Ad-hoc Bonus duly up to the year 2008-09 likewise the other Staff of the West Bengal Government.

In enclosing herewith a self-explanatory Mass Petition [Annexure-A], submitted by some deprived FTSs as well as HHWs engaged in the English Bazar Municipality, Malda for implementation of Urban Health Scheme, I would like to draw your kind attention to the fact that:-

- 1.71 numbers HHW and 14 numbers FTS have been working in this ULB from the date of implementation of the ongoing Urban Health Scheme, IPP VIII (EXTN).
- 2. Up to the financial year, 2008-09, they have been paid the Adhoc Bonus as per the order of the Municipal Affairs Department, Govt. of West Bengal.
- 3. Regarding payment of Adhoc Bonus for the year, 2009-10, necessary order was also issued vide memo No.796/MA/P/C-10/1G-9/2007dt.01-10-2010 [Annexure-B]. But unfortunately, no fund for payment of Adhoc Bonus has been released so far. As a result, Bonus has not been paid. On the contrary, the municipal authority could not provide the same due to insufficiency of its own revenue income.
- **4.** A letter was forwarded for release of necessary fund for Adhoc Bonus well in advance, prior to issuance of the relevant order for Bonus, with anticipation that the Adhoc Bonus would be paid as previous year [Annexure-C]. But, the reply of the same is yet to be received.

MEMORANDUM

SUB.: Grant of Ad-hoc bonus to the State Government Employees and some other categories of Employees for the year 2009-2010.

The undersigned is directed by order of the Governor to say that the Governor is pleased to decide that the State Government employees who are not covered by any of the productivity Linked Bonus Schemes, and whose revised emoluments did not exceed Rs.18,000/- per month as on 31st March, 2010 will be entitled to ad-hoc bonus for the accounting year 2009-2010 at the rate of Rs.1,000/- per head. The upper eligibility ceiling of Rs.18,000/- p.m. as on 31st March, 2010 will be applicable irrespective of whether the emoluments are drawn in the pre-revised or revised scale of pay or on fixed/consolidated contract pay.

- 2. The benefit will be admissible subject to the following terms and conditions:-
- (i) Ad-hoc bonus admissible under this order will be worked out on the basis of emoluments as admissible on 31.03.2010. For the employees drawing pay and allowances in terms of the West Bengal Services (Revision of Pay and Allowances) Rules, 2009, the term 'revised emoluments' in this order will mean and include pay in the pay band plus grade pay in the revised pay structure and includes the non-practicing allowance, if any, Dearness Allowance, but will not include any other pay and allowances such as house rent allowance, medical allowance, compensatory allowances, etc.

For those who are drawing pay and allowances in the unrevised scale, the term 'emoluments' will mean and include basic pay, personal pay, special pay (additional remuneration), dearness pay, dearness allowance, deputation (duty) allowance, Steno allowance and interim relief, if any, but will not include Specialist pay and other allowances such as house rent allowance, medical allowance, compensatory allowance etc. For those who are drawing remuneration on contract basis, the term 'revised emoluments' will mean the consolidated contract pay drawn by them.

- (ii) The employees whose emoluments on 31.03.2010 exceeded Rs.18,000/- p.m. but during the year 2008-2009 their emoluments at least for six months were less than Rs.18,000/- p.m. i.e. the said emoluments exceed the eligibility ceiling of Rs.18,000/- p.m. on account of promotion, drawal of increment, implementation of C.A. Scheme, enhancement of dearness allowance etc. after remaining less than Rs.18,000/- p.m. for at least six months, will be entitled to ad-hoc bonus of Rs.1,000/- per head under this order.
- (iii) The employees who were in services in service on 31.03.2010 and rendered at least 6 months continuous service during the year 2009-2010 will be eligible for payment of ad-hoc bonus under this order.

Pro-rata payment will be admissible in such cases to the eligible employees for periods of continuous service during the year ranging from six months to full year, the eligibility period being taken in terms of number of months of service (rounded off to the nearest number of months). A fraction of 15 days or more should be counted as one month.

(iv) The amount of ad-hoc bonus on pro-rate payment as admissible under para 2(iii) above will have to be calculated according to the following formula:-

- = The amount of ad-hoc bonus, subject to maximum amount of Rs. 1,000/- only.
- (v) The casual workers who have put in work at least for 120 days and the employees on consolidated pay in the year 2009-2010 will also be entitled to ad-hoc bonus under this order according to the following formula:-

Total amount of Salary/Wages earned during the year 2009-2010

= The amount of ad-hoc bonus, subject to maximum amount of Rs. 1,000/- only.

The salary/wages in these cases should have the same meaning as 'revised emoluments' as defined in para 2(i) above.

3. The disbursement of Ad-hoc bonus sanctioned hereinabove should be made in case of Muslim State Government employees in between 1st September, 2010 to 8th September, 2010 and in case of other State Government employees (other than Muslim State Government employees) such disbursement should be made in between 1st October, 2010 to 8th October, 2010.

In case of failure, the disbursement should be made as early as possible before the festival of Durga Puja / Id-Ul-Fitre.

- 4. The charge in respect of payment of ad-hoc bonus under this order will be debitable to the detailed head viz. - 5. The Governor further pleased to direct that the benefit of ad-hoc bonus sanctioned under this order will also be available to the different categories of employees who had been allowed the same in the last year in accordance with Finance Department's Memo No.8605-F, dated 03.0.2009 by issue of Government orders by various Departments in this connection.. As in the last year, orders for grant of ad-hoc bonus in respect of the employees of Statutory Bodies/Local Bodies/State aided Non-Government Educational Institutions and such other categories of employees of various establishments, who were allowed ad-hoc bonus/ex-gratia at par with the State Government employees or at the rate not more than Rs.1,000/- per head as approved by the Government in the last year, should be issued by the Departments concerned without referring the file to Finance Department, Group-'P'.
- 6. Clarifications issued in previous years in respect of various points raised in connection with admissibility and drawal of ad-hoc bonus would continue to apply.



Sir,

In enclosing herewith a self-explanatory Mass Petition [Annexure-A], submitted by some deprived FTSs as well as HHWs engaged in the English Bazar Municipality, Malda for implementation of Urban Health Scheme, I would like to draw your kind attention to the fact that:-

- 1.71 numbers HHW and 14 numbers FTS have been working in this ULB from the date of implementation of the ongoing Urban Health Scheme, IPP VIII (EXTN).
- 2. Up to the financial year, 2008-09, they have been paid the Adhoc Bonus as per the order of the Municipal Affairs Department, Govt. of West Bengal.
- 3. Regarding payment of Adhoc Bonus for the year, 2009-10, necessary order was also issued vide memo No.796/MA/P/C-10/1G-9/2007dt.01-10-2010 [Annexure-B]. But unfortunately, no fund for payment of Adhoc Bonus has been released so far. As a result, Bonus has not been paid. On the contrary, the municipal authority could not provide the same due to insufficiency of its own revenue income.
- **4.** A letter was forwarded for release of necessary fund for Adhoc Bonus well in advance, prior to issuance of the relevant order for Bonus, with anticipation that the Adhoc Bonus would be paid as previous year [Annexure-C]. But, the reply of the same is yet to be received.

The upper eligibility ceiling of Rs.18,000/- p.m. as on 31st March, 2010 will be applicable irrespective of whether the emoluments are drawn in the pre-revised or revised scale of pay or on fixed/consolidated contract pay.

- 2. The benefit will be admissible subject to the following terms and conditions:-
- (i) Ad-hoc bonus admissible under this order will be worked out on the basis of emoluments as admissible on 31.03.2010. For the employees drawing pay and allowances in terms of the West Bengal Services (Revision of Pay and Allowances) Rules, 2009, the term 'revised emoluments' in this order will mean and include pay in the pay band plus grade pay in the revised pay structure and includes the non-practicing allowance, if any, Dearness Allowance, but will not include any other pay and allowances such as house rent allowance, medical allowance, compensatory allowances, etc.

For those who are drawing pay and allowances in the unrevised scale, the term 'emoluments' will mean and include basic pay, personal pay, special pay (additional remuneration), dearness pay, dearness allowance, deputation (duty) allowance, Steno allowance and interim relief, if any, but will not include Specialist pay and other allowances such as house rent allowance, medical allowance, compensatory allowance etc. For those who are drawing remuneration on contract basis, the term 'revised emoluments' will mean the consolidated contract pay drawn by them.

- (ii) The employees whose emoluments on 31.03.2010 exceeded Rs.18,000/- p.m. but during the year 2008-2009 their emoluments at least for six months were less than Rs.18,000/- p.m. i.e. the said emoluments exceed the eligibility ceiling of Rs.18,000/- p.m. on account of promotion, drawal of increment, implementation of C.A. Scheme, enhancement of dearness allowance etc. after remaining less than Rs.18,000/- p.m. for at least six months, will be entitled to ad-hoc bonus of Rs.1,000/- per head under this order.
- (iii) The employees who were in services in service on 31.03.2010 and rendered at least 6 months continuous service during the year 2009-2010 will be eligible for payment of ad-hoc bonus under this order.

Pro-rata payment will be admissible in such cases to the eligible employees for periods of continuous service during the year ranging from six months to full year, the eligibility period being taken in terms of number of months of service (rounded off to the nearest number of months). A fraction of 15 days or more should be counted as one month.

(iv) The amount of ad-hoc bonus on pro-rate payment as admissible under para 2(iii) above will have to be calculated according to the following formula:-

- = The amount of ad-hoc bonus, subject to maximum amount of Rs. 1,000/- only.
- (v) The casual workers who have put in work at least for 120 days and the employees on consolidated pay in the year 2009-2010 will also be entitled to ad-hoc bonus under this order according to the following formula:-

Total amount of Salary/Wages earned during the year 2009-2010

= The amount of ad-hoc bonus, subject to maximum amount of Rs. 1,000/- only.

The salary/wages in these cases should have the same meaning as 'revised emoluments' as defined in para 2(i) above.

3. The disbursement of Ad-hoc bonus sanctioned hereinabove should be made in case of Muslim State Government employees in between 1st September, 2010 to 8th September, 2010 and in case of other State Government employees (other than Muslim State Government employees) such disbursement should be made in between 1st October, 2010 to 8th October, 2010.

In case of failure, the disbursement should be made as early as possible before the festival of Durga Puja / Id-Ul-Fitre.

- 4. The charge in respect of payment of ad-hoc bonus under this order will be debitable to the detailed head viz. "Ad-hoc Bonus" the opening of which was sanctioned under the "Salary" head sub-ordinate to all Major, Minor and Sub-heads in the Revenue Expenditure section of the State Budget in terms of para 9 of this Department's Order No.4611-F, dated 22.04.1988 and necessary fund for this purpose have been provided under the above detailed head in the budget grant available for 2010-2011.
- 5. The Governor further pleased to direct that the benefit of ad-hoc bonus sanctioned under this order will also be available to the different categories of employees who had been allowed the same in the last year in accordance with Finance Department's Memo No.8605-F, dated 03.0.2009 by issue of Government orders by various Departments in this connection. As in the last year, orders for grant of ad-hoc bonus in respect of the employees of Statutory Bodies/Local Bodies/State aided Non-Government Educational Institutions and such other categories of employees of various establishments, who were allowed ad-hoc bonus/ex-gratia at par with the State Government employees or at the rate not more than Rs.1,000/- per head as approved by the Government in the last year, should be issued by the Departments concerned without referring the file to Finance Department, Group-'P'.
- 6. Clarifications issued in previous years in respect of various points raised in connection with admissibility and drawal of ad-hoc bonus would continue to apply.

Matrisadan & OPD is project of Englishbazar Municipality, which is constructed with the financial assistance from SUDA with the object of providing health care to General Public mainly to females (Matri) at an affordable cost. As such, object is not profit maximization instead wealth maximization in terms of services to mankind. The feasibility report is prepared to ascertain a point of no profit and no loss i.e. a point where recurring expenditure of Matrisadan is met by its own recurring revenue through internal sources without taking any financial aid from Englishbazar Municipality.

AIM & OBJECTIVE:

To provide better health care services who the inhabitants of Englishbazar Municipality are at an affordable price and to run the institution on "No profit – No loss" basis.

2). HUMAN RESOURCE RESTRUCTURING:

At present, there are 53 nos. employees engaged at Matrisadan which includes Doctors as swell as other staffs and a monthly expenditure of Rs. 1,40,600/- is being incurred under Salary & Wages.

- a). Medical Superintendent
- b). General Duty Medical Officer
- c). Visiting Doctors
- d). Consultant Doctor

a). MEDICAL SUPERINTENDENT

One post, preferably who will be residential and he will be responsible for the administration of the hospital, as well as his service will be utilized as General Duty Medical Officer. He will be paid by Matrisadan.

b). GENERAL DUTY MEDICAL OFFICERS

General Duty Medical Officers will be appointed by Englishbazar Municipality. Their duty will be 8hrs. to 12 hrs. by rotation in any shift and they will porovide4 consultation at OPD, manage the Indoor patients and also assist in the O.T. during their duty shifted their duty shift. They will also admit their patient form outdoor under their supervision.

They will get mo9nthly salary from the Matrisadan as well as the consultation fees collected from the OPD and a certain amount from bed rent and OT assistant charges for managing the in bed patients and O.T. assistance.

c). <u>VISITING DOCTORS</u>

The local doctors who are interested to admit their patient under their supervision at Matrisadan, they will be called as VISITING DOCTORS, but their name has to be approved by the Core Committee. They are not entitled to get any Salary from Matrisadan, but they will collect their fees directly from the patient party or through Matrisadan as per the prefixed charges declared by the committee. The visiting Doctors will be requested to render their professional services at a considerable rate for the BPL patients if approved by the committee.

d). <u>CONSULTANTS</u>

Any Doctor of the locality may be called as a CONSULTANT DOCTOR. This is not necessary to empanel the name of the Consultants. By maintaining the hospital protocol any Doctor may be called if the patient party desires and required charges for the Consultant Doctor will be borne by the patient party.

Any non-empanelled Doctor may refer their patient to Matrisadan, but the patient will be admitted under the supervision o on duty Medical Officer.

NOTE:

Restructuring of Salary for Doctors and other staffs is required leave, duty hers and responsibilities for everyone to be fixed.

Apart from the above, the committee should implement the rules and regulations of the Hospital as sell as the code of conduct for the Doctors and Staffs, so that the Hospital will run with discipline and could satisfy the patient and patient party.

3). REVENUE RE-STRUCETURING:

Total number of Beds – 19, out of which 15 beds are for APL and 4 Nos. are for BPL

OPD CHARGES

- a). BPL patients seen by GDMO and visiting Doctors, charges will be Rs. 25/-per patient per visit. GDMO/visiting Doctor will get Rs. 15/- per patient per consultation and Rs. 10/- will go to the a/c of Matrisadan per patient per consultation.
- b). APL patients seen by GDMO, fees will be Rs. 50/- per patient per consultation Out of which GDMO will get Rs. 40/- per patient per consultation and Rs. 10/- will be deposited in the a/c of Matrisadan for per patient per consultation. If the patient seen by the **Visiting Doctors**, charges for the Matrisadan will be Rs. 10/- and Visiting Doctor will take his own consultation fee, but this amount should be approved by the Core Committee.

INDOOR CHARGES

a). For BPL patients, bed charge will be Rs. 30/- per day. The whole charge will go to the a/c of Matrisadan and the GDMO will provide free services to BPL in bed patients. For consultancy, the Visiting Doctor will get a prefixed charge (suggested Rs. 50/-) to be paid d by the patient party.

Cost of the medicine & other requisites has to be borne by the patient party.

b). For APL patients, bed charge will be Rs. 150/- per patient per day, from which General Duty Medical Officers will get 20% of bed charge and the rest 80% will go to the a/c of Matrisadan per patient per day. Professional charges for the VISITING DOCTOERS to be approved by the Core Committee (preferably Rs. 100-150/- per day or per consultation).

Cost of the medicine and other requisites are extra to be borne by the patient party.

Managing and maintaining 24 hrs. Pharmacy is a time taking and difficult job. So, Matrisadan may allot pharmacy shop to the third party on rental basis with the conditions of keeping and selling desired medicines at reasonable price through out the day i.e. 24 hrs.

5). Extension of Matrisadan Build for up gradation of Diagnostic unit and other Health Care Services

At present the work load in respect of gathering of different type of patients at both Indoor and Outdoor unit of Matrisadan has been increased considerably. It is also experienced that now not only from the municipal area but also the people diving outside this municipality are availing the Maternity facility along with other medical facilities. A statement of Indoor and Outdoor patients attended in this Matrisadan is appended below from which it is found the demand of attending the medical facilities by the BPL as well as APL duly increased in every month.

Expected monthly rent is Rs. 1500/- (excluding electric bill)

7). ADVERTISEMENT & POLICY:

In the present era, advertisement & publicity is not only essential for commercial institutions but also for Govt., Semi-Govt. or Charitable institution. Matrisadan has to aware the people at large about its services, its rate benefits, details of doctors in order to enhance its patient turnover through proper publicity. It is a vital assignment and core committee should plan its strategy at a regular interval.
