



Provided that no such resolution shall be moved before the expiry of six months from the date of assumption of office by a Chairman, and if such resolution is not carried by a majority of the

Rules, 1995

Rule 6(3):-

"(3) If there is a requisition for removal of the Chairman under subsection (3) of section 18, -

 a special meeting for considering the resolution for removal of the Chairman shall be held in the manner laid down in these rules;

(b) if the resolution for removal of the Chairman is duly carried out, the vacancy in the office of the Chairman shall be filled up by election at a meeting to be held in accordance with the procedure laid down in clauses (b), (c) (d) and (e) of sub-rule (2), the provisions of which shall apply mutatis mutandis."

Rule 9:-

- *9. Extraordinary meeting. (1) In an extraordinary meeting, no matter, other than the one for which the meeting has been convened, shall be discussed. Such meetings may be -
 - (a) an emergent meeting; or
 - (b) a special meeting.
- emergent nature, may be convened, at any time, by the Chairman or, in his absence, the Vice-Chairman, after giving twenty-four hours' notice to the members.
- (3) (a) A special meeting may be convened by the Chairman or, in his absence, by the Vice-Chairman suo motu after giving not less than three days' notice to the members.
- (b) A special meeting may/also be convened after giving not less than three days' notice to the members, on a requisition containing specifically the agenda and signed by not less than one-third of the total number of Councilors of the Municipality, by -

(i) the Chairman, within fifteen days from the date of receipt of such requisition or, on his failure to do so.

- (ii) the Vice-Chairman within seven days thereafter or, on his failure to do so, or
- (iii) any three of the Councillors of the Municipality within further seven days thereafter.

(c) Notwithstanding anything contained in these rules, if the situation so demands owing to stalemate condition prevailing in the functioning of the Municipality, the officer may, in the interest of public service, convene a special meeting of the Municipality with at

least three days' notice to the members, specifying the agenda and venue of the meeting ' (Quoted)

Mr. Amal Baran Chatterjee, the Learned Counsel appearing for the 10 (ten) Councilors (Respondent Nos. 5 to 14) claims majority on the basis of the Order passed on 18.9.2008 by another Hon'ble Single Judge and which reads as follows:

The writ petitioners claim themselves to be the majority members of Dhulian Municipality in the district of Murshidabad.

Mr. Amai Baran Chatterjee, learned advocate, appears on behalf of the private respondents and submits that his clients are the majority members of the municipality.

It is not possible for this court to decide which group is the majority group.

I, therefore, direct the Sub-Divisional Officer, Jangipur, Murshidabad, to convene a meeting of all the councilors of Dhulian Municipality in the office of the municipality and to ascertain the views of the members by secret ballot.

The Sub-Divisional Officer is, also, directed to submit a report in this regard one week after reopening of the court after long vacation for the year 2008, when this writ application shall appear as 'for orders' before the regular bench subject to the convenience of that bench.

During the pendency of this writ application, the board of councilors of the municipality shall not take any policy decision.

Let xerox plain copies of this order duly countersigned by the Assistant Registrar (Court) be made available to the learned advocates for the parties on usual undertakings and for taking steps in the matter.

Learned Counsel states that pursuant to the aforementioned Order dated 18.9.2008, the secret ballots were received and opened in Court on 19.12.2008 and upon examination of the ballots, it was evident that only 9 (nine) supported the Petitioners whereas 10 (ten) supported the Respondents. Learned Counsel states that since the majority has been proved against the Petitioners, the writ petition should be dismissed. Learned Counsel relies upon the Order dated 19.12.2008 which reads as follows:

The sealed cover containing nineteen ballot papers is opened in Court today.

On Examination of the ballots, this Court finds that out of nineteen Councillors, nine supported the petitioners and the rest ten supported the private respondents.

Thus, the majority views are against the writ petitioners.

Be that as it may, Mr. Bhattacharjee, learned Advocate appearing for the petitioners now submits that the exercise which has been made for taking the view of the Councillors of the said municipality by secret ballot is practically a futile exercise as his clients in fact have challenged the legality of the notice by which the meeting was convened for removal of the Chairman of the said municipality.

Under such circumstances, the hearing of this application stands adjourned till Monday next.

Let the ballot papers be kept with the record.

submits that Section 18(3) of the Act itself lays down and emphasizes the word "majority" as well as on the word "meeting to be called". He states that merely because on 11.8.2008 the Vice-Chariman had issued a notice that a meeting would be convened on 20.8.2008, that by itself is



not sufficient to meet the requirements as laid down either under Section 18(3) of the Act or under Rule 6 of the Rules.

This Court is inclined to accept the submissions of Mr. Amal Baran Chatterjee for the reasons stated hereinafter.

Upon the perusal of Section 18(3) it is absolutely clear that the Chairman can be removed from office by a resolution carried by a majority of the members. In the instant case, two factors in support of the Respondents qua the word "majority" are, that firstly, the requisitionists were 10 (ten) in number out of 19 (nineteen) and secondly, pursuant to a judicial Order of this Court on 18.9.2008 quoted above, the majority view, on opening of the sealed cover on 19.12.2008, was against the Petitioners. On both the counts, therefore, the majority view is against the Petitioners.

Mr. Bhattacharya submits that in view of the provisions of Rules 6 read with Rules 9(3)(b)(i) and Rules 9(3)(b)(ii), since the meeting itself was called by the Vice-Chairman within 7 (seven) days after the 15th day expired on 6.8.2008, the same was in terms of the Statute and the Rules, therefore, cannot be questioned.

Such a submission does not appeal to this Court at all. Under Section 18(3) of the Act a Meeting has to be "called" and under the Rules, the meeting has to be convened. The Rules

cannot be interpreted in such a manner that it will have the effect of rendering otiose the provisions of the principle Act. In the instant case, the words used in the principle Act being Section 18(3) is "called". In other words, the meeting must have been called within the period stipulated in the Rules. The interpretation of the words used in the Rules, namely "convened" must be interpreted in such a manner that the convening of the meeting should be such that it is actually held within the time frame indicated in the Rules themselves. In other words, if under Rule 9(3)(b)(ii) the Vice-Chairman was required to convene the meeting within seven days from the expiry of the 15th day i.e. 6.8.2008, then the act of actually holding the meeting in terms laid down under Section 18(3) read with Rule 6(3)(a) should have been within 7 (seven) days from 6.8.2008 itself i.e. latest by 13.8.2008. In the instant case, the meeting was held on 20.8.2008 which is beyond time and, therefore, the other 3 (three) Councilors, within three days from 13.8.2008, correctly exercised their rights, under Rule 9(3)(b)(iii) and called the meeting on 19.8.2008 (i.e. within a further 7 days after 13.8.2008).

15. The meeting of the Respondents held on 19.8.2008, therefore, was correct and the meeting of the Petitioners held on 20.8.2008 was, for the foregoing reasons, irregular.

For the foregoing reasons, this Court holds that the writ petition has no merit. It is accordingly dismissed.



Enquiry Report on selection of HHWs in Dhulian Municipality

Date of enquiry: 01.12.2007 Enquiring Officer: GP Kundu, DDLB

Ref: SUDA No. SUDA-Health/63 ULBs/07/494, dated 28.09.2007 of Director, SUDA and subsequent instruction of DLB, WB and Director, SUDA

Following are the salient points revealed during enquiry which may be perused.

1. A list of selected HHWs (regular 19 plus paneled 7) was prepared by Dhulian Municipality earlier. The same was subsequently cancelled as per direction of SUDA

2. On cancellation of the previous list of selected HHWs fresh notice was issued on 26.06.2007 seeking application for HHWs, but no further applications were received till last date of 05.07.2007.

Old applications were considered afresh. These applications were further checked primarily in presence of representative of SUDA and 100 applicants were summoned for test/interview held on 06.08.2007.

4. 88 out of 100 applicants appeared before the committee comprising the Chairperson, representative of SUDA, BMOH, one health committee member and Sanotory Inspector. ACMOH and BDO, though said to have invited, could not attend.

5. Regular and paneled HHWs were selected as follows

There is no reference of BPL in many cases. It was said that final list of BPL is still not available with them and all selected HHWs are said to be from BPL families.

7. Out of 9 complainants 3 could be met. They are Yasin Seikh, Councillor, Ward No. 11, Dilip Sarkar, councilor, Ward No. 5 and Safar Ali, Councillor, Ward No. 8. They could not produce any document in support of their complaint. However, Safar Ali verbally complained about the irregularities. Also Md. Moinuddin (husband of Majeda Bibi, Councillor, Ward No. 15, another complainant) showed a xorox copy (un-attested) of one school-certificate in respect of Anjura Khatun (a person objected to), daughter of Manu Seikh, issued on 05.09.2007 from Dhulian Balika Vidyalaya where the date of her birth was mentioned as 27.05.1974 and she was in class VII in 1987. According to transfer certificate issued from Momintola Senior Madrasah, her date of birth is 02.01.1975 and passed Class VIII in 1989. In either of the cases, however, the age is between 25 and 35 years. He also showed a chit of unsigned paper according to which date of birth of Purnima Das (the person objected to) daughter of Surjakanta Das is said to be 05.11.1969 as per her Admit Card (no proof given) when she alleged to have appeared in Sec. Exam. In 1989 from Fotullapur High School. But as per attested copy of transfer-certificate issued from Momintola Sr. Madrasah, she had passed Class VIIIin1989 and her date of birth is 21.07.1972. No other substantial proof could be produced. Both Fotullapur High School and Momintola Senior Madrasah are outside Dhulian Municipality.

8. Notice for BOC meeting of 07.09.2007 was issued on 01.09.2007 with 11 agenda of which 9th was in connection with HHW-selection. In this meeting the list of selected HHWs was voted out in 10-9 margin, total no. of Councillors being 19.

- Notice for subsequent BOC meeting of 25.09.2007 was issued on 17.09.2007 with 3 agenda, 2nd being HHW-selection. In this meeting 10 Councillors were present and passed the list of selected HHWs.
- 10. It is true that Smt Purnima Das was selected as HHW of Ward No. 16 while her husband Sri Bhagyanath Das was one of the members of the selection committee and was present during the conduct of test/ interview. This may be unethical, but there might not have been any bar so far as the constitution of the selection committee is concerned.

11. Following are the examples of transfer certificates issued from Momintola Senior Madrasah against which doubts were expressed in the complaint.

Enquiry Report on selection of HHWsunder CBHCS and others in respect of Dhulian Municipality

Date of enquiry: 19.04.2007 Enquiring Officer: GP Kundu, ADLB

Following are the salient points revealed during enqury which may be perused.

A. Selection of HHWs under CBHCS


- Notice invitingapplications for deployment of HHWs was first issued on 5.12.2006 from 35-45 years women (married/ left by husband/ widow) before knowing the actual selection procedure circulated by SUDA, last date of submission being 12.12.2006
- Then a revised notice was issued on 16.12.2006 seeking applications from 25-45 years women, last date receiving being 23.12.2006.
- In both the cases the notices were issued not in conformity with the model notice form circulated by SUDA. Main shortcomings were: (1) no mention of BPL women, (2) wrong age-group, (3) wrong minimum qualification and (4) no mention of desirable motivation/experience in rendering social work.
- Application format was also not in conformity with the one modelled by SUDA as there
 was no mention of bpl reference and motination/ experience in social work, if any.
- The ULB does not have any BPL list approved by district authority. They are only having the information of no. of BPL families (3,206) and the no. of BPL persons (9,315) as per MR Dealers' reportssaid to have approved by SCF&S. There are 3,016 AAY families (17,380 units) 26 recipients of Annapurna Yojana.
- Municipality level Health & Family Welfare Committee was formed by BOC on 20.06.2006.
- Total no. of applications received by the ULB for HHW was about 120 ranging from 3 from a couple of wards to 17 from ward no. 10.
- The lists were primarily scrutinized by MHFW Committee and arrived at the finally selected list of both for regular and panel HHWs.
- Candidates were not summoned for any test/ interview to assess their merit for the particular job assignment. SUDA was not informed either for the process of final selection.
- However, finally selected candidates are all married women and are in the age-group of 25-35 years one from each ward for 19 regular HHWs and not more than one from any ward for 7 panel candidates, all having educational qualification of Class-VIII or above.
- The selected candidates may not be all from BPL families as there no mention of BPL reference or any certificate to that effect from councilors/ others said to have verbally certified by the councilors or confirmed from field experience.
- However, no equipments have so far been procured by the ULB and the fund allotted is lying with the ULB.

Implementation of ILCS.

- Primarily sanctioned by SUDA was 9056 cases and later revised to be 8310.
- The ULB maintains separate registers for ILCS beneficiaries both for Super-structure type and for Dorma-mat type from whom the ULB has received beneficiaries' contributions (Rs. 1500 for SS and Rs. 250 for DM type from each).
- Total no. of beneficiaries who contributed for ILCS is 8310. Rs. 17,76,000 was contributed by 1184 for SS type and Rs. 17,81,500 was contributed by 7126 for DM type. Ward-wise break up is also available with the ULB. But there is no reference of issuance of work order and completion thereafter. So during field inspection I had to take with me both the registers.
- Fund received from SUDA has fully utilized both for SS and DM types (Rs. 23,27,200 plus Rs. 2,50,96,950).

- Beneficiaries' contributions were deposited in separate Bank Λ/c, having a current balance of Rs. 14,161 only, work order issued for all 1184 SS cases and for 7000 DM cases out of 7126 cases.
- According to MED report as on 2.2.2007, 1173 SS cases abd 6891 DM cases were completed and a few are ongoing, though work held up due to non-receipt of funf from SUDA, since a bank-draft endowed by SUDA for the purpose was lost during transit.
- Earlier on 21.8.2006 MED had submitted a claim of Rs. 62,77,920. Subsequently on 13.3.2007a revised claim Rs. 53,52,275 was preferred by MED.
- Physically verified sites of at least 10 constructions in ward nos. 10, 8 and 11 and tried to
 collect information from people nearby. All are found to have constructed. Except one
 (where the latrine is not used and bricks of the soak-pits taken out, may be due shift of
 residence), all are pressed into good use and users are quite happy having their own toilet.
- There is demand for more low cost latrines in Bidi workers infested slum areas.

Uddin Sk, son of Mohammed Sk of Kanchantola complained that he had contributed Rs. 250 long back, but the work was left after digging the pit only. As monsoon approaches he feared more damages. So was the complain of a few others. It was confirmed the work could not be completed in spite of issuing work order in fear of non-availability of fund

C. Other remarks

 The ULB is to cater a 80,000 strong population in 19 wards with less than 40 permanent staff, half of whom are conservancy workers.

Economy of the area revolves around Bidi manufacturing. About 3/4th of the population depend directly or indirectly on Bidi industry. Bidi making, being a hazardous job, most of the Bidi workers live in a very shabby environment.

 There is no EO or FO and ULB is understaffed. Upto last month the job of IIC and Accountant was shouldered by a single person. However, from this month one Accountant has joined. There is only one SAE posted at present.

 Financial management is not that bad though BSR is pending since 2000, BSRs for 2000-02 and 2002-04 are under preparation and audit report for 2004-06 received recently.

• There is no diversion of fund and no PF amount undeposited.

Fund utilization position is however not good.

 Tender for work/ supply of materials are publicized in local and sub-divitional offices, comparative statements prepared and work/supply order issued after approval.

 Appropriation register, cash book, MBs, IT/ST/security deduction registers and bill/vouchers were checked as they belong to a chained process. IT/ST deducted are regularly deposited. TDS and payment certificates are issued regularly.

HC does a commendable job but he has to shoulder everything. This may sound
unhealthy for an organization. Also accountant cash book is incomplete due to nonreconciliation of bank a/c statement.

No water tax charged. Pipe water supply does not cover all wards/ all pockets of wards.

Road network, drainage, waste disposal are far below the mark.

 Annual administration report and annual financial report are normally prepared and submitted, but those are pending for the year 2005-06 and 2006-07.

Progress of KUSP roll out program is very poor. Only city level sensitization
programme was held. DPG and DTGs could not be constituted fully and ward level
programmes are yet to start. AFC and Urban Planner could not be selected as yet.
However computer literacy programme for the selected staff started.


