Written test and viva voce for all the eligible & willing HHWs of each SC will be conducted on the same day by MHFWC on the prescribed questionnaire from SUDA. The date & time for selection is to be intimated to all the members of MHFWC including SUDA well in advance.

The MHFWC will select the suitable candidates for the post of FTS per SC and prepare SC-wise final list for placement before the BOC meeting.

The list of finally selected FTSs so ratified by the BOC meeting is to be forwarded by the Chairman of the ULB to the undersigned for office record. The selected FTSs are to undergo training, the details of which will be intimated to you on receipt of list of selected FTSs. On completion of such training for FTSs, they will be engaged as FTSs for which necessary instruction will follow.

- 6. Up to date Monthly Progress report has been submitted to the Project Officer / Director, SUDA Health . This Report has been done by Honorary Health Workers and also Compiled by M & S Cell Staff.
- 7. Awareness Program and other Immunizations Program has been done successfully like Pulse Polio etc.

- 8. SUDA has already been informed regarding arrangement of the training in respect of M & S Cell Staffs of Community Based Primary Health Care Service of Dhuliyan Municipality.



Both the State as well as the

Respondent nos. 5 to 14 are represented by their respective Counsel. All the nine (9) Petitioners are Councilors of the Dhuliyan Municipality, P.O. Dhuliyan in the district of Murshidabad out of which the Petitioner no. 1 is the Chairperson and the Petitioner no. 2 is the Vice-Chairman.

Similarly, the Respondent nos. 5 to 14 are also Councilors of the same municipality.

- These Petitioners pray for an Order commanding upon the Respondents to forebear from giving effect to or from acting in furtherance of a notice dated 14.8.2008 as contained in Annexure "P-2" as well as the communication made by the Additional District Magistrate (D), Murshidabad and addressed to the Chairman of the Municipality vide Annexure "P-4" informing him that the meeting proposed to be convened by the Vice-Chairman on 20th August, 2008 was being cancelled under the provisions of Rule 9(b)(ii) of The West Bengal Municipalities (Procedure and Conduct of Business) Rules, 1995 (hereinafter referred to as the said Rules).
- 3. The Petitioners also pray for a similar relief commanding upon the Respondents not to give effect to the communication dated 18.8.2008 issued by the Additional District Magistrate (D), Murshidabad (Annexure "P-5") informing that in place of Rule 9(b)(ii) mentioned in the earlier letter dated 14.8.2008 (Annexure "P-4"), the same be read as Rule 9(3)(b)(ii) of the said Rules. The Petitioners also pray for an Order commanding upon the Respondents not to give effect to any Resolution that may have been taken on 19.8.2008 with regard to a removal of the Chairman and further, also

commanding them to act strictly as per the resolution dated 20.8.2008 which was sought to be cancelled by Annexure "P-4" as aforesaid.

gathered from the writ petition are that on 22.7.2008, 10 (ten) Councilors out of 19 (nineteen) gave notice to the Chairman vide "Annexure-P" requesting him to convene a meeting for discussing the agenda relating to adopting a resolution for her removal from office. On failure on the part of the Chairman to call such a meeting, the Vice-Chairman by his notice dated 11.8.2008 (as contained in Annexure "P-1") informed the Councilors that a 'No Confidence Motion' meeting would be held on 20.8.2008.

Thereafter, on 14.8.2008 three Councilors namely, the Respondent Nos. 5, 8 and 12 issued a notice on 14.8.2008 vide Annexure "P-2" stating that since the Chairman and the Vice-Chairman had failed to convene the meeting on the requisition dated 22.7.2008, they therefore and in terms of the provisions of Rule 9(3)(b)(iii) of Chapter III of the said Rules requested 19 (nineteen) Councilors including the Petitioners to attend a special meeting to be held on 19.8.2008. By the impugned communication of the same day i.e. 14.8.2008 (Annexure "P-4"), the Additional District Magistrate (D) proceeded to cancel the meeting that was sought to be convened on 20.8.2008. The Petitioners have stated that on 19th August, 2008 a

meeting was held by the ten requisitionists of "Annexure-P" in glaring violation of Rules 9(3)(b)(i) read with 6(3) and Section 18(3) of the Act and, therefore, no cognizance should be given to any resolution that may have been taken on the said day i.e. on 19.8.2008 for the removal of the Chairman.

The Petitioners have stated that in any event, on 20th August. 2008, a meeting was held in which 9 (nine) Councilors were present and in which resolution was taken against the requisition for the removal of the Chairman. The documents pertaining to the meeting held on 20.8.2008 have been marked jointly as Annexure "P-6", "P-7" and "P-8".

7. Mr. Milan Chandra Bhattacharya, the Learned Counsel for the Petitioners states and submits that 10 (ten) Councilors out of 19 (nineteen) had requisitioned a Meeting vide "Annexure-P" in terms of Section 18(3) of the West Bengal Municipal Act, 1993 (hereinafter referred to as the said Act) read with Rule 6(3) of the said Rules. According to Mr. Bhattacharya, reading the aforementioned provisions of Section 18(3) of the said Act with Rule 6(3) and Rule 9(3)(b)(i) of the said Rules, the meeting ought to have been held within 15 (fifteen) days from the date of the requisition i.e. on 22.7.2008 and 15 (fifteen) days thereafter would have lapsed on 6.8.2008. According to him, if the Vice-Chairman, within seven days after the 15th day, as per

the provisions of Rule 9(b)(ii), called a meeting, then it would be valid and in terms of the statute without any irregularity. In the instant case, the period of 7 (seven days) lapsed on 13.8.2008 from 6.8.2008 and, therefore, since the Vice-Chairman, by his notice dated 11.8.2008 had called the meeting, it was valid and, therefore, there could not have been any further resolution on 19.8.2008 prior to six months in terms laid down under the proviso to Section 18 (3) of the said Act and that too, when, in the resolution taken on 20.8.2008 (Annexure "P-6"), it was resolved NOT to remove the Chairman and that the members therein had full faith and confidence upon her.

8. In order to adjudicate this case, it would be relevant to take notice of the relevant provisions of the Act and the Rules which are quoted below:

"The West Bengal Municipal Act, 1993.

Section 18:

- 18. Terms of office of Chairman.- (1) The Chairman shall cease to hold office as such if he ceases to be a Councillor of the municipal area.
- (2) The Chairman may, at any time, by giving a notice in writing to the Board of Councillors, resign his office, and the procedure for acceptance or otherwise or the resignation shall be such as may be prescribed.
- (3) The Chairman may be removed from office by a resolution carried by a majority of the total number of [elected members] of the Board of Councillors holding office for the time being [present and voting by them,] at a special meeting to be called for this purpose in the manner prescribed upon a requisition made in writing by not less than one-third of the total number of [elected members] of the Board of Councillors, and the procedure for the conduct of business in the special meeting shall be such as may be prescribed:

Provided that no such resolution shall be moved before the expiry of six months from the date of assumption of office by a Chairman, and if such resolution is not carried by a majority of the

balulos,

total number of jelected members, no further resolution for such purpose shall be moved before the expiry of a period of six months from the date on which the former resolution was moved."

West Bengal Municipalities (Procedure and Conduct of Business)

Rules, 1995

Rule 6(3):-

"(3) If there is a requisition for removal of the Chairman under subsection (3) of section 18, -

a special meeting for considering the resolution for removal of the Chairman shall be held in the manner laid down in these rules;

if the resolution for removal of the Chairman is duly carried out, the vacancy in the office of the Chairman shall be filled up by election at a meeting to be held in accordance with the procedure laid down in clauses (b), (c) (d) and (e) of sub-rule (2), the provisions of which shall apply mutatis mutandis."

Rule 9:-

- *9. Extraordinary meeting. (1) In an extraordinary meeting, no matter, other than the one for which the meeting has been convened, shall be discussed. Such meetings may be -
 - (a) an emergent meeting; or
 - (b) a special meeting.
- (2) An emergent meeting for transaction of business of an emergent nature, may be convened, at any time, by the Chairman or, in his absence, the Vice-Chairman, after giving twenty-four hours' notice to the members.
- (3) (a) A special meeting may be convened by the Chairman or, in his absence, by the Vice-Chairman suo motu after giving not less than three days' notice to the members.
- (b) A special meeting may also be convened after giving not less than three days' notice to the members, on a requisition containing specifically the agenda and signed by not less than one-third of the total number of Councilors of the Municipality, by -
- (i) the Chairman, within fifteen days from the date of receipt of such requisition or, on his failure to do so,
- (ii) the Vice-Chairman within seven days thereafter or, on his failure to do so, or
- (iii) any three of the Councillors of the Municipality within further seven days thereafter.
 - (c) Notwithstanding anything contained in these rules, if the situation so demands owing to stalemate condition prevailing in the functioning of the Municipality, the officer may, in the interest of public service, convene a special meeting of the Municipality with at

least three days' notice to the members, specifying the agenda and venue of the meeting ' (Quoted)

9. Mr. Amal Baran Chatterjee, the

Learned Counsel appearing for the 10 (ten) Councilors (Respondent Nos. 5 to 14) claims majority on the basis of the Order passed on 18.9.2008 by another Hon'ble Single Judge and which reads as follows:



The writ petitioners claim themselves to be the majority members of Dhulian Municipality in the district of Murshidabad.

Mr. Amai Baran Chatterjee, learned advocate, appears on behalf of the private respondents and submits that his clients are the majority members of the municipality.

It is not possible for this court to decide which group is the majority group.

I, therefore, direct the Sub-Divisional Officer, Jangipur, Murshidabad, to convene a meeting of all the councilors of Dhulian Municipality in the office of the



municipality and to ascertain the views of the members by secret ballot.

The Sub-Divisional Officer is, also, directed to submit a report in this regard one week after reopening of the court after long vacation for the year 2008, when this writ application shall appear as for orders' before the regular bench subject to the convenience of that bench.

During the pendency of this writ application, the board of councilors of the municipality shall not take any policy decision.

Let xerox plain copies of this order duly countersigned by the Assistant Registrar (Court) be made available to the learned advocates for the parties on usual undertakings and for taking steps in the matter.

Learned Counsel states that pursuant to the aforementioned Order dated 18.9.2008, the secret ballots were received and opened in Court on 19.12.2008 and upon examination of the ballots, it was evident that only 9 (nine) supported the Petitioners whereas 10 (ten) supported the Respondents. Learned Counsel states that since the majority has been proved against the Petitioners, the writ petition should be dismissed. Learned Counsel relies upon the Order dated 19.12.2008 which reads as follows:

The sealed cover containing nineteen ballot papers is opened in Court today.

On Examination of the ballots, this Court finds that out of nineteen Councillors, nine supported the petitioners and the rest ten supported the private respondents.

Thus, the majority views are against the writ petitioners.

Be that as it may, Mr. Bhattacharjee, learned Advocate appearing for the petitioners now submits that the exercise which has been made for taking the view of the Councillors of the said municipality by secret ballot is practically a futile exercise as his clients in fact have challenged the legality of the notice by which the meeting was convened for removal of the Chairman of the said municipality.

Under such circumstances, the hearing of this application stands adjourned till Monday next.

Let the ballot papers be kept with the record.

Learned Counsel further states and

submits that Section 18(3) of the Act itself lays down and emphasizes the word "majority" as well as on the word "meeting to be called". He states that merely because on 11.8.2008 the Vice-Chariman had issued a notice that a meeting would be convened on 20.8.2008, that by itself is



not sufficient to meet the requirements as laid down either under Section 18(3) of the Act or under Rule 6 of the Rules.

This Court is inclined to accept the submissions of Mr. Amal Baran Chatterjee for the reasons stated hereinafter.

Upon the perusal of Section 18(3) it is absolutely clear that the Chairman can be removed from office by a resolution carried by a majority of the members. In the instant case, two factors in support of the Respondents qua the word "majority" are, that firstly, the requisitionists were 10 (ten) in number out of 19 (nineteen) and secondly, pursuant to a judicial Order of this Court on 18.9.2008 quoted above, the majority view, on opening of the sealed cover on 19.12.2008, was against the Petitioners. On both the counts, therefore, the majority view is against the Petitioners.

Mr. Bhattacharya submits that in view of the provisions of Rules 6 read with Rules 9(3)(b)(i) and Rules 9(3)(b)(ii), since the meeting itself was called by the Vice-Chairman within 7 (seven) days after the 15th day expired on 6.8.2008, the same was in terms of the Statute and the Rules, therefore, cannot be questioned.

Such a submission does not appeal to this Court at all. Under Section 18(3) of the Act a Meeting has to be "called" and under the Rules, the meeting has to be convened. The Rules

Parlos

cannot be interpreted in such a manner that it will have the effect of rendering otiose the provisions of the principle Act. In the instant case, the words used in the principle Act being Section 18(3) is "called". In other words, the meeting must have been called within the period stipulated in the Rules. The interpretation of the words used in the Rules, namely "convened" must be interpreted in such a manner that the convening of the meeting should be such that it is actually held within the time frame indicated in the Rules themselves. In other words, if under Rule 9(3)(b)(ii) the Vice-Chairman was required to convene the meeting within seven days from the expiry of the 15th day i.e. 6.8.2008, then the act of actually holding the meeting in terms laid down under Section 18(3) read with Rule 6(3)(a) should have been within 7 (seven) days from 6.8.2008 itself i.e. latest by 13.8.2008. In the instant case, the meeting was held on 20.8.2008 which is beyond time and, therefore, the other 3 (three) Councilors, within three days from 13.8.2008, correctly exercised their rights under Rule 9(3)(b)(iii) and called the meeting on 19.8.2008 (i.e. within a further 7 days after 13.8.2008).

15. The meeting of the Respondents held on 19.8.2008, therefore, was correct and the meeting of the Petitioners held on 20.8.2008 was, for the foregoing reasons, irregular.
