Your petitioner states that your petitioner appeared in the departmental examination for being promoted in the post of First Track Supervisor (FTS) under Bongaon Municipality and ultimately there was a major illegalities and irregularities were caused in the process of selection for the said post of First Track Supervisor

the basis of her voice of protest the illegal appointment of two First Track Supervisors were cancelled and for this reason of raising the voice of protest against the illegal activities of the concerned authorities of the Bongaon Municipality the petitioner became under the oblique view of the respondent municipal authorities and since then she was subjected to humiliation and harassment on the behest of the municipal authorities and the respondent no. 9 out of said grudge filed a suit for defamation against the petitioner herein before the Civil Court leveling some false and fictitious allegations against the petitioner herein wherein the petitioner has already entered appearance and contesting the same.

But the respondent no. 6 gave a false and frivolous report to the Deputy Director, Government of West Bengal, Department of Municipal Affair, Writers' Building, Kolkata - 700001 by a letter vide memo no. B.M. 1109 dated 26-10-2010 and the petitioner herein came to learn as to the said report since the copy of the said report was forwarded to the petitioners by the Deputy Director, Government of West Bengal, Department of Municipal Affair, Writers' Building, Kolkata - 700001 by a letter vide no. 704/M.A./O/C-7/2P-28/2002 dated 03 - 12 - 2009.

The photo copy of the said letter dated 03-12-2009 issued by the Deputy Director, Government of West Bengal, Department of Municipal Affair, Writers' Building, Kolkata – 700001 along with the letter dated 26 – 10 – 2009 as issued by the respondent no. 6 are annexed herewith and collectively marked with letter P-3 to this application.

Your petitioner states that after perusing the said report it transpired to the petitioner that the allegations as leveled against the petitioner in the said report and the statement made therein by the respondent no. 6 is entirely false and fictitious and nothing but a cock and bull story.

ping - pong boll running from office on one authority to another, fruitlessly, since last three months.

That your petitioner lastly on 27-03-2010 again gave a representation to the Chairman, Bongaon Municipality and copy of which was also forwarded to the Deputy Director, Government of West Bengal, Department of Municipal Affair, Writers' Building, Kolkata – 700001, by speed post on 29-03-2010 by speed post but the same is also not heeded by the concerned respondents.

VIII. For that the impugned action and / or inaction of the respondent authority is otherwise bad in law and liable to be interfered with by this Hon' le Court in exercise of its exra-ordinary writ jurisdiction.

29. The application is made bonafide and for ends of justice.

In the above facts and circumstances your

Petitioners pray most humbly that Your

Lordships would graciously be pleased to:-

A] A writ of and/or in the nature of mandamus do issue to command the respondents

particularly the respondent no. 3 and 6 to reinstate the writ petitioner in her service as the Honourary Health Worker (HHW) under the Community Based Primary Health Care Service (CBPHCS) in the Bongaon Municipality;

B] A writ of and/or in the nature of mandamus do issue to command the respondents particularly the respondent no. 3 and 6 and to pay the petitioner the Salary / Honourarium w. e. f. 06 – 08 – 2009, when the writ petitioner was illegally terminated from her service till date @ Rs. 3500/÷, which the writ petitioner was last paid in terms of Honourarium / Salary as the as the Honourary Health Worker (HHW) under the Community Based Primary Health Care Service (CBPHCS);

C] A writ of and/or in the nature of mandamus do issue to command the respondents particularly the respondent no. 3 to reinstate the writ petitioner in her service as the Honourary

Health Worker (HHW) under the Community Based Primary Health Care Service (CBPHCS) pursuant to the letter of request issued by the respondent no. 6 in favour of the respondent no. 3 vide memo no. B/M 46 dated 08 – 01 – 2010 (as annexure-P-4);

D] A writ of and/or in the nature of mandamus do issue to declare that act of the respondents and each of them and/or their men, agents, servants, employees, staffs, subordinates and/or authorities and/or any and/or each of them, of terminating the writ petitioner from her service as Honourary Health Worker (HHW) under the Community Based Primary Health Care Service (CBPHCS) is unlawful and violative to the constitutional right of the petitioners.

E] Pass Appropriate Direction(s)/Order(s).

F] Rule NISI do issue in terms of prayers (A) to (G) above;

G] Pass an interim order restraining the respondents to pay subsistence allowance to the writ petitioner w. e. f. 06 – 08 – 2009, when the writ petitioner was illegally terminated from her service as the Honourary Health Worker (HHW) under the Community Based Primary Health Care Service (CBPHCS) till date and thereafter month by month till the disposal of this writ application and / or till the writ petitioner is reinstate in her service as Honourary Health Worker (HHW) under the Community Based Primary Health Care Service (CBPHCS) with full back salaries / Honourarium w. e. f. 06 – 08 – 2009.

H] Pass ad interim order(s) in terms of the above interim order.

I] Pass such further and/or other order(s)/direction(s) as may seem fit and proper.







The eligibility criteria of the ULB for selecting First Tier Supervisor (FTS) from amongst the regular HHWs working under CBPHC are as under:

- HHWs working for at least 6 months after joining in the post.
- HHWs completed base line Health survey, submitted report to the ULB and the ULB forwarded the same to SUDA.
- > HHWs started family visit fortnightly, entered health data in Family Schedule.
- > HHWs prepared and submitted fortnightly HMIS report to the ULB and the ULB forwarded the same to SUDA monthly at least for last 2 months.
- > The ULB identified all the required no. of Sub-Centres.
- > The ULB completed purchase of furniture, equipment & drugs for Sub-Centres.
- The ULB engaged Medical Officer as per order of Dept. of Municipal Affairs.
- The service activities for immunization, ANC / PNC check up and general treatment clinic initiated in the Sub-Centres.

The ULBs who have satisfied the above mentioned criteria are to send a confirmation to the undersigned prior to selection of FTSs from amongst the regular HHWs.

While selecting the candidature for FTS following criteria should be taken into consideration.

Criteria for Selection:

- i) Age between 25 36 years.
- ii) Minimum educational qualification Madhyamik Pass and is able to do simple arithmetical calculation,

- iii) She should have executed her duties properly while working as regular HHW. Preliminary assessment is to be done by HO / MO (in their absence Executive Officer). Check list of which are as follows:
 - Attendance and field activities / performance,
 - Collection and compilation of base line health survey data,
 - · Ability in filling up of Family Schedule, HMIS format,
 - · Maintaining records, registers,
 - Assist in conduct of immunization, ANC / PNC clinic, general treatment clinic,
 - · Level of capacity for motivational work,
 - · Possession of leadership quality.

The list of HHWs per SC is to be prepared by the HO / MO (in their absence Executive Officer) indicating gradation of preliminary assessment as good / average / poor. The said list is to be placed on the day of selection of FTS before the Municipal Level Health & Family Welfare Committee (MHFWC) who has been vested with the responsibility of selection.

Written test and viva voce for all the eligible & willing HHWs of each SC will be conducted on the same day by MHFWC on the prescribed questionnaire from SUDA. The date & time for selection is to be intimated to all the members of MHFWC including SUDA well in advance.

The MHFWC will select the suitable candidates for the post of FTS per SC and prepare SC-wise final list for placement before the BOC meeting.

The list of finally selected FTSs so ratified by the BOC meeting is to be forwarded by the Chairman of the ULB to the undersigned for office record. The selected FTSs are to undergo training, the details of which will be intimated to you on receipt of list of selected FTSs. On completion of such training for FTSs, they will be engaged as FTSs for which necessary instruction will follow.


