It is observed that the letter of WB Municipal Health Schemes' Employees Congress has mentioned about three Health schemes namely CUDP III, IPP-VIII, Community Based Primary Health Care Services. There are other Health programmes of similar nature implementing by the ULBs namely CSIP, IPP-VIII (Extn.), RCH Sub-Project, Asansol and HHW Scheme in 11 Non-KMA ULBs.

From the said letter it is not clear for which category of personnel the demands have been placed. However, it is to mention here that all the personnel working under different Health programmes in the ULBs are mostly engaged for part time work (12 noon to 4 p.m.) on contract & honorarium basis. Few personnel like Resident Medical Officer, Asstt. Health Officer and staff of Management & Supervision Cell are full time worker engaged on contract and consolidated salary basis.

Recently the rate of honorarium has been increased by the MA Dept. w.e.f. 01.04.2008.

The rate of honorarium varies for the different category of part time personnel – the details are as under:

Demand of the Employees Congress & Comments / Proposal are as under:

1. "That we may kindly be treated as Municipal Employee giving minimum wage".

They are deployed by the ULB. Minimum wage for them may be considered for.

2. "That all the categories of workmen in CUDP III. IPP-VIII & Community Based Primary Health Care Services their monthly wages must be equal and no differential treatment be made from one category to another".

Discrepancy in the honorarium for the category of personnel of different Health programmes in respect of HHWs & FTSs have been removed with the recent enhancement of honorarium.

 "That at the time reviewing to change the present staff norms of Municipalities etc. we may kindly be absorbed in permanent posts given priority (which will be vacant) according to our qualification & experience".

Probably there is no permanent posts in the Municipal establishment of the nature of HHWs & FTSs' job. If there is vacancy in other post of permanent nature in the establishment of Municipality there may be no bar if the recruitment rules & regulation complies as it is not the promotional one.

4. "That we may kindly be given same leave facilities like present permanent Municipal Employees".

As such Maternity leaves are in vogue at par with the Government rules. The other leave rule for the part time employees may be considered for them.

5. "That we may kindly be supplied with good sarees minimum 3 (within 6 months of a year), blouse etc. each year".

Uniform of two sets of saree & blouse were provided in two phases by CMU in a span of last three years.

Provision of supply of uniform of two sets to each of the HHWs, FTSs & STSs may be considered for each year.

6. "That all should get minimum Rs. 1,000/- as Puja Ex-gratia before 15 days of each year's Durga Puja".

Puja Ex-gratia @ Rs. 1,000/- are being sanctioned in each year.

Necessary action may be taken by the Dept. to release advance fund to SUDA so that onward release could be made to the ULBs a fortnight before Puja.

7. "All categories of workmen engaged in different Health schemes in ULBs should get appointment letter either from State Govt. or ULB Authority".

Dept. may decide on the issue.

From the said letter, it is observed that 15 point demands embodied in federation memorandum dt. 09.09.2009 is not enclosed.

However, from the 2nd para of the said letter it is seen that their demand is treating "all kinds of Health employees" as casual employees of the ULBs at a minimum wage of Rs. 129/- (Rupees One hundred twenty nine) only per day.

This is to mention here that Honorary Health Workers (HHW), First Tier Supervisors (FTS), Second Tier Supervisors (STS), staff of Health Administrative Unit (HAU), ESOPD and Diagnostic Centre (DC) are working on part time basis (i.e. four hours per working day) on consolidated honorarium per month. The present rates of honorarium for each category of Health Workers are as under:
