

NOTE SHEET



Communications from Chairman of North DumDum Municipality and Baranagar Municipality vide no. NDDM/PH/2526 dt. 12.08.2016 and 181 dt. 18.08.2016 respectively, received by us, for placing of additional fund for procurement of 1)ELISA machine, 2)Hand Cart, 3)Movable Compactor and 4)Auto type solid waste carrier machine and other for taking preventive steps considering the latest outbreak of suspected Dengue diseases in different urban areas, are placed herewith at Flag "A" and "B" respectively.

- A) In case of North Dum Dum Muncipality, they have not mentioned in their letter (at Sl. no. 1) about specification of ELISA machine and estimated cost to be borne for such procurement. Hence, it is proposed that they may be requested for placing the letter with specification duly vetted by Government hospital/ CMOH etc with the amount required for such purchase. If approved with regard to items at sl. no. 2-4 i.e Hand Cart, Movable Compactor and Auto Type solid waste carrier machine engineering section, SUDA may be requested for further action for obtaining necessary specification and allotment therefore at their end.
- B) In case of Baranagar Municipality, the only amount that is relevant for health wing is 'Cost of preventive measures' for Rs. 7,50,000/- at Sl. no. IV. But it may be mentioned here that we have already released fund of Rs. 4,89,000/- for procurement of lervicidal oil, IEC etc vide our memo no. SUDA-Health/65(Pt.-VII)/14/71(124) and SUDA-Health/65(Pt.-VII)/14/76(124) dt. 29.07.16 & 02.08.16 respectively.

In case of Sl. no. III, we have already released special fund for such campaign for health check up of senior citizen and Rs. 15,36,000/- has already been released for special cleanliness campaign. Hence, the ULB may be requested to expend the earmarked fund for the specific purpose as noted by them.

Furthermore, it is worthy to mention here that we have unspent fund of Rs. 84.13 lakhs under the heading BMS grant released by Department of Municipal Affairs for prevention of vector borne diseases (containing unspent fund for 2011-12, 2013-14 and 2014-15 all together and after payment for procurement of leaflet).

Considering the urgency we may agree to the proposals of both Chairmen for allotting the special grant for the aforementioned purpose and request them to lodge the same claim with estimated amount vetted by authorized Govt. department with a declaration about the usage of the machine with adequacy of trained technician.
