The humble petition of the petitioners abovemaned most respectfully -

SHEWETH:-

- 1. Your petitioners state that your petitioners are all citizens of India having their permanent residence at the address as mentioned in the cause title of the instant writ petition.
- 2. Your petitioners state that a project proposal with regard to community based primary health care service was approved by the Department of Health and Family welfare. The grossroot level man power and facilities admitted for Murshidabad Municipality is as follows:-

(Regular)16

1st panel for peplacement of

- Your petitioner states that the following criteria for selection of Honorary Health Workers as fixed by the concerned authority is as follows:-
 - (i) To be selected from the 8 P L Population of the respective ward.
 - (ii) Must be female in the age group of 25 - 35 years.
 - (iii) Preferably married.
 - (iv) Minimum class-VIII pass
 - (v) Having motivation / experience of fendering social services.

- 4. Your petitioners state that the process for selection of Honorary Health Worker was also been fixed by the concerned authority. The process for selection of Honorary Health Worker is as follows:-
 - (i) The issue of selection of Honorary Health
 Workers is to be put in the Board of councillors
 meetings meeting of the municipality.
 - ii. Notice to be put up in the Notice Board inviting the applications from the women for B p L families.
 - committee in consultation with the Chairman will form a 4 or 5 member selection Sub-Committee for preliminary selection of Honorary Health workers. The said committee will prepare the list of preliminary candidates for final selection.

(iv. Final selection will be done by the Health and family welfare committee where one representative from Management and Supervision Cell at SUDA will be present.

v. List of finally selected candidates against each ward and list of panel candidates in preference seriatim is to be prepared.

vi. The list of such finally selected and panel candidates will be displayed in the Notice Board for information and reporting within stipulated period for training.

A true copy of the said proposal with regard to community base primary Health Service as approved by the Department of family Health and Welfare in respect of Murshidabad Municipality is annexed hereto and is marked with Annexure

interview of the intending candidates the Chairman,

Murshidabad Municipality selected 6 candidates for the

purpose of appointment as Honorary Health Worker. The

said selection list was prepared by the Chairman,

Murshidabad Municipality on 6.8.2007. The list of the

Selected candidates are as follows 1-

- 1. Soma Biswas Petitioner No.4
- 2. Dipali Biswas (Das) Petitioner No.3
- 3. Lina Mukherjee (Chakraborty) petitioner No.6
- 4. Gouri Pramanick(Sharma) Petitioner No. 5
- 5. Kakali Sarkar (Hazra) Petitioner No.2
- 6. Baby Biswaspetitioner No.1

Thus it appears that your petitioners are all selected for attending the training course strating from 10.8.2007 and the said training course course could continue for a period of 45 days.

- the Municipal authority prepared a panel of 16 candidates for appointment as Honorary Health Workers. The said panel was prepared on 6.8.2007. The candidates whose names appeared in the said panel of 16 did not perform satisfactorily in the interview.
- 7. Your petitioners state that it was notified by the Chairman Murshidabad Municipality that the empanelled candidates are to attend the training course. The said notification was issued on 6.8.2007.
- 8. Your petitioners state that pursuent to the notification dated 6.8.2007, your petitioners attended the training course for a period of 45 days from 10.08.2007.
- 9. Your petitioners state that after completion of the said training your petitioners appeared in the examination canducted by the concerned authority and Your petitioners performed better than the candidates whose names appeared in the panel of 16 candidates.

- Your petitioners state that on 15.10.2007

 Your petitioners came to know from the office of the Municipal authority that your petitioner will be appointed as Honorary Health Workers. Your petitioners further came to know that the process of giving such appointment will start from 01.11.2007.
 - came to know from the Municipal authority that the Municipal authority has included the names of councillors of ward Nos. 12 and 15 in the panel of 16 candidates.

 prepared from appointment as Honorary Wealth Workers.

 Your petitioners further came to know that only 16 candidate will be given appointment as Honorary Health Workers and your petitioners who were selected earlier on the basis of better performance in the interview will not be considered for appointment as Honorary Health Workers.
 - 12. Your petitioners state that the name of your petitioners were excluded from the panel for appointment as Honorary Health Workers without any

reasons. The reasons for exclusion of names of your petitioners were not intimated to your petitioner. As such your petitioners submitted a representation dated 17.10.2007 to the S.D.O Lalbagh, Murshidabad as well as to the Chairman, Murshidabad Municipality.

A true copy of the representation dated 17.10.

2007 is annexed hereto and is marked with Annexure "p2"

to this petition.

the panel, the Municipal authority included the name of certain candidates who are not eligible for appointment to the said post. The near relatives of some councillors and the accountent of the Municipality have been included in the said panel. The names of two cannoillors have alos been included in the panel for appointment of Honorary Health Worker's. Your petitioners being aggrieved by and dissatiafied with the preparation of the said panel submitted 9 representation to the Director Supr. District Magistrate as well as the S.D.O Lalbagh.

- authority acted illegally and malafide by not publishing the panel of candidates whose name were considered for appointment as Honorary Health Workers.
- of training course an interview was conducted by the Trainers (Doctor and the Nurse) and in the said interview your petitioners performed better than the candidates whose names appeared in the panel of 16.
 - authorities have acted illegally and malafide by not preparing the following panels as specified in the guidelines for selection of Honorary Health Workers.
 - i). No. of Regular Honorary Health Workers.
 - ii) . 1st panel for replacement of Honorary Health Workers to be upgraded to F T S's.

if required in future.

petitioners submitted an application before the S.D. Lalbagh on 15.11.2007 interalia praying for furnishing certain information with regard to No.16 female candidates who have been selected for appointment as Honorary Health Workers in Murshidabad Municipality.

A true copy of the said prayer for furnishing information on 15.11.2007 is annexed hereto and is marked with Annexure "P4" to this petition.

Lalbagh, by a memo No. 2165 dated 21.11.2007 informed your metitioners that the matter is not related to the office of the s.D.O under such circumstances the office of the S.D.O has no acess to the required information.

It was also stated that since the information is related with the Chairman Murshidabad Municipality, your petitioners were asked to contact with the Chairman Murshidabad Municipality for required information.

True copy of the said memo being No. 2165 dated
21.11.2007 is annexed hereto and is marked with Annexure
"P5" to this petition.

thereafter your petitioner submitted an application
dated 3.12.2007 before the Chairman, Murshidabad Municopality interalia praying for furnishing the information
regarding the appointment of Honorary Health Worker of
the said Municipality.

a true copy of the said application dated 3.12.

2007 is annexed hersto and is marked with Annexure "P6"

to this petition.

20. Your petitioners state that inspite of receipt of the same application dated 3.12.2007, the Chairman Murshidabad Municipality is sitting tight over the matter and have not furnish the information as sought for by your petitioner.

- 21. Your petitioners state that the Municipal authorities have prepared the panel by violating the process for selection of the Honorary Health Workers while preparing the panel of 16 candidates the respodents authorities have not strictly followied.not strictly followed the Criteria leid down for selection of Honorary Health Worker. Most of the candidates selected for appointments do not possess minimum education qualification required for appointment to the said post. Most of the candidates also do not fall within the age group fixed for selection of Honorary Health Marka Workers. Most of the selected candidates do not have the experience of pendering social service.
- 22. Your petitioners state that the panel of 16 candidates which has been prepared by the Municipal authorities for appointment of the Honorary Health workers is illegal and arbitrary. As such the said appeal is required to be cancelled and/or quashed.

Thus being agrieved by and dissatiafied with the illegal and malafide action on the part of the municipal authority by preparing a panel of 16 candidates arbitrarily for appointment to the post of Honorary Health Worker's by excluding the names of your petitipner, your petitioners begs to move the instant application under article 226 of the Constitution of India before Your Lordships on the following amongst other:

GROUNDS

- For that the Chairman Murshidabad Municipality

 acted illegally and malafide by preparing a panel

 Without following the procedures laid down for

 selection of Honorary Health Worker's.
- II. For that the Chairman Murshidabad Municipality acted illegally and malafide by preparing a panel without following the citerial laid down for marking selection of Honorary Health Workers.

- acted illegally and malafide by excluding the names of your petitioner from the panel for giving appointment as Honorary Health Worker's after calling your petitioners to under go the training cause.
- To that the respondent municipal authority acted illegally and malafide by including the names of the candidates in the panel of 16 whose performance in the interview was below the performance level of your petitioners.
- v. For that the respondent Municipal authority acted illegally and malafide by including names of some candidates who does not fall within the age group of 25 35 years.
- VI. For that the chairman Municipal authority

 acted illegally and malafide by including the

 name of some candidates in the panel who do

 not have motivation/experience of rendering

 social services.

VII. For that the Chairman Municipality acted

illegally and melafide by not selecting the

candidates from the BPL population of the

respective words.

VIII. For that the Chairman Murshidahad Municipality acted illegally and malafide by including the name of near relation of the councillors and accountant of the said municipality.

TX. For that the Chairman, Murshidahad Municipality acted illegally and malafideby including the name of councillors of word No. 12 and 15 in the panel of 16 EMBRIGHER for appointment as Honorary Health Workers.

acted illegally and malafide by not preparing
separate panels for Regular Honorary Health
worker's 1st panel for replacement of Honorary
Health Worker's to be upgraded to F T S's
2nd panel for filling of the vacancies if
required in future.

- XI. For that the respondent Municipal authorities acted illegally and malafide by not publishing the panel officially.
- AII. For that the respondent Municipal authority

 acted illegally and malafide by not intimating

 your petitioners the reasons for excluding the

 name of your petitioners, were the panel of

 selected candidates.
 - XIII. For that the Chairman Murshidabad Municipality acted illegally and malafide by not furnishing the information of the 16 female candidates who have been selected from appointment.
 - XIV. For that the respondent authority acted
 illegally and malafide by sitting right over
 the representation of your petitioner for
 such a long time.
 - XV. For that the Principle of natural justice been grossly violated in the instant case.

- of injunction is passed restraining the respondent authorities from giving appointment to the candidates as Honorary Health Worker's from the panel of 16 candidates till the disposal of the instant writ petition, your petitioner will suffer irreparable loss and injury.
- 25. Your petitioners state that there is no other alternative speedy, and efficacious remedy available for your petitioner and the relief which is sought for herein if granted would afford complete relief to your petitioners.
- 26. Your petitioners state that the records relating to the case of your petitioner are lying in the office of the respondent authorities within the appellate side jurisdiction of this Hon'ble Court and as such this Hon'ble Court in its appellate side jurisdiction has jurisdiction to try and entertain the instant writ petition.

- 27. Your petitioners state that your petitioners has not moved any other writ petition and/or any other application either before this Hon'ble Court or before any other courts in India on the same self sause of action.
- 28. Your petitioners state that unless the orders as prayed for herein are passed, your petitioners will suffer irreparable loss and injury.
- 29. This application is made bonafide and in the interest of justice.

In the premises as aforesaid your petitioners most humbly prays that Your Lordships would graciously be pleased to issues :-

(a) A writ in the nature of Mandamus

commanding the respondent authorities

to set aside and cancel the panel of 16

candidates prepared for giving appointment

to the post of Honorary Health Worker's.

- commanding the respondent authorities

 to give appointment to your petitioners

 as Regular Honorary Health Worker's

 whose names were selected on 6.8.2007

 in the list prepared by the concerned

 respondent authority;
- (c) A writ in the nature of Mandamus commanding the Murshidabad Municipality to furnish the information regarding the 16 candidates whose names have been included in the panel for appointment as Honorary Health Worker's.
- (d) A writ in the nature of Mandamus

 commanding the respondent authorities to

 consider the representation submitted

 by your petitioners;

- (e) A writ in the nature of Certiorari commanding the respondents to certify and transmit the records relating to the case of your petitioners to this Hon'ble Court so that Your Lordships on perusal of the same may do concerable justice to your petitioner by setting aside quashing, amending, altering and/or varying any orders that may be found to have been passed illegally and adverse to the interest of your petitioners;
- (f) Rule NTSI interms of prayer a,b, c and d,e above;
- (g) An order of injunction restraining the respondent authorities from giving appointment to the post of Honorary Health NEXAS worker's to the 16 candidates whose names have been included in the panel;





A Community Based Primary Health Care services programme in 63 Municipalities outside the Kolkata Metropolitan Area had been launched by the Dept. of Health & Family Welfare and Dept. of Municipal Affairs on 24th February, 2006.

The objective of the programme were:

- (a) To bring an overall improvement in the urban health scenario as a whole with reference to reduction in Crude Birth Rate, Maternal Mortality Rate, Infant Mortality Rate and enhancement of Couple Protection Rate.
- (b) (b) To provide primary health care service delivery to the urban population with focus to Below Poverty Line (BPL) population
- (c) To implement public and National Health Programmes for the population of the Urban Local Bodies (ULBs)

Strategy

- (a) Health & Family Welfare Committee for each of the Urban Local Body is to be formed
- (b) Decentralisation of services in three tier system i.e grass-root (door-step), Urban Sub-Health Centre and referral to the govt. hospitals for effective permeation of Reproductive & Child Health (RCH) care services, Public Health services to the community
- (c) Providing package of primary health care services by the Female Honorary Health workers (HHW) at grass-root level
- (d) One HHW is to look after approx. 1000 BPL population or 200 BPL families and to maintain link between the health facilities and the community
- (e) A Sub-centre is to cover approx. 5000 BPL population. One First Tier Supervisor wil; l be in charge of each Sub-centre
- (f) The FTS will be selected in due course from amongst the regular HHWs working at least for six months and will undergo schedule training after which will be engaged as FTS. After such engagement the resultant vacancies will be filled up from the selected panel candidates.

Statement with regard to programme implementation at Murshidabad Municipality

(a) Letter bearing no. SUDA-Health / 63 ULBs/ 06 / 175 dt. 03.11.2006 issued to the Chairman , Murshidabad Municipality on the subject of Grass-root level man-power and Health facilities under the said programme. In this letter , entitled no. of regular HHWs , no. of panel candidates , total no. of regular HHWs and panel candidates to be selected & trained , no. of regular HHWs to be engaged after completion of training , no. of Sub-centres and no. of First Tier Supervisors.

Guideline for selection of HHWs was also enclosed along with this letter.

- Amendment in the panel list was done and communicated to the municipality vide this office memo no. SUDA-Health /63 ULBs/ 06/181 (60) dt 13.11.2006, wherein ist and 2nd panel list was clubbed keeping total no. of panel candidates unaltered.
- (c) Letter no. 16(10) M.M dt. 10.04.07 of the Chairman, Murshidabad Municipality on the subject of interview for Honorary Health workers to be held on 20 21.04.07 was received by this office. Accordingly, Dr. Naresh Chandra Mondal, Community Development Officer, HHW Scheme, Jangipur Municipality was deputed as representative of State Urban Development Agency (SUDA) to attend the selection process of regular HHWs & panel candidates at Murshidabad Municipality on the above mentioned dates.
- (d) List of selected regular HHWs and panel candidates signed by the President of Municipal Level Health & FW Committee and other members i.e., Dy. Magistrate, SDO (L), President Health Sub-Committee, Representative of ACMOH, Lal bag and representative of SUDA dt. 21.04.2007.
- (e) Further communication to the Chairman was made by this office vide letter no. SUDA-Health /63 ULBs /07/70 dt. 11.5.2007 on receipt of a copy of representation by Smt . B. Mondal who happens to the nominee of District Magistrate, Murshidabad for selection of Honorary Health Worker.

The detailed enquiry reveals that Poulami Choudhury (Hazra) procured false certificate from Kolan P.B. Vidyapith in order to increase her age as per eligibility criteria. Her actual date of birth is 1st day of August, 1985 as revealed from her Admit Card issued by West Bengal Board of Secondary Education, which does not qualify her requirement age. That is why she procured false certificate from Kolan P.B. Vidyapith which shows her date of birth as 01.8.1981 in order to make her age more than 25 years.

By producing this false certificate issued from Kolan P.B. Vidyapith Poulami Choudhury (Hazra) could succeed in getting the appointment of Honorary Health Worker.

In the light of the above, you are requested to lodge FIR against Poulami Choudhury (Hazra) and Teacher-in-Charge, Kolan P.B. Vidyapith for adopting fraudulent tactics for wrongful gain. You are further requested to remove Poulami Choudhury (Hazra) from the post of H.H.W at once.

It appears from the guideline that the female aged 25 to 35 years, BPL Population, Preferably married, minimum Class-VIII having motivation with experience of Social Service, will be the criteria of candidate. There is no bar to the Councillor or the family members of Councillor to be the candidate of the said post. This engagement is Honourary. It is not a Service at all. As the prescribed Committee has already been selected the candidates according to the legal way, so there is no question regarding violation of rules and regulation and also illegal manner by Murshidabad Municipality.

With reference to above, the following activities are to be undertaken by your ULB:

- The names of regular candidates (Sixteen nos.) only is to be listed and put up in the notice board of ULB. asking them to function as HHW with effect from 15th October, 2007 and inform Director. SUDA accordingly with regard to date of joining of HHWs.
- The Chairman of the ULB is to allocate the area of operation for each HHW.
- One HHW will cover a population not exceeding 1,000 BPL contained in a single ward. A ward having less than 1,000 BPL population will have one HHW.
- The HHW shall be responsible for Primary Health Care of BPL families under her jurisdiction and be responsible for both public health and health statistical data collection for the entire population within the ward.
- The ward Councillor will monitor and supervise the activity at ward level.
- HHW Kit bag along with contents provided by SUDA is to be given to all the regular HHWs only.
- To start with, HHW will conduct baseline survey of the allotted BPL families as per the proforma already provided by SUDA, to be checked and scrutinized by HO / MO / SI, who will compile .he data ward-wise and ULB-wise.
- Job responsibility of the HHW (working hours 12-00 Noon to 4-00 P.M. of each working day) is :
 - fortnightly home visit to each BPL families,
 - motivate the community to avail health services collection of data and filling up of Family Schedule,
 - treatment of minor ailments at door step, distribution of drugs for three days maximum,
 - registration of pregnancy within 12 weeks,

- As per Project proposal, the service charge (rental) should not exceed Rs 1.600 per month per Sub-Centre which includes electricity, water & sweeping cleaning charges. These rental charges will only be applicable for the Sub-Centre accommodated in Club (CBO accommodation. There will be no rental charges for the Sub-Centre accommodated in municipal / community accommodation.


