Based on the Memorandum No. 6732-F(P) dt. 03/08/2012 of 'Grant of Ad-hoc Bonus to the State Government Employees and some other categories of Employees for the year 2011-2012' some ULB have raised the question weather TPO/Cos are entitled to get Ad-hoc bonus for the year 2011-12. Some other has requested to reimburse the Adhoc bonus amount to them.

It is observed in the aforesaid memorandum that "the employees on consolidated pay in the year 2011-12 will also be entitled to ad-hoc bonus under this order". The employees under consolidated pay of the Local Bodies are entitled to get the ad-hoc bonus at the rate not more than Rs. 2500/-.

Since the salaries of the full time TPOs and COs are being released by this office we may have the obligation to release or reimburse the ad-hoc bonus as per norms of the department.

If approved, selected ULBs who are having full time TPO/Cos may be informed.

Hence, we may re-circulate aforesaid order copies to all ULBs to follow leave rules of the full time contractual TPO/CO engaged for implementing SJSRY.
