You may kindly be aware that the National level Mission mode programme was launched on 1st April, 2014 in the name of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) to alleviate Poverty and vulnerability in urban in areas.

As it is proved that the SHG is a vehicle for the eliminating poverty and protecting from the vulnerabilities for the poor household particularly the poor women. Hence the DAY-NULM programme has introduced the SHG concept for the poor Women of the urban household. In this programme, there is two tier of federation SHGs Namely Area Level Federation (ALF) and City Level Federation (CLF). The SHGs will get the revolving fund as a grant of Rs. 10000/after 3 months from inception. The ALF is a registered body under Society Registration Act, 1961 and the federation will get a grant as revolving fund of Rs.50000/- from the said programme.

SHG bank credit linkage is an important subcomponent under NULM. Therefore, like rural SHGs, now the urban SHGs are handling large amount of fund to lend their members. In such situation for monitoring of their fund the audit of their accounts is indispensible.

It has come to knowledge that you have already prepared training module and study materials for the SHGs of rural areas, Activity wise there is no difference between rural SHGs and urban SHGs. Therefore, the same training module and study materials can be used for the training of community auditors under NULM.

You are requested to provide the training module and study materials so that we can take approval from our

department to conduct the training.
