As you may be aware, Pradhan Mantri YUVA Yojana (Pradhan Mantri Yuva Udyamita Vikas Abhiyan), a flagship program of the Ministry of Skill Development and Entrepreneurship, aims to provide an enabling environment for potential, existing and early stage entrepreneurs, to start and sustain businesses and become self-employed and further generate employment through their enterprises.

2. A brief of the pilot program to be conducted over a period of 7 months (up to 31st March 2020) along with implementation time lines is placed at enclosure. Based on the pilot a 5-year PM-YUVA schemes is being planned.
3. The activities under the pilot include Mass Awareness Campaign (on entrepreneurship), Entrepreneurship Education Program (ITIs, Polytechnics, PMKK centres and JSS), Mentoring & Handholding (for aspiring entrepreneurs and early stage entrepreneurs).
4. We recognize the role of various concerned departments of skilling ecosystem at the state level, to make the pilot program successful. In this regard, we would like to collaborate with **West Bengal State Urban Development Agency (SUDA)** in West Bengal. SUDA plays an important role in youth empowerment providing Urban youth avenues to take part in the process of nation building as well providing opportunities for the development of their personality and skills through various skilling and livelihood programs.
5. SUDA can play an important part in the PM-YUVA pilot program in the state in different activities, including mass awareness campaign, setting up enterprises for BPL urban youth etc. In pilot phase we will be targeting districts near to Kolkata e.g Kolkata, Howrah, Hoogly, North 24 Parganas, South 24 Parganas, Nadia, Burdawan etc.
6. PMYUVA will be organizing 3 days mentorship and handholding sessions for aspiring entrepreneurs helping them to start up their enterprise and earn their livelihood. PMYUVA will also help existing enterprises to scale up.

1. Background

Skilling and Entrepreneurship are two distinct yet related functions of MSDE. Consequently, Pradhan Mantri Kaushal Vikas Yojna (PMKVY) and Pradhan Mantri YUVA Yojana (PMYY) are the two pillars of this Ministry. While JSS is also focuses on skilling the youth in sector specific trades to make them job ready and motivate beneficiaries to take up self-employment as a career option. PMYY endeavours to create jobs through entrepreneurship education, training, capacity building, mentoring and handholding. Skilling in specific trades does not ensure entrepreneurial competence amongst the trainees. 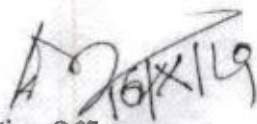

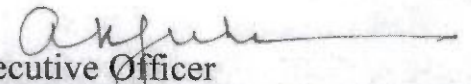
