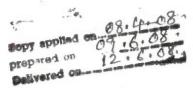

B. 2nd Tier : Neighbourhood committee (NHC)

This middle level tier consists of 3 - 25 NHGs represented by one volunteer; leader of each of the Neighbourhood groups in a Ward. This organisation will perform the following roles:

- 2) provide suggestion for group involvement in meeting community needs and goals (mini-plans),

C. 3rd Tier : Community Development Society (CDS)

CDS will consist of 10 (ten) NHCs being represented by two elected representatives from each of the NHCs, under the area of operation/jurisdiction of the Bally No. 1 CDS.

This apex organisation will be responsible for the following roles and tasks:

- represent needs of all the communities, especially women and children;
- 2) Liaise and link up with agencies and departments to promote action in the community towards fulfillment of their needs;
- 3) identify specific training and arrange for their organisation, post-training follow-up and such other actions as may be necessary;
- 4) facilitate community surveys to identify genuine beneficiaries for economic and shelter benefits;
- 5) prepare community plans and proposals, mobilizing resources from the community, municipality, different departments of the State Central Governments, financial institutions, NHGs and other agencies as may be approved by the State/Central Government;
- 6) facilitate repayment of bank loans by the heneficiaries in time, in co-ordination with the UPE cell of the Municipality;
- 7) create small community assets in identified slums/pars/ mohalla/settlements of the urban poor families in consultation with the UPE cell of the Municipality;
- to be the focal point under Swarna Jayanti Sahari Rojgar

 Yojana for purposes of identification of beneficiaries, preparation of applications, monitoring of recovery and generally
 providing whatever other support is necessary to the progra
 mmes of self-employment and wage employment;

to manage and facilitate thrift and credit activities, to encourage community savings as also other group activities;

- 10) to manage, as per National Slum Development Programme, various community activities including organisation of thrift and credit societies, community Development Fund, provision of community sanitation, pre-schoolm education, non-formal education, audit education and such other social sector programmes, as per Guidelines of the Government from time to time, and
- 11) do all such acts, deeds, matters and things any may be deemed incidental or conducive to the foregoing objectives.

The income and properties of the Society whatsoever derived or obtained shall be applied solely for promotion of the objects of the society and in doing so, direction of the Government, if any, in that regard shall be followed and no portion thereof shall be paid or divided amongst any of its members by way of profits.

Regulations of Bally No. 1 Community Development Society at the town Bally Ward No. 4 of Bally Municipality Howrah District,
West Bengal.

1. Membership :

Bally No. 1 Community Development Society is the formal association of 10 (ten) No. of NHCs under Ward Nos.1,2,3,4,5,6,7,8,9,10 of the Bally Municipality.

This association is based on common goals and objectives. CDS will consist of two representatives. viz. The Chairperson and the Secretary of each Neighbourhood Committee (NHC) as executive members (with voting right). CDS will also include honorary (without voting right) member viz. Town Project Officer, Community Organisors, ward Councillors of concerned Wards, representatives of NGOs, sectoral Departments, leading citizens and other resource persons.

Neighbourhood Committee (NHC) as referred earlier, is a formal association of women living below poverty line (as per identification survey according to guidelines of Govt. of India). This Committee will consist of all the Resident Community Volunteers from 8-15 Neighbourhood Groups (NHG) located in close proximity in urban slums para Mohalla settlements of urban poor people and living within the same electoral ward. These RCVs from NHGs will be executive members (with voting right) and elect/select from amongst themselves. one Chairperson, one Vice-Chairperson, one secretary and one Treasurer. NHCs will also include honorary members (without voting right) viz. Community Organisor concerned Ward Councillor, Secretary of concerned Ward Committee and representatives not exceeding five from various sectoral groups in the community.

Neighbourhood Goup (NHG) as mentioned earlier will comprise of one female member far from each of 10-40 identified BPL families, living in close proximity to each other in urban slum/para/mohalla each in the three electoral Ward. Each Beighbourhood Group (NHG) will select/elect urrough community consensus or any other democratic norm one woman representative from amongst themselves who will be termed as Resident Community Volunteer (RCV).

2. Cessation of Membership :

Any member, herein refered to as RCV will cease to be a member -

- a) on her becoming a non-poor in accordance with the identification survey,
- b)on her tendering of resignation and acceptance of the same by the concerned NHG/NHC/CDS.

3. Register of Members :

Bally No. 1 CDS shall maintain a Register of members containing the members name, address, occupations, date of admission and cessation of membership, similarly, NHC/NHG shall maintain their respective Register of members with the same particulars as above. The Register will be kept open for inspection of the members concerned of CDS/NHC/NHG, on requisition. All entries required to be made therein shall be entered within a period of 15 days.

4. Rights and Obligations of Members :

Any member of the CD Society has the right :-

- a) to elect/to be elected in any election of the CDS (for members having voting rights only);
- b) to submit suggestion for discussion to the Governing Body and sub-committee on any matter relating to the CDS;
- c) to inspect the accounts and the proveedings of the meetings of the CDS on appointment with the Secretary, and
- d) to pay subscription within the prescribed time.



Subhadra Sengupta President and detrimental to the interests of the Society and is also in violation of the Rules and Regulations of the Society, the Governing Body may after due enquiry censure, suspend or even expel the member from the Governing Body. In that case the Governing Body shall first serve the member concerned with a show cause notice showing therein the charges framed and ask here to submit her statement in defence within a month. On receipt of the explanation the Governing Body shall have the power to take suitable action against the erring member after allowing her to defend her case. If no reply to the show cause notice is received within a month, the Governing Body may take an ex-parte decision.

For any act of expulsion or termination, no such member shall be entitled to prefer any claim for compensation of damage even if it is proved on subsequent date that such act of expulsion or termination was wrongful and or unlawful.

6. Governing Body :

- (A) There shall be a Governing Body consisting of one member from each HNC (either of Chirperson and Secretary of NHC). The Office-bearers of Governing Body shall comprise of Chairperson, one Vice-Chairperson, Secretary, two Joint Secretaries, Treasurer and other members. The office bearers and other members of Governing Body will be elected biannually at the A.G.M. excepting that these shall be one C.O. of the U.L.B to function as the ex-officio secretary in the C.D.S Governing Body.
- (B) Register for the removal of Governing Body members shall be dealt with as has been prescribed as in the case of other members noted hereinbefore.
- (C) Term of office of the Governing Body shall be two years, ordinarily, and unless it is dissolved and or terminated early under unforeseen circumstances. After election, the old Governing Body will continue to fundtion till the new Body takes over charge which shall under no circumstances be more than 30 days from the date of election. Any vacancy in the CDS/Governing Body shall be filled up with 4(four) weeks from the date of vacancy by a resolution of majority of members (with voting rights). General Council of
- (D) Meeting of the CDS shall be held at least once in three months at such place, date and time as the Chairperson or the Secretary may determine. Meeting of the Governing Body shall be held every month at a place, date and time as the Secretary/Chairperson



Subhadra Sengupton President of the CDS will be convened by the Town Project Officer/Community Organisor and presided over by an executive members of CDS to be elected in the meeting. Requisition meeting of CDS/Governing Body may be summoned by at least one third members(with voging rights) of the CDS/Governing Body. The Secretary shall summon the meeting within seven days failing which the Chairperson shall do so provided that no business other than specified in the notice shall be transacted in that meeting.

(E) Notice and Quorum :

At least 7 days' of the meeting specifying the place, date and time and the general agenda to be transacted shall be given to every member of the CDS/Governing Body, Emergency meeting may be called on 24 hours' notice.

One third of the members (with voting right) personally present shall constitute a quorum for the meeting of the CDS/Governing Body. Absence of quorum in the meeting, even after lapse of 30 minutes of the scheduled time will eventually lead the members present to adjourn the meeting.

(F) Procedure of the meeting :

The Chairperson or in her absence, the Vice-Chairperson will chair all meetings of CDS on Governing Body. In the absence of both Chairperson and Vice-Chairperson, the members present shall elect Chairman of the meeting. All questions before the meeting will be settled by consensus, failing which the decision will be taken by a majority of votes each member (except honorary members) will have one vote. The Chairman of the meeting shall have a second or casting vote in addition to his own vote, in case of equality of votes.

7. Duties, Responsibilites and Powers:

The Governing Body shall have general power of supervision and conduct over all the affairs of the CDS at its various tiers and in particular, shall discharge the following duties:

a) to appoint sub-committee with such duties and powers as may be considered necessary and expedient.

- b) to accept donation, gift, subscription, movable or immovable properties for fulfilling the objects of the CDS,
- c) to sell, lease, mortagage or otherwise dispose of or deal will or any part of the property of the society,
- d) to keep proper accounts of the society and to open bank account in the name of the society in one or more banks,
- e) to co-opt honorary/ex-officio members in the CDS,
- f) to engage temporarily on contract basis one person to assist the Secretary/Treasurer in the maintenance of records, accounts etc.
- g) to propare CDS area based plans on the basis of Community Action Plans prepared by NHCs and determine priorities for implementation of plans,
- h) to sanction schemes, projects, etc. to be undertaken by CDS,
- i) to facilitate thrift and credit activity at NHG level, mobilise resources, organise Community Development Fund etc.
- j) to prepare budget of the society, and
- k) to conduct any other business as may be delegated upon by the CDS or by the ULB/State Government and not specified hereinbefore, to meet the duties and obligations of the society under various Urban Poverty Alleviation Programmes of the State and Central Government.

8. safe custody of Properties :

- (i) The Governing Body shall be responsible for the safe custody of the fund, properties and assets of the CDS.
- (ii) The fund of the society shall be kept in Savings Account/ Fixed Deposits with any scheduled commercial bank/co-operative bank/post office in the area of operation of the society.

9. Books of Accounts & Inspection :

The books of accounts and other statutory books shall be kept at the registered office which shall be located at a central place within its jurisdiction and shall be open to inspection of the members at such time and place as the Governing Body directs on a written request made by any member.

10. Accounting Year :

The accounting year of the society shall be form the 1st day of April of each year to the 31st day of March of the following year.

11. General Meeting :

i) Annual General Meeting :

(A) Notice

The Secretary shall call the Annual General Meeting within two months from the end of the last financial year giving at least 14 days' notice to all members. The Notice shall contain the place, day, time and agenda of the meeting.

(B) Agenda

The business to be transacted at the AGM shall be :

- to confirm the minutes of the last AGM and of special General Meeting, if any;
- ii) to adopt with or without modification the report of the working of the CDS for the previous year;
- iii) to pass audited accounts of CDS for the previous year ended;
- . iv) to appoint qualified Auditor or Auditors;
 - v) to transact such business as may be fixed by the Governing Body;

- vi) to transact such other business as may be brought forward by giving 14 days' notice from any member and
- vii) to conduct elections to the Governing Body biannually.
- (C) Quorum of the meeting :

One third of the total number of members (with voting right) of the CDS personally present at the commencement of the meeting shall constitute the quorum.

(D) Manner and Method of Voting :

The Chairman of the meeting shall decide the manner and method at the outset of the meeting.

ii) Special General Meeting

A special General Meeting may be convened by the Governing Body at any time depending upon the urgency of the matter. At least 7 days' notice shall be given to every member for special General Meeting.

At least 2/3rds (two-thirds) of the numbers (with voting right) may request the Chairperson of the CDS to hold a special General Meeting. The Chairperson or in his absence, Vice-Chairperson or in the absence of both, the Governing Body shall convene the special General Meeting within one month from the date of receipt of such mequest. In default of the Governing Body, the requisitionists shall hold such meeting provided that no business other than those specified in the notice shall be transacted.

iii) Extra-ordinary General Meeting :

The Governing Body may direct to convene an extra-ordinary general meeting for consideration of addition, alteration or modifications of the Memorandum/Regulations of the CDS. 7(seven) days notice along with the draft of proposed changes shall be sent to all members before the meeting. The resolution for change, amendment etc. of the Memorandum and Regulations be carried out if accepted by the three fourths of the members (with voting right) present at the meeting.

12. Duties of the Officer bearers :

(A) C. D. S :

Chairperson : She shall -

- a) preside over all meetings of the society;
- take all disciplinary actions such as removal, dismissals
 etc. in consulation with the Governing Body;
- c) advise the Secretary in any matter requiring urgent attention;
- d) give pay orders on all bills for payment;
- e) call emergent meeting and
- f) act upon any other resolution adopted by the Governing Body.

Vice-Chairperson:

In the absence of the Chairperson, she shall perform all the duties of the Chairperson.

Secretary : She shall, -

- a) convene all the meeting of the society;
- b) maintain minutes books of all meetings and all other records, documents etc.
- c) issue general circular and notices;
- d) sign on behalf of the society receipts for all sums received as subscription, donation, any other fund etc;

- e) get the accounts of the society audited by a Chartered Accountant;
- f) ensure compliance with all statutory requirements; and
- g) transact any other business that may be assigned upon her by the society.

Joint Secretary :

- a) In the absence of the Secretary, perform all the duties of the Secretary, and
- b) perform any other duty that may be assigned upon her.

Treasurer : She shall, -

- a) collect and receive all sorts of subscription, donations and the deposit of money and issue receipts therefor;
- b) maintain and keep Cash Book and such other accounts as are necessary:
- c) operate Bank Account jointly within with the Secretary or the Chairperson; and
- d) prepare the budget in consultation with the secretary for consideration of the Governing Body.

B. NHC :

Chairperson: Same as in the case of Chairperson of CDS.

Vice Chairperson: Same as those of Vice Chairperson of CDS.

Secretary: Same as those of Secretary of CDS

Treasurer: Same as those of Treasurer of CDS

C. RCV OF NHG

She will act as a channel of information and communication for the NHG on the one hand and provide feedback to NHC or to other forum, as may be necessary.

13. Maintenance and Audit of Accounts :

The CDS shall maintain books of accounts as required under section 15(1)(a)(b) of the Act. The accounts shall be audited by a duly qualified auditor as stated in Section 15(2) of the Act.

14. Suit and Legal Proceedings :

All suits and legal proceedings by or against the society shall be in the name of the Secretary or such person as shall be appointed by the Society.

15. Alteration of Memorandum and Regulations :

The Memorandum and Regulations may be altered, modified, rescineded or added to by special resolutions passed by the this members in an extra-ordinary general meeting called for the purpose.

The society may delegate the Governing Body the powers to make, alter, modify or rescind such bye-laws & rules as may be considered necessary in the interest of smooth functioning of the society.

16. Dissolution of Society :

Subject to the provisions of Sections 24 and 17 of the Governing Body, West Bengal Societies Registration Act, 1961 or any statutory modifications thereof the society may be dissolved by a resolution to that effect passed by the members of the society at a general meeting. The said meeting shall also decide the manner of disbursement of the funds and assets of the society, if any after dissolution.

The CDS (Community Development Society) with the recommendation of Neighborhood Committee (NHC's) will approve the list of beneficiaries to encourage under-employed and unemployed youths to set up small enterprise relating to services, petty business and manufacturing for which there is a lot of potential in urban areas and forward to the Bank to release the loan amount as desired.
- 4. The CDS (Community Development Society) will provide infrastructural support to beneficiaries for setting up micro enterprise in relation to marketing their products etc. by providing selling places in the from of 'Kiosks' and rewari markets, setting up of Nagar Palika Kendra for construction and other services.
- The CDS (Community Development Society) shall extend to help to the Bank to recover/ realize the loan amount within due
- 6. The CDS (Community Development Society) shall arrange to provide skill development through appropriate training to the urban poor in a variety of service and manufacturing trades as well as in local skills and local crafts so that they can set up self employment ventures or secure salaried employment with enhanced remuneration.

- 2. The CDS (Community Development Society) will prepare the list of women beneficiaries belonging to women headed households which are headed by widows, divorces, single women or even households where women are the sole earners and shall be ranked higher in priority than other beneficiaries.
- 3. The CDS (Community Development Society) with the recommendation of Neighbourhood Committee (NHC's) will approve the list of beneficiaries to encourage under-employed and unemployed youths to set up small enterprise relating to services, petty business and manufacturing for which there is a lot of potential in urban areas and forward to the Bank to release the loan amount as desired.
- 4. The CDS (Community Development Society) will provide infrastructural support to beneficiaries for setting up micro enterprise in relation to marketing their products etc. by providing selling places in the from of 'Kiosks' and rewari markets, setting up of Nagar Palika Kendra for construction and other services.
- 5. The CDS (Community Development Society) shall extend to help to the Bank to recover/ realize the loan amount within due time.
- 6. The CDS (Community Development Society) shall arrange to provide skill development through appropriate training to the urban poor in a variety of service and manufacturing trades as well as in local skills and local crafts so that they can set up self employment ventures or secure salaried employment with enhanced
- 7. The CDS (Community Development Society) would be set up service centre for those who have undergone skill upgradation training.
- 8. The CDS (Community Development Society) shall formulating the scheme by formation of DWCUA (a subsidized programme) extended to urban poor women who decide to set up self employment ventures in a group as opposed to individual effort and take up an economic activity suited to their skill training, aptitude and local market. This group strategy shall strive to empower the urban poor women by making them independent as also providing a facilitating atmosphere for collective self employment.
- 9. Community Development Society shall organize motivate and the female members to encourage community savings as also other group activities by formation of Thrift and Credit Societies, generally, for bringing in socio-economic changes in the community, are Altogether it will formed as self banking system a diversion from the conventional banking system with community participation with deposit and credit linkage programme under the control of CDS(Community Development Society).
- 10. The CDS (Community Development Society) shall survey and draw up a list on priortisation of available basic minimum services in the areas and this list along with remarks with respect to where such services should be located etc shall be forwarded to the Urban Local Body to provide wage employment to the beneficiaries from the identified poor families for construction for socially and economically useful public assets.
- 11. Community Development Society will primarily take responsibilities to achieve the goals under KUSP programme to improve urban planning and governance, enhance access of basic urban services to the poor promote pro-poor economic growth. The programme is a multi-sector urban reform programme being implemented by the Municipal Affairs Dept. Govt. of W.B. with financial aid from the Dept. for International Development (DFID) U.K..
- 12. CDS (Community Development Society) is wholly responsible to create capacities in the communities to effectively engage and contribute in improving the living environment through the Jawaharlal Nehru National Urban Renewal Mission (JNNURM) which was launched on 03.12.2005.
- 13. Apart from the above, CDS (Community Development Society) is a body corporate with perpetual succession of identified BPL members having folded responsibilities for changes of economic and social development of the town as entrusted by the Govt. of India, Govt. of W.B. and Urban Local Body after enactment of 74th Constitutional Amendment Act.
- 14. The income generated to CDS (Community Development Society) as surplus after due payment of all rates/ charges/ contracts/ services shall be solely utilized for promotion of the objects of the Society and in no way, shall it be distributed as what person relation Chromora num to any members of the Society.

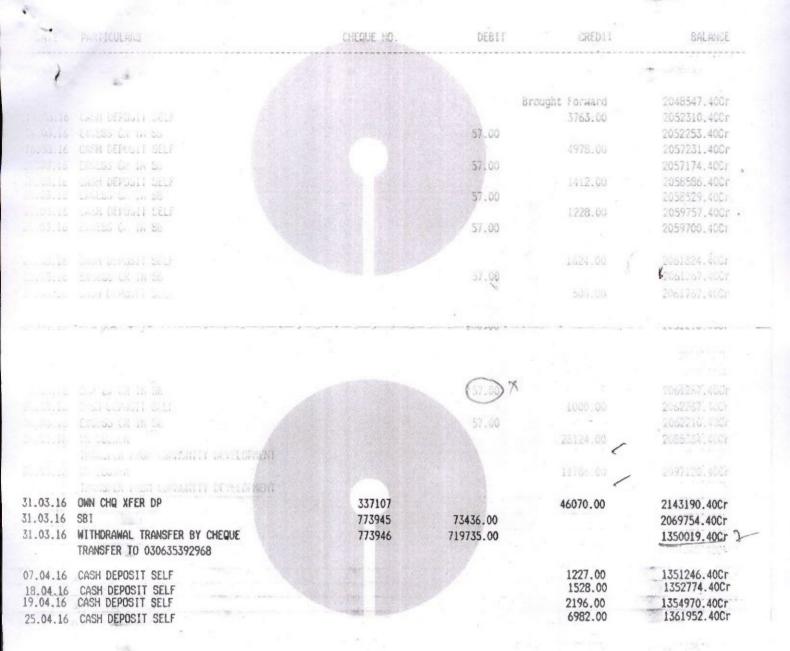
