Guidelines for submission of Online application for Food Safety License:

- 1. Please read carefully and follow Simple Steps on Deptt. website foodsafety.delhigovt.nic.in to submit online application in form "B" for Food Safety License in the link Food Licensing and Registration System (FLRS) available on website of FSSAI at fssai.gov.in.
- Submit copies of all required documents ONLY "ELECTRONICALLY" including form "B" and, wherever applicable, also the affidavit of proprietorship and affidavit of FSMS Plan. The FBO need not submit the physical copy of form "B" or any other document in the Deptt. of Food Safety.
- 3. As per FSSAI directions dated 19.07.2013:
 - (i) Column no. 4 of Form "B" is applicable for manufacturers only. As per section 3 (1)(zd)- "manufacturer" means a person engaged in the business of manufacturing any article of food for sale and includes any person who obtains such articles from an other person and packs and labels it for such purposes.
 - (ii) In case of manufacturer, person mentioned at column no. 4 and 5 of form "B" shall be same.
 - (iii) In column no. 5, Name of Nominee, if appointed shall be mentioned.
- 4. In case of registered company, instead of submitting whole Memorandum of Association and Article of Association (MOA) only the copy of Certificate of Registration/ Incorporation under Companies Act, relevant pages of kind of business undertaken by the company, Responsibilities liabilities of directors and list of Directors as available in the MOA shall be submitted electronically
- 5. Separate license is to be obtained for each sales outlet. In case the FBO is having godowns for storage and vehicles for transfer of food article from its godown to its sales outlet, the details of such godown/registration no. of vehicles shall be added in the address column of Form "B" after entering the address of sales outlet. However in case the said vehicle is being used for transportation of food article of other FBOs also, then he need a separate "Transporter" license.
- 6. If an FBO like sweet shop is having its workshop at a different premises other than its sales outlet and the said workshop is meant only to prepare food to be sold at single sales outlet, then application can be made for single license while mentioning the address of workshop after the address of its sales outlet in Form "B".

- 7. License for manufacturing and processing unit will be issued after inspection of the unit whereas for units other than manufacturing and processing unit, license will be issued without pre-inspection.
- 8. The Deptt. being regulator/facilitator, license for FBOs will be generated on the basis of documents uploaded by the FBO presuming that the FBO has complied with the provisions of FSS Act/Rules/Regulations and other Acts/Rules/Regulations etc. as applicable. However, the department reserves the right to inspect site and scrutinize documents as per policy of the department.
- Any information found incorrect/false at later stage may lead to suspension/cancelation of license and action as per provision of the FSS Act/Rules/Regulations.

ORDER

Sub: Generation of Online FSSAI License and Registration-reg.

At present, as per the practice followed, the printed copy of License/Registration Certificate granted is sent by the Licensing/Registration Authorities to Food Business Operators (FBOs) through post at their correspondence address except in case of Delhi, Jammu & Kashmir and Madhya Pradesh where State Licenses/Registration Certificates bearing scanned signatures of concerned Licensing/Registration Authorities are sent by email to FBOs.

- 2. The practice of sending License/Registration by post has certain disadvantages like postal delay in delivery, non-receipt of License/Registration certificate and it also leads to inconvenience and harassment of FBOs who have to visit the office of Licensing/Registering Authority in case of non-receipt of License/Registration Certificate.
- 3. FSSAI has been seized of the matter for sometime. It has been decided that in case of Central License, State License and Registration, after the Licensing/Registration Authority approves grant of License/Registration, a copy of License/Registration Certificate will be sent to email ID/FLRS Bin of FBO. The License/Registration Certificate will contain the following sentence at the end:

"This is a computer generated License/Registration Certificate and does not require signature of the License/Registration Authorities."

The FSSAI License/Registration Certificate shall also bear a Quick Response (QR) code as a security feature to verify the License/Registration Certificate. Based on the computer generated License/Registration Certificate, the FBO will be in position to start his food business immediately. This decision will come into force w.e.f. 01 May 2018.

4. The computer generated copy of License/Registration Certificate will be sent to (i) registered email-id of FBO, (ii) email-id of the person nominated for complying condition of License by the FBO and (iii) in FLRS Bin of FBO. An SMS Alert in this regard will also be sent to the concerned FBO for information at the time of generation of License/Registration Certificate.

5. This issues with the approval of Competent Authority in accordance with the powers vested in FSSAI under Section 16 (5) and Section 89 of Food Safety and Standards Act, 2006.

Please visit the website of Food Safety & Standards Authority of India at http://www.fssai.gov.in to file On-line application for Food Safety License. Click "Food Licensing and Registration System" (FLRS) and take the following simple steps to submit the application:

- Click the tool "Check your eligibility" on the web page of FLRS to know whether you are eligible for Central License or State License or Registration.
- If you are eligible for State License, check the list of documents to be uploaded from the website of FSSAI and store in electronic mode before proceeding to fill online application.
- 3. Sign up in "Self-Care-Portal" on top right of the web page and create your User ID and Password.
- 4. Sign in with your User ID and Password
- Click "Apply for License/Registration" in the link License/ Registration and select the state as Delhi and proceed after clicking the Kind of Business.
- 6. Click on the action "Click to apply" on right hand side of the page.
- 7. Click on Form "B" and fill up and take print out of each page by pressing "Ctrl+P" before taking the step "Save and Next".
- 8. Sign the hard copy of Form "B", scan and upload.
- 9. Scan other documents and upload.
- 10. SBI Challan will be generated.
- 11. Take out print.
- 12. Deposit challan with required license fee printed on the challan in any branch of State Bank of India.

Proceedings of the Second Meeting of the Steering Committee for supervision and monitoring of the implementation of the provisions of the Food Safety and Standards Act, 2006 held on 10.09.2018 at Nabanna.

The Chief Secretary and Chairperson of the Committee welcomed the members of the Committee and initiated the discussion. Agenda-wise discussion followed thereafter. List of participants is enclosed.

Agenda No. 1: Enforcement of the FSS Act, 2006: A report on Present Status

The Commissioner Food Safety presented a report on the present status of enforcement of the Food Safety and Standards Act, 2006 in the State.

The Additional Chief Secretary, Health and Family Welfare Department informed the Committee that the enforcement activities can be taken up more rigorously once the process of recruitment of FSOs is completed. It was noted that recommendations of WBHRB on recruitment of FSOs are tentatively expected to be available by October, 2018. He informed that some additional staff may be provided to Food Safety wing through reshuffling of Group-'C' & Group-'D' Staff.

He also advised to include more specific information like dates etc while presenting status reports.

Agenda No.2: Change the Nomenclature of the Existing State-Level Steering Committee to State Level Advisory Committee on Food Safety and Inclusion of Other Stake Holders

The Committee agreed to the proposal to change the nomenclature of the existing Committee to "State Level Advisory Committee on Food Safety to Assist, Aid or Advise on any Matter Concerning Food Safety" as stipulated under FSS (Licensing and Registration of Food Businesses) Regulations, 2011.

On the proposal for inclusion of other stakeholders, the Chief Secretary advised to include the representatives of Enforcement Branch in the committee. He further observed that need-based meetings and consultations may be held separately with other stake holders as and when required.

Agenda No.3: Creation of District Level Advisory Committee for Monitoring and Implementation of the Act at the District Level

The Chief Secretary observed that there are already quite a few district level committees dealing with similar issues, such as the Committees framed by the Department of Consumer Affairs, Department of Animal Resources etc. Hence the District Level Advisory Committee for monitoring and implementation of Act at district level, as required under the Regulation 2.1.15 of FSS (Licensing and Registration of Food Businesses) Regulations, 2011, may be formed taking into account the existence and mandates of the existing committees. He advised to move a proposal along these lines for consideration.

Agenda No.4: Use of Food Grade Blue Color in Industrial Ice to Stop its Misuse in Place of Edible-Ice Industrial ice being cheaper, it is rampantly used in place of edible ice in storing food or even in serving cold beverages causing serious health hazards. Additional Chief Secretary, Health and Family Welfare Department informed that the matter has been taken up with Industry, Commerce and Enterprises Department to stop the misuse of Industrial Ice in place of edible-ice. Chief Secretary approved the proposal and directed to take it up with the Department of Industry, Commerce and Enterprises for further necessary action.

Agenda No.5: Food Safety Awareness among School Children Through School Curriculum

Commissioner Food Safety informed that the Orange Books 1, 2 and 3 published by FSSAI for children of various age groups has been shared with the School Education Department. It was proposed that to inculcate food safety discipline at an early age these may be considered for inclusion in school syllabus. Chief Secretary advised that suitable extracts may be prepared which may be included in the school syllabus.

Agenda No.6: Food Fortification

The Ministry of Human Resource Development (MHRD) and the Ministry of Women and Child Development (WCD) have issued letters mandating the use of fortified oil, wheat flour and double fortified salt in MDM and ICDS respectively. Principal Secretary, Food and Supplies Department informed that food fortification initiatives are under process. The Chief Secretary advised Principal Secretary, Food and Supplies Department to call a meeting to chalk out a way forward in supplying fortified food in the state.

Additional Chief Secretary, Health and Family Welfare Department advised to organize registration melas in different districts as well.

There being no other issue, the meeting ended with a vote of thanks to the Chair.

Sub Fees for analysis of food articles by Central Combined Laboratory (CCL)

In view of the alleged adulteration of meat issue, different Municipalities including Kolkata Municipal Corporation have been sending samples to West Bengal Public Health Laboratory (WBPHL) for analysis. Requests were being received from Municipalities for waver of fees charged by WBPHL for analysis of samples. The matter was considered and it has been decided that the Central Combined Laboratory (including WBPHL) will conduct analysis of food articles received from Municipalities and Corporations free of charge till 30th of June, 2018 for public service. This is issued with the concurrence of Finance Department vide their U.O. No Gr. O/2018-19/0006 dated 12 06:2018.

Accordingly Municipalities may kindly be requested to send additional meat samples to WBPHL for analysis.
