Ministry of Housing and Urban Poverty Alleviation Govt. of India had allowed to engage NGOs as Resource Organisation to form New SHG at different ULBs. The Resource Organisations will facilitate the formation of SHGs and their development, bank-linkages, their federation at the area and city-levels, training and capacity building, and establishing links to ULBs. Later GoI has also allotted to engage Community Development Society (CDS) as resource Organization (RO)

Situation:-

On 6th august 2014, department of Municipal Affairs has been approved for the for the RFP/EoI in the file no- SUDA-77/2014 .the detail of the EoI has been in that file. The draft of EoI also be approved here. on the basis of the approval of the department EoI has been called and only Two NGOs and 2 CDS has applied. Now WBSULM has to call EoI for the empanelment of RO at the uncovered ULBs. and enaged in A

The situation has been elaborately discussed below:-

- 1. As per approval of Govt of India WBSULM has been engaged CDSs as RO in different ULBs. Ist phased 58 ULBs has been covered by engaging Resource Organizations. Mr present WBSULM has been engaged 88 CDS among 38 ULBs and 4 NGOs in 20 ULBs as RO.
- 2. On the basis of the new order from GOI all ULBs has been under one Umbrella of DAY-NULM. Now the poverty alleviation programme -National Urban Livelihood Mission (NULM) has been spread throughout the State in all 125 ULBs. This 67 new ULB has to be cover by RO.
- 3. WBSULM has been covered 33 ULBs by engaging RO. Among 28 ULBs has been covered by 39 CDS and 5 ULBs has been covered by 2 NGOs. So the Situation is 35 ULB remain Uncover.
- 4. In this situation- out of 67 ULBs only 33 covered, 34 left out among 67 ULB. So this 34 ULB still uncovered by Resource Organization. and we think this is a very much big number by covering with the engagement of RO.
