A 50 bedded shelter unit under the scheme Shelter for Urban Homeless (SUH) was sanctioned by Project Sanction Committee (PSC) on 16.12.2015 with an amount of Rs. 121.43 Lakh in favour of Chandernagar Municipal Corporation. As per report from ULB, the date of commencement of work is 15.11.2016 and as per DPR work should be completed within one year from the date of commencement. Several times intimation has been done from this end for completion of the work. Till now the construction work is going on.

In this regard the under signed visited the site of Shelter for Urban Homeless under Chandernagar Municipal Corporation on 24.05.2018 During the visit it appears that, the progress of the work is 70 % and brick work is going on. The under signed also attend the meeting at the chamber of Commissioner Chandernagar Municipal Corporation regarding the slow progress of the work. Executive Engineer, MED, contractor engaged for the work, concerned Municipal Engineer, CIC NULM and City Mission Manager NULM were present in this meeting. A discussion has been made regarding the slow progress of the works and the tentative date of completion of the work. After discussion in the meeting it was decided that to follow up the regular progress of the work, meeting will be conducted on monthly basis. A tentative date (i.e. August, 2018) of completion of the work was fixed by the Commissioner in consultation with Executive Engineer, MED. Regarding the payment of bills and submission of Utilization Certificate a discussion was made. It was decided in the meeting that, after clearing of bills Corporation will submit the Utilization Certificate to this end at the earliest. In this meeting Commissioner, CMC suggested to City Mission Management unit to prepare for shelter functionalization work (i.e. Shelter Management Committee formation, Selection of NGO and other relevant work of SUH).

A 50 bedded shelter unit under the scheme Shelter for Urban Homeless (SUH) under DAY-NULM with an approved project cost of **Rs. 121.43 Lakh** (excluding DPR preparation cost) was approved by Project Sanction Committee (PSC) in its 5 th meeting in favour of Chandernagar Corporation.

As per DAY-NULM guidelines the funding pattern of Central & State shares is 60:40. The Central share is Rs. 72.85 Lakh & State share is Rs. 48.58 Lakh. So far to the tune of Rs. 48.30 Lakh (1 st instalment) was released in favour of the Chandernagar Corporation on 15.02.2016.
