Recently the undersigned has visited two 50 bedded shelter unit at Krishnanagar Municipality along with the audit team from Govt. of India 20.03.2018. During their visit it has been observed that the shelter unit (50 bedded) is functional with 25 bedded capacity although the number of inmates is 39. It may be highlighted that Project Sanctioning Committee had sanctioned this shelter unit with 50 bedded capacity and the allotment released from our end was in full for construction and procurement of different items for the inmates which include the 50 beds, The same has been brought before the Chairperson of Krsihnanagr Muncipality during the visit. As per report available at this office that there is no such arrangement has been made for further beds till now.

In this context now we may communicate to the Chairperson of Krishnanagar Municipality that 50 bedded shelter unit is a mandate under SUH Component as per guidelines and it is necessary to comply with the Guidelines.

The above matter is submitted for your kind consideration and further process.
