Sir,

You may be aware that a Road Map of SUH by 2021 was submitted to the Hon'ble Supreme Court of India for setting up shelter units to cover the homeless population within KMC area. Initially 29 locations were identified by the KMC under the jurisdiction of different Departments/Organizations.

In this regard number of letters have been issued to the line departments and several meetings have been conducted with different Departments. Some Departments/Organizations did provide the land or NOC for setting up shelters and few Departments/Organization agreed to transfer the land or to provide NOC

It may be further be noted that as per communiqué no. **M-13/23/2017/UPA-I SECTION - MHUPA(EFS9026963) dated:15.11.2017** of MoHUA as per direction of Hon'ble Supreme Court of India in the matter of **W.P.(C) of 55 of 2003** a Third Party Survey was conducted in 2018 (March-April) by Kolkata Municipal Corporation (copy enclosed herewith for ready reference). As per this survey, **7272** homeless population was identified in KMC area.

Form the aforementioned survey report it reveals that homeless population concentration in Ward nos. **2,4,5,6,7,9,12,15,20,13,14,29,21,22,24,38,36,59,86 & 75** is high and in these wards one or more than one 50/100 bedded shelter is required to set up to cover the homeless population

As per records available with the office, the following SUH are either completed or in process.

It may be further be noted that as per communiqué no. **M-13/23/2017/UPA-I SECTION – MHUPA(EFS9026963) dated:15.11.2017** of MoHUA as per direction of Hon'ble Supreme Court of India in the matter of **W.P.(C) of 55 of 2003** a Third Party Survey was conducted in 2018 (March-April) by Kolkata Municipal Corporation (copy enclosed herewith for ready reference). As per this survey, **7272** homeless population was identified in KMC area.

Form the aforementioned survey report it reveals that homeless population concentration in Ward nos. **2,4,5,6,7,9,12,15,20,13,14,29,21,22,24,38,36,59,86 & 75** is high and in these wards one or more than one 50/100 bedded shelter is required to set up to cover the homeless population
