

Minutes of Meeting on Management of Food Court at Kolkata SARAS held on 13.11.2013 at 01.00 p.m. at DRD Cell, Howrah Zilla Parishad

Record of Attendance of members present in the meeting is enclosed herewith in a Separate Sheet

Sri Arindam Niyogi, WBCS (Exe), Project Director, DRD Cell, Howrah Zilla Parishad presided over the meeting and told that Kolkata SARAS would be organised at Central Park, Salt Lake during 12th to 25th December 2013.

Then he initiated the discussion regarding the finalisation of rates of different food items. Representatives from concerned districts placed the list of the items with rate chart to Project Director, DRD Cell, Howrah Zilla Parishad. The following decision has been taken in the meeting –

- 1. Each and every item will be sold in a fixed rate from each stall which will be clearly displayed in stall wise Flex.
- 2. Shiliguri Mahakuma Parishad will be requested to use the terms 'Chicken Momo' and 'Chicken Chowmin' instead of 'Non Veg. Momo' and 'Non Veg. Chowmin' and also to modify rate of Chowmin as per enclosure.
- Rates of full plate of each item will be mentioned in rate chart and rates of half plate will not be mentioned in the chart.
- 4. Rates of 'Pakora', 'Devil', 'Chop', like items will be reflected on the basis of per plate and not on the basis of per piece.
- 5. Two pieces of 'Egg Devil' will be served in each plate with Mustard Kasundi and Salad.
- District wise list of Cooked Food items and rates against each item has been fixed in the meeting (enclosed).
- 7. Item wise rate chart will be sent to SUDA such that they also may maintain it.

Stall Allocation -

Miscellaneous -

For better management of Food Court -

- Each District related to Food Court will prepare their flex matter and send it to Project Director, DRD Cell, Howrah Zilla Parishad within 21st November 2013.
- District wise Flex displaying food items available, with rate of each item for maintaining transparency and it will be arranged by Howrah, except that of SUDA.
- Uniform (Apron / Chef's Cap/ Mouth Guard / Gloves etc) will be worn by the participant group members which would be provided by a Sangha of Howrah District as in previous occasion.
- Dustbin with disposable Poly-bags will be provided by North 24 Pgs. from the first day. Separate Sweeper will be provided for it.
- Separate contingent Menial should also be provided regularly and exclusively for the Food Park by North 24 Pgs. to clear the waste cups / plates frequently from the 1st Day.
- 6. Sufficient provision of light will be made for food courts.
- At least 3 number of electric line will be provided to each stall of food court. (2 nos. of 15 amp. and 1 no. of 5 amp.)
- 8. This time no bag will be provided.

- 9. Each District may arrange for Refrigerators, Micro Oven etc. for their participants by their own arrangements.
- Electric Lines for Refrigerator will remain active (on) for round the clock (Specially at night)
- 11. Special care should be taken by the participating Districts about the compulsory use of eco friendly paper napkins, paper cup / plat, spoon, Foil Container (for packing) etc. Poly bags should be at least of 40 micron.
- 12. Gap between the stalls and kitchen will be narrower than it was in the previous year.
- 13. Sufficient and Suitable places will be provided for the SHG members of all stalls in the kitchen.
- 14. Space between stalls and kitchen will be covered by a shed of tarpaulin or otherwise.
- 15. DPD(Credit) of North 24 Pgs. has been requested to maintain the above 3 points (11 to 13). In addition to it he has also been requested to clear and level the land between the stall and the kitchen.
- 16. North 24 Pgs. has requested to keep the supply of water sufficient since inception.

As there was no other point to discuss, the meeting ended with vote of thanks to and from the chair.






