As you are aware that the Ministry of Housing & Urban Affairs is implementing DAY-NULM since September, 2013. Now, the Ministry has decided to introduce healthy competition among the States/UTs and ULBs through a ranking system namely SPARK which stands for Systematic, Progressive, Analytical & Real-time Ranking.

2. Under SPARK, the parameters have been categorized into input, output and outcome type for every component of the scheme. The idea is that in the present year higher weightages will be assigned to the input parameters which will gradually move towards outcome and output parameters in the coming years depending on the stage of implementation of the scheme. SPARK provides real time ranking by capturing data from the NULM MIS entered by the ULBs. A concept note regarding the SPARK ranking system is enclosed and it can also be accessed from www.nulm.gov.in.

3. It is needless to say that ULBs should enter data regularly and if possible daily so that their actual achievement gets reflected in the ranking. Therefore, I request you to instruct SULMs and ULBs to take necessary steps for making the MIS database up-to-date.

4. The Ministry further plans to take this ranking to the level of Urban Local Bodies so that the interse ranking of the cities within the State as well as across the country can also be viewed and necessary steps can be taken to handhold cities which are not doing so well. To make it possible, the States need to disaggregate the targets given for the State to the level of ULBs and communicate it to them. The Ministry has already communicated the State/UT-wise targets under various components vide letter dated 2nd June, 2017.

5. I wish your State good luck for performance in the SPARK ranking system. I also take this opportunity to request you to issue necessary instructions to the SULM/ULBs in this regard.

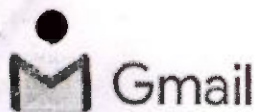

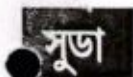

And whereas, the Scheme is implemented through various grassroots level institutions under the Department of Urban Development or the Municipal Administration or any other concerned Department responsible for the implementation of the Scheme under the State Governments and Union territory Administrations;

And whereas, the aforesaid Scheme involves expenditure incurred from the Consolidated Fund of India;

Now, therefore, in pursuance of the provisions of section 7 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (hereinafter referred to as the said Act), the Central Government hereby notifies the following, namely:—

1. (1) Any individual desirous of availing the benefits under the Scheme is required to furnish proof of possession of Aadhaar or undergo Aadhaar authentication.
- (2) An individual desirous of availing the benefits under the Scheme, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, but desirous of availing the benefits under the Scheme is hereby required to make application for Aadhaar enrolment by 30th June 2017, provided he or she is entitled to obtain Aadhaar as per section 3 of the said Act and such individuals may visit any Aadhaar enrolment centre (list available at Unique Identification Authority of India (UIDAI) www.uidai.gov.in) to get enrolled for Aadhaar.
- (3) As per regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the concerned Department responsible for implementation of the Scheme in the State Government or Union territory Administration which requires an individual to furnish Aadhaar, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar, and in case there is no Aadhaar enrolment centre located in the vicinity such as in the Block or Taluka or Tehsil, the concerned Department responsible for implementation of the Scheme under the State Government or Union territory Administration is required to provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or the Department or authority itself becoming UIDAI Registrar:

Provided that till Aadhaar is assigned to the individual, benefits under the Schemes shall be given to such individual, subject to the production of the following documents, namely:—

- (a) (i) if he or she has enrolled, his or her Aadhaar Enrolment ID slip; or
- (ii) a copy of his or her request made for Aadhaar enrolment, as specified in sub-paragraph (b) of paragraph 2; and
- (b) (i) Bank passbook containing photograph; or (ii) Voter identity card; or (iii) Ration Card; or (iv) Permanent Account Number (PAN) Card; or (v) Driving license issued by the Licensing Authority under the Motor Vehicles Act, 1988 (59 of 1988); or (vi) Passport; or (vii) Kisan Photo Passbook; or (viii) Certificate of identity having photo of such person issued by a Gazetted Officer on official letter head; or (ix) any other documents as specified by the State Government or Union territory Administration;

Provided further that the above documents shall be checked by an officer specifically designated by the State Government or Union territory Administration for that purpose.

2. In order to provide convenient and hassle free benefits to the beneficiaries under the Scheme, the concerned Department responsible for implementation of the Scheme under the State Government or Union territory Administration shall make all the required arrangements including the following, namely:—

- (a) Wide publicity through media and individual notices to be given to the beneficiaries to make them aware of the requirement of Aadhaar to receive benefits under the Scheme and they may be advised to get themselves enrolled at the nearest enrolment centre available in their areas by 30th June 2017, in case they are not yet enrolled. The list of locally available enrolment centres (list available at www.uidai.gov.in) shall be made available to them.
- (b) In case, the beneficiaries are not able to enroll due to non-availability of enrollment centres in the near vicinity such as in the Block or Taluka or Tehsil, the concerned Department responsible for implementation of the Scheme under the State Government or Union territory Administration is required to create Aadhaar enrolment facilities at convenient locations, and the beneficiaries may be requested to register their requests for Aadhaar enrolment by giving their names, addresses, mobile numbers and other details, with the concerned officially designated by the State Government or Union territory Administration or through the web portal provide for the purpose.

3. This Notification shall come into effect from the date of its publication in the Official Gazette in all States except the States of Assam, Meghalaya and Jammu and Kashmir.



Mission, Principles, Values, Strategy

NULM Mission

2.1 To reduce poverty and vulnerability of the urban poor households by enabling them to access gainful self-employment and skilled wage employment opportunities, resulting in an appreciable improvement in their livelihoods on a sustainable basis, through building strong grassroots level institutions of the poor. The mission would aim at providing shelter equipped with essential services to the urban homeless in a phased manner. In addition, the Mission would also address livelihood concerns of the urban street vendors by facilitating access to suitable spaces, institutional credit, social security and skills to the urban street vendors for accessing emerging market opportunities.

Guiding Principles

2.2 The core belief of National Urban Livelihoods Mission (NULM) is that the poor are entrepreneurial and have innate desire to come out of poverty. The challenge is to unleash their capabilities to generate meaningful and sustainable livelihoods. The first step in this process is motivating the urban poor to form their own institutions. They and their institutions need to be provided sufficient capacity so that they can manage the external environment, access finance, expand their skills, enterprises and assets. This requires continuous and carefully designed handholding support. An external, dedicated and sensitive support structure, from the national level to the city and community levels, is required to induce social mobilisation, institution building and livelihood promotion.

2.3 NULM believes that any livelihood promotion programme can be scaled up in a time-bound manner only if driven by the poor and their institutions. Such strong institutional platforms support the poor in building up their own human, social, financial, and other assets. This in turn, enables them access to rights, entitlements, opportunities and services from the public and private sectors, while enhancing their solidarity, voice and bargaining power.

2.4 As per the Constitution (74th Amendment) Act, 1992, urban poverty alleviation is a legitimate function of the Urban Local Bodies (ULB). Therefore, ULBs would need to undertake a lead role for all issues and programmes concerning the urban poor in cities/towns, including skills and livelihoods.

2.5 NULM would aim at universal coverage of the urban poor for skill development and credit facilities. It will strive for skills training of the urban poor for market-based jobs and self-employment, facilitating easy access to credit.

2.6 Street vendors constitute an important segment of the urban population at the bottom of the pyramid. Street vending provides a source of self-employment, and thus acts as a measure of



urban poverty alleviation without major Government intervention. They have a prominent place in the urban supply chain and are an integral part of the economic growth process within urban areas. NULM would aim at facilitating access to suitable spaces, institutional credit, social security and skills to the urban street vendors for accessing emerging market opportunities.

2.7 Urban homeless persons who live without shelter or social security/ protection are the most vulnerable class, even while they contribute towards sustaining cities with their cheap labour. Life on the streets involves surviving continuously at the edge, in a physically brutalized and challenging environment. There is a need for appropriate policy intervention to address the challenges faced by homeless people, with regard to shelter, social housing and social protection. Accordingly, NULM would aim at providing shelter equipped with essential services to the urban homeless in a phased manner.

2.8 NULM would place a very high emphasis on convergence with schemes/programmes of the relevant line Ministries/Departments and programmes of state governments dealing with skills, livelihoods, entrepreneurship development, health, education, social assistance, etc. An alliance strategy will be sought with all concerned departments to promote skills training of rural-urban migrants as a bridge between the livelihoods of the rural and urban poor.

2.9 NULM would aim at partnership with the private sector in providing skill training, employment and operation of shelter for homeless. It will strive for active participation of private and civil society sectors in providing shelter to the urban homeless, skill training and placement of the urban poor and also in facilitating technological, marketing and handholding support for the urban poor entrepreneurs who want to be self-employed and set up their own small businesses or manufacturing units.

Values

2.10 The mission will espouse the following values:

- i Ownership and productive involvement of the urban poor and their institutions in all processes;
- ii Transparency in programme design and implementation, including institution - building and capacity strengthening;
- iii Accountability of government functionaries and the community;
- iv Partnerships with industry and other stakeholders; and

v Community self-reliance, self-dependence, self-help and mutual-help

Strategy

2.11 NULM will adopt the following strategy:

- i Building capacity of the urban poor, their institutions and the machinery involved in the implementation of livelihoods development and poverty alleviation programmes through handholding support;
- ii Enhancing and expanding existing livelihoods options of the urban poor;
- iii Building skills to enable access to growing market-based job opportunities offered by emerging urban economies;
- iv Training for and support to the establishment of micro-enterprises by the urban poor – self and group;
- v Ensure availability and access for the urban homeless population to permanent 24-hour shelters including the basic infrastructural facilities like water supply, sanitation, safety and security;
- vi Cater to the needs of especially vulnerable segments of the urban homeless like the dependent children, aged, disabled, mentally ill, and recovering patients etc., by creating special sections within homeless shelters and provisioning special service linkages for them;
- vii To establish strong rights-based linkages with other programmes which cover the right of the urban homeless to food, healthcare, education, etc. and ensure access for homeless populations to various entitlements, including to social security pensions, PDS, ICDS, feeding programmes, drinking water, sanitation, identity, financial inclusion, school admission etc., and to affordable housing;
- viii To address livelihood concerns of the urban street vendors by facilitating access to suitable spaces, institutional credit, social security and skills to the urban street vendors for accessing emerging market opportunities.



GUIDELINES/STANDING INSTRUCTIONS/SYNOPSIS AS PER C.I.C.

1. **PROVIDE INFORMATION TO OFFICE BEARERS / (ASSOCIATION / ORGANIZATION / NGO) / REF.No.139/ICPB/2006 dt.25.10.2005:**

Information should not be denied quoting section 3 since office bearer of Corporation, Association, Company, NGO etc. who is also a citizen of India, information shall be supplied to him/her, provided the applicant gives his/her full name. In such cases, it will be presumed that a citizen has sought information at the address of the Corporation etc. Hence it has been decided that even if information is sought by an office bearer of an Association/Union, the same should be treated as valid in terms of provisions of the RTI Act vide letter No.139/ICPB/2006 dt.25.10.2005.

2. **TRANSFER OF INTIMATION WITHIN THE TIME BOUND. REF: SEC. 6(3) OF THE RTI ACT, 2005:**

As per section 6 (3) of the RTI Act 2005, in case the information sought does not come under the purview of the public authority the same should be transferred to the appropriate public authority and to be intimated to the applicant immediately about such transfers. Provided that the transfer of an application pursuant to this sub-section shall be made as soon as practicable but in no case later than five days from the date of receipt of the application.

3. **REFUSAL OF REQUEST & NOT RESPONDING IS LIABLE TO ATTRACT PUNISHMENT: REF: SEC. 7(2) & 20(1) OF RTI ACT, 2005:** As per section 7 (2) of the Act, if the PIO fails to give decision of the request for information within the specified period of thirty days under sub-section (1), shall be deemed to have refused the request.

4. **VERNACULAR AS PER PETITIONER'S REQUEST: REF: 4(4) OF RTI ACT, 2005:**

It requires giving information to the citizens in the language they know as per the provisions of section 4 (4), accordingly English Version is preferred.

5. **DENIAL OF INFORMATION ON GROUNDS OF LACK OF MAN POWER IS NOT PERMISSIBLE: REF: SEC.5 OF RTI ACT, 2005:**

As per section 5 every public authority shall, within one hundred days of the enactment of this Act, designate as many officers as the Central Public Information Officers or State Public Information Officers as the case may be, in all administrative units or offices under it as may be necessary to provide information to persons requesting for the information under this Act.

6. **DENIAL OF INFORMATION MERELY QUOTING THE BARE CLAUSE OF THE ACT IS NOT PERMISSIBLE: REF: SEC.7(8) (1): of the Act [section 7 (8) (i):**

Merely quoting the bare clause of the Act [section 7 (8) (i)] does not imply that the reasons have been given. PIO should indicate clearly the grounds of seeking exemptions from disclosure of information while rejecting a request vide letter 27/IC(A)/06, dated 10.04.2006.

7. **PENALTY & DEPARTMENTAL ACTION FOR MALAFIDE DENIAL AND DELAY IN REPLY: REF: SEC.20(1) OF RTI ACT, 2005:**

Malafide denial of information sought is liable to attract penalty of Rs.250/- from the date of application till the date of information provided and disciplinary action by the department as per section 20 (1).

8. **INFORMATION SOUGHT ON NUMBER OF POINTS IS STATUTORY, MANDATORY AND LEGITIMATE: REF: (AMAR SINGH DAHIYA VS. FOOD CORPORATION OF INDIA DT.04.02.2008, CIC DIGEST (VOL.II) PG.2732::**

- a) Information sought by the applicant in one application under the RTI Act has to be provided, if application fee of Rs.10/- has been paid, irrespective of the number of points, on which information have been sought by the information seeker (*Amar Singh Dahiya vs Food Corporation of India dt.04.02.2008, CIC Digest (Vol.II) pg. 2732*).

b) **DECISION:**

The respondent has wrongly asked the appellant to pay Rs.10/- as fee for each of the items for which information was sought by the appellant. There is no proviso in the rules for such a demand.

9. **INFORMATION TO BE PROVIDED IF RELATES TO 100 YEARS: REF: (SUKUMAR DE VS. HINDUSTAN STEEL WORKS CONSTRUCTION LTD. DT.12.02.2008. CIC DIGEST (VOL.II, PG.2048) & O.P.SINGHAL VS. DEPUTY COMMISSIONER, CIVIL LINES, MUNICIPAL CORPORATION OF DELHI, DT.17.09.2007, CIC DIGEST VOL.II, PG.1807:**

a) The denial of information merely on the ground that the action relates to more than 20 years is not acceptable (Sukumar De vs Hindustan Steelworks Construction Ltd. dt.12.02.2008, CIC Digest Vol.II page 2048).

b) Appellant has stated that after 20 years such information cannot be denied (*A.Vatsraj Vs. State Bank of India dt.19.06.2007, CIC Digest Vol.II page 1568*).

c) If the information is more than 20 years old, it is not excluded, but mandated to be provided (*O.P.Singhal Vs. Deputy Commissioner, Civil Lines, Municipal Corporation of Delhi dt.17.09.2007, CIC Digest Vol.II page 1807*).

d) Although the information asked for ranges over 100 years and relates to railway bridges throughout the country, the Commission directs to furnish the information in part as to whatever is presently available, since the issue is an important one relating to safety, the Commission feels that it should be compiled and provided to the Complainant keeping technologies in mind (*Salim Baig Vs. Railway Board dt.20.12.2007, CIC Digest Vol.II page 1952*).

10. **INFORMATION TO BE PROVIDED FREE OF COST IF IT EXCEEDS THE TIME LIMIT: REF: SEC.7(6) OF RTI ACT, 2005:**

Section 7 (6) "Notwithstanding anything contained in section 7(5), the person making request for the information shall be provided the information free of charge where a public authority fails to comply with the time limits specified in subsection (1) of section 7".

11. **INFORMATION TO BE PROVIDED WITHIN 48 HOURS: REF:SEC.7(6) OF RTI ACT, 2005:**

As per section 7(1) of the Act, where information sought for concerns the life and liberty of a person, the same shall be provided within forty-eight hours of the receipt of the request.

12. **VOLUMINOUS INFORMATION TO BE PROVIDED IN THE FORM OF C.D.; REF:S REF: SEC.4(a) OF RTI ACT, 2005:**

Where the information sought is voluminous, it is to be provided in the form of C.D.. Also to state that as per section 4(a) of the Act it is mandatory to "maintain all its records duly catalogued and indexed in a manner and the form which facilitates the right to information under this Act and ensure that all records that are appropriate to be computerized and connected through a network all over the Country on different systems so that access to such records is facilitated".

13. **INFORMATION SHALL BE PROVIDED IN THE SOUGHT FORM: REF:SEC.7(9) OF RTI ACT, 2005:**

As per section 7(9) of the Act, "An information shall ordinarily be provided in the form which it is sought, unless it would disproportionately divert the resources of the Public Authority or would be detrimental to the safety or preservation of the record in question". Hence it is mandatory of the public authority to provide the information sought in any available form and merely quoting this section and denial of information on grounds that it is not available in the sought form is not sustainable.

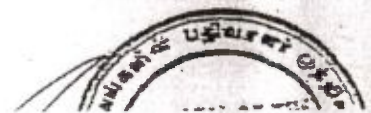



You may kindly be aware that the National level Mission mode programme was launched on 1st April, 2014 in the name of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) to alleviate Poverty and vulnerability in urban in areas. The six major components of the programme were designed to eliminate all types of vulnerabilities. The Components are;

1. Employment through Skill Training and placement – ESTP
2. Self Employment Programme – SEP
3. Social Mobilization and Institutional Development-SMID
4. Shelter for Urban Homeless – SUH
5. Support to urban Street vendor – SUSV
6. Capacity Building and Training Programmes – CBT.

For implementation of DAY-NULM programme, three Mission management Units namely City mission Management Unit (CMMU) at ULB level, State Mission management Unit (SMMU) at State Level and National Mission Management Unit (NMMU) at national Level has set up and dedicated manpower has been deployed at ULB level. As it is proved that the SHG is a vehicle for the eliminating poverty and protecting from the vulnerabilities for the poor household particularly the poor women. Hence the DAY-NULM programme has introduced the SHG concept for the poor Women of the urban household. In this programme, there is two tier of federation SHGs Namely Area Level Federation (ALF) and City Level Federation (CLF). The SHGs will get the revolving fund as a grant of Rs. 10000/- after 3 months from inception. The ALF is a register body under Society registration Act, 1961 and the federation will get a grant as revolving fund of Rs.50000/- from the said programme. In this programme, there is a provision for City Livelihood Centre at the ULB level for providing services and information like security, carpentry, gardening, construction, plumbing, electrical work, health care support, housekeeping etc to the resident of the ULBs. hand, the poor people may get the information about market of their produce marketable goods, government schemes and benefit, Skill training opportunities, social security etc form the centre.

Self Employment Programme (SEP) is an important Component for development of Micro Entrepreneurs at ULB level. The component has three subcomponents (1) Self Employment programme for Individual (SEP-I) (Loan amount upto Rs. 2 Lakhs) (2) Self Employment Programme for Group (SEP-G) (loan Amount upto Rs. 10 Lakhs) (3) SHG Credit Linkage (1st dose loan amount minimum Rs. 1.25 Lakhs)

For SEP-I and SEP-G, the beneficiaries have to pay 7% rate of interest for their loan rest (Actual interest charge by bank minus 7%) will be given as interest subsidy to the loan account of the beneficiaries. For SHG Credit linkage the interest subsidy will be the difference between the prevailing rate of interest charged by the bank and 7% per annum, on all loans to SHGs of urban poor. An additional 3 percent interest subvention will be provided to all Women SHGs (WSHGs) who repay their loan in time. The Interest subsidy will be subject to timely repayment of the loan (as per the loan Repayment schedule) and suitable certification obtained from banks by the ULB.

Shelter for Urban homeless is a burning issue and monitoring by the Hon'ble Suprim Court. The said programme is providing the financial support to the ULBs for development of Shelter for the urban homeless.

The programme is focused on the universal financial inclusion for all categories of people of urban areas. The main objective of Support to urban street vendors is to issue of Identity Cards through survey of street vendors, Development of city street vending plans, Infrastructure development of vending zones in the city, Training and Skill Development, Financial Inclusion, Access to credit, Linkages to social security schemes.

Since Last one year the said programme is being implemented in 125 ULBs of our state with dedicated manpower and infrastructure. As the programme is growing and the number of beneficiaries are increases, so we may face different types of problems in different situation which may hinder the progress of the programme. In this view, we are requesting your kind intervention

on the said programme so that the poor women of urban area of your district get their entitlements from the programme. You are also requested to entrust any officer under your control who may look into the entire programme for your district and intervene proper implementation to achieve the goal of the programme. District Municipal development officer or any officer looking after the work of the District Urban development Agency (DUDA) may look after the monitoring and implementation of the programme. I am enclosed herewith the present status and Component wise target for the Financial year 2017-18 of different ULBs of your district.

I am directed to refer to this Ministry's letters of even number dated 18.3.2016 and 23.6.2016, (copies enclosed) on the subject mentioned above vide which all States/UTs were requested to take the following courses of action on priority basis:-

- i) Creation of an internal DBT Cell in State/UT (latest by 30.6.2016);
- ii) Adoption of DBT measures for DAY-NULM for last leg transfer of funds through electronic means by state implementing agencies to an Institution/Organization or a beneficiary by following the procedures prescribed in the Concept Note circulated vide this Ministry's O.M. dated 18.3.2016. Scope of DBT may be enhanced by including the transfers made in the form of salary, honorarium, incentives, etc. paid to the various enablers of DAY-NULM like Community Organizers and other contractual staff engaged by SMMUs and CMMUs (latest by 15.7.2016);
- iii) Seeding of beneficiaries list with Aadhaar or any other bio-metric identification (latest by 15.12.2016)
- iv) Developing an IT application to capture real time information about the DBT status of various schemes and uploading of details of beneficiaries on MIS portal by the implementing agencies which can be accessed by the Ministry, State/UT Governments and other stake holders (latest by 15.12.2016);

2. It is requested that the progress achieved by your State/UT in digitizing the beneficiary database and Aadhaar seeding of the digitized beneficiary database, may be intimated to the Ministry. If the process has not been completed so far, the specific time-frame by which Aadhaar seeding of the digitized beneficiary database, may kindly be indicated.

3. It may kindly be ensured that all payments to implementing agencies/institutions, training providers and end beneficiaries may be made through electronic means only and cheque/cash payments may be discarded. Further, all



bank accounts of beneficiaries need to be Aadhaar linked to ensure Aadhaar based DBT disbursal. A revised Concept Note on adoption of DBT initiatives, has also been prepared by incorporating the measures to be adopted under the components like 'Innovative & Special Projects' and 'Support to Urban Street Vendors'. A copy of the same is enclosed.

4. All States/UTs are requested to send an Action Taken Report on adoption of DBT measures for DAY-NULM like digitization of beneficiary database, Aadhar seeding of beneficiary data base, Aadhaar linking of bank accounts and transfer of funds through electronic means, to the Ministry at the earliest.

CONCEPT NOTE ON ADOPTION OF DBT INITIATIVES UNDER NULM

Guidelines for Direct Benefit Transfer

To meet the socio-developmental objectives of poverty elimination and inclusive growth, a number of Government programmes and schemes have been introduced. However, optimal efficient and effectiveness have not been achieved due to leakages, etc. Direct Benefit Transfer (DBT) Scheme aims to reduce leakages, cut down corruption, eliminate middlemen, target beneficiaries better, speed up transfer of benefits to eligible beneficiaries.

To streamline implementation of DBT, the Ministry of Finance has issued guidelines from time to time. Ministry of Finance has directed vide their Office Memorandum No.I-11011/58/2013-DBT dated 27.8.2015, that DBT Mission prescribed framework is to be implemented by all Ministries/Departments for all Central Sector Schemes and Centrally Sponsored Schemes where component of transfer of cash benefits to beneficiaries is involved. Ministry of Finance further directed that in cases where sanction is made through State Government under Centrally Sponsored Scheme, with or without matching grant by State, the DBT initiative is to transfer funds electronically through Public Financial Management System (PFMS) platform to the respective state Government and ensure that state Government releases funds directly to the beneficiaries electronically.

In accordance with the directions of the Ministry of Finance contained in their Office Memorandum No.I-11011/58/2013-DBT dated 13.2.2015 and 19.2.2015, for Centrally Sponsored Schemes where funds are transferred to State Governments, each Ministry/Department will work with the respective State Governments to ensure that the cash component of each scheme is transferred electronically to each beneficiary(individual or institution). In case funds are being transferred to any institution that institution shall transfer cash component of those funds to each beneficiary electronically.

Present system of fund flow in NULM

- i. The funds are devolved/transferred by the Ministry to the Government of State/UT.
- ii. Funds are further released by the State Government to the State Urban Livelihoods Mission Unit (SULM) which is deposited in their bank accounts.
- iii. The SULM transfers money to the Urban Local Body (ULB) which is deposited in bank accounts of ULBs.

- iv. ULBs releases the funds to training providers, banks, individuals or institutions as the case may be through cheque/cash or direct transfer to bank accounts.

Proposed system of fund flow in NULM

- i) All steps of the present system of fund flow will remain the same except that funds which are to be transferred directly to beneficiaries(individuals or institutions), will be released by ULBs directly to the accounts of beneficiaries (individuals or institutions) through the PFMS system of CGA or NEFT/RTGS or Aadhar based system of NPCI.

The sub components under NULM where DBT is possible and the procedure for implementing the DBT, are as follows:

I. Self-Employment Programme (SEP)

- i) Under the SEP component, interest subsidy over and above 7% rate of interest is available on a bank loan for setting up of individual or group enterprises. At present, the difference between 7% per annum and the prevailing rate of interest, is being provided to banks under the SEP component.
- ii) Under the DBT initiatives, the interest subsidy can be credited to the bank account of the beneficiary(individual or group). For this purpose, ULBs will maintain a list of all beneficiaries/groups and their accounts which have been verified. Banks will calculate the amount of interest subsidy and additional interest subvention and intimate the details to ULBs. Thereafter, the ULBs will make an invoice of accounts against which the cash benefits will be transferred directly to the accounts of beneficiaries/groups.
- iii) An additional 3 percent interest subvention is provided to all Women SHGs (WSHGs) who repay their loan in time. The interest subvention can be directly credited to the bank account of WSHGs after obtaining a certification from the bank regarding timely repayment of the loan by the WSHGs.
- iv) The transfers made through DBT may also be updated in the NULM MIS portal.

II. Employment Through Skills Training And Placement (EST&P)

- As per the Common Norms which are applicable to the Employment

Through Skill Training and Placement(EST&P) component of NULM, the Transport costs, boarding and lodging expenses, post placement support, etc. are admissible to certain candidates as prescribed in the guidelines.

- Under the DBT initiatives, the Training Providers will maintain a list of all beneficiaries/groups and their accounts which have been verified.
- If the training provides for reimbursement of transport costs, boarding and lodging expenses, etc. which are to be given to the beneficiaries along with their account details, will be sent by the Training Providers to ULBs.
- After due verification, the ULBs will make an invoice of accounts against which the cash benefits will be transferred directly to the accounts of beneficiaries, preferably through PFMS System of CGA. However, the ULBs may also use the NEFT/RTGS or the Aadhar based NPCI.
- The transfers made through DBT may also be updated in the NULM MIS portal.

III. Social Mobilisation and Institution Development (SM & ID)

- Under the SM&ID component, a onetime Revolving Fund support of Rs.10,000/- is provided to urban poor SHGs which have not availed such support earlier. Similarly, a onetime Revolving Fund support of Rs.50,000/- is available to registered Area Level Federations of SHGs.
- Under the DBT initiatives, Urban Local Bodies(ULBs) will maintain a list of SHGs and ALFs and their accounts which have been verified.
- Thereafter, the ULBs will make an invoice of accounts against which the Revolving Fund support will be transferred directly to the accounts of beneficiaries preferably through PFMS System of CGA. However, the ULBs may also use the NEFT/RTGS or the Aadhar based NPCI.
- The transfers made through DBT may also be updated in the NULM MIS portal.

IV. Support to Urban Street Vendors(SUSV)

- Street vendors who undergo a training programme/workshop will

be paid a daily amount as stipend for number of days attended, and calculated based upon opportunity cost of livelihood.

- Under the DBT initiatives, the Training Providers/Resource Agencies will maintain a list of all beneficiaries and their accounts which have been verified.
- Claims for stipend to be given to the beneficiaries along with their account details, will be sent by the Training Providers/Resource Agencies to ULBs.
- After due verification, the ULBs will make an invoice of accounts against which the cash benefits will be transferred directly to the accounts of beneficiaries, preferably through PFMS System of CGA. However, the ULBs may also use the NEFT/RTGS or the Aadhar based NPCI.
- The transfers made through DBT may also be updated in the NULM MIS portal.

V. Innovative & Special Projects(I&SP)

- Under the DBT initiatives, all payments to the Institution/NGO or the Training Providers/Resource Agencies will be transferred directly to the concerned organization, preferably through PFMS System of CGA. However, the ULBs may also use the NEFT/RTGS or the Aadhar based NPCI.
- Any Project having a cash component for the beneficiaries will have to ensure Aadhar seeding of the beneficiaries.
- Under the DBT initiatives, the Institution/NGO will maintain a list of all beneficiaries and their accounts which have been verified.
- Claims for cash benefit to be given to the beneficiaries along with their account details, will be sent by the Institution/NGO to State Implementing Agency/ULBs.
- After due verification, the State Implementing Agency/ULB will make the invoice of accounts against which the cash benefits will be transferred directly to the accounts of beneficiaries, preferably through PFMS System of CGA. However, the ULBs may also use the NEFT/RTGS or the Aadhar based NPCI.
- If the Project envisages provision of training for the beneficiaries, the Institution/NGO will maintain a list of all beneficiaries and their accounts which have been verified. Aadhar seeding of all beneficiaries will also be done.
- If the training provides for reimbursement of transport costs, boarding and lodging expenses, etc. which are to be given to the

- beneficiaries along with their account details, will be sent by the Training Providers to the State Implementing Agency/ULBs.
- After due verification, the State Implementing Agency/ULB will make the invoice of accounts against which the cash benefits will be transferred directly to the accounts of beneficiaries, preferably through PFMS System of CGA. However, the ULBs may also use the NEFT/RTGS or the Aadhar based NPCI.
 - The transfers made through DBT may also be updated in the NULM MIS portal.

VI. Capacity Building & Training (CB&T)

- Under the CB&T component, remuneration, TA, DA, etc. are provided to staff including Experts in SMMU and CMMUs, Community Organisers and support staff.
- Under the DBT initiatives, All State Level Implementing Agencies and Urban Local Bodies(ULBs) will maintain a list of staff along with their Aadhaar number and bank accounts which have been verified. All payments made to staff on account of their remuneration, TA, DA, etc. would be made directly to their bank accounts preferably through PFMS System of CGA. However, the NEFT/RTGS or the Aadhar based NPCI may also be used.
- In case the manpower support at SMMU and CMMUs, is hired through an agency, the agency will maintain their Aadhaar number and bank accounts which have been verified. All payments made to the agency, will be transferred to its bank account electronically preferably through PFMS System of CGA. However, the NEFT/RTGS or the Aadhar based NPCI may also be used.
- The transfers made through DBT may also be updated in the NULM MIS portal.

Integration of DBT details with MIS

Details of beneficiaries including Aadhaar number, bank account numbers, mobile number, amount transferred to each account through DBT, transaction details, etc. should be entered in the MIS regularly.

It is requested that the consent of the State/UT along with suggestions, if any, for further improvement/fine-tuning of the proposal may be sent to the Ministry at the earliest so that the DBT framework can be implemented for DAY-NULM.

I am directed to refer to this Ministry's Office Memorandum of even number dated 18.3.2016(copy enclosed) vide which a Concept Note on adoption of DBT initiatives under DAY-NULM, was forwarded. Thereafter, Cabinet Secretariat has informed vide their O.M. dated 31.3.2016(copy enclosed) the scope of DBT is expanded to include all welfare/subsidy schemes operated by all Ministries/Departments of Government of India directly or through implementing agencies, which involve cash/kind benefits' transfers to individuals. It is specified that the scope of DBT is expanded to include cash transfer to individual beneficiaries, in-kind transfer to individual beneficiaries as in the case of Public Distribution System and other transfers within the programme design comprising transfers made to the various enablers of government schemes like community workers, NGOs, in the form of honorarium, incentives, etc, for successful implementation of the schemes. Further, all States/UTs are required to establish internal DBT Cell to take advantage of ICT technology to improve Government to People interface and develop IT application to capture real time information about the DBT status of various schemes.

2. Stiff time-lines for implementation of DBT have been laid down by the Government and these includes setting up of internal DBT Cell in all States/UTs by 30.6.2016, all DBT disbursal to be Aadhar linked by 31.12.2016 and all subsidies and welfares schemes to be brought under DBT by 31.3. 2017.

3. In view of the facts mentioned in the preceding paras, all States/UTs are requested to take the following courses of action on priority basis:-

- i) Creation of an internal DBT Cell in State/UT (latest by 30.6.2016);

- ii) Adoption of DBT measures for DAY-NULM for last leg transfer of funds through electronic means by state implementing agencies to an Institution/Organization or a beneficiary by following the procedures prescribed in the Concept Note circulated vide this Ministry's O.M. dated 18.3.2016. Scope of DBT may be enhanced by including the transfers made in the form of salary, honorarium, incentives, etc. paid to the various enablers of DAY-NULM like Community Organizers and other contractual staff engaged by SMMUs and CMMUs (latest by 15.7.2016);
- iii) Seeding of beneficiaries list with Aadhar or any other bio-metric Identification(latest by 15.12.2016)
- iv) Developing an IT application to capture real time information about the DBT status of various schemes and uploading of details of beneficiaries on MIS portal by the implementing agencies which can be accessed by the Ministry, State/UT Governments and other stake holders(latest by 15.12.2016);

3. Cabinet Secretariat has informed that implementation of DBT in all Schemes involving transfer of cash and in-kind benefits to individual beneficiaries has gained prime importance and its implementation is being monitored at the highest level. As such, you are requested to take necessary action and intimate the details of Internal DBT Cell constituted in your State and the measures taken for rolling out of DBT measures for DAY-NULM, by return communication.
