





For some time past, it has been observed by the State Government in Finance Department that proposals are received from various Departments for opening of Bank Account in the name of Government Officials or Government Institutions/Offices for implementing various development schames/projects or for the implementing various development Institutions. Bometimes funds management of particular Government Institutions. Bometimes funds are directly received from different Hinistries of Government of are directly received from different Hinistries of Government of India (GOI), and the amount is directly credited into the bank India (GOI), and the amount is directly credited into the bank account of the concerned administrator, authorised to implement the project. In some cases, though the Central fund is routed through State Budget, as per guideline of the concerned scheme/project, separate Bank Account is required to be opened. Again, project, separate Bank Account is required to be opened. Again, in some cases fund from State Budget is released as 'Block Grants' in some cases fund from State Budget is released as 'Block Grants' in some cases fund from State Budget is released as 'Block Grants' in some cases fund through Bank Accounts in the name of those Institutions.

As a consequence of the various factors mentioned above, a large number of bank accounts dealing with public funds are under operation in the State. In order to monitor the actual utilisation of public fund transacted through bank accounts, it is necessary to streamline the opening and operation of bank accounts and develop an IT-based accimaism, which will provide the expenditure details and closing balance on a regular basis.

with this objective in view the Governor is pleased to issue the following guidelines in the matter of opening and operation of bank accounts by Government officials/agencies/institutions:

- 3. No proposal for opening of new bank account shall be considered by the Finance Department unless the list as referred to in paragraph-1 is received by February 29, 2008.

- 10. The fund released by the Government shall not be withdrawn by any Department/District Officer for the purpose of keeping them in fixed deposit; it should be utilized as soon as possible, for the purpose for which it was sanctioned. This does not prohibit the Department to utilize subject to guidelines, if any, the amount of interest, if any credited by the mank in respect of any Savings mank account.
- 11. Wherever feasible remittence facility may be used for transfer of fund from Mead (ffice to the field offices and refund of unspent balances from field offices to Mead Office. Under the Remittance facility system, the money can be transferred from one branch to other branch of the same bank under centralized computer system in real-time.
- Reconciliation of those lank Accounts shall be made on the quarterly basis.
- 13. Expenditure out of the bank accounts shall be subject to financial rules and guidelines, if any, under the relevant schools. Concerned Administrative Department shall introduce post-audit to monitor the operation of bank accounts.
- 14. For the purpose of monitoring the bank accounts the Departments shall develop uniform, integrated and comprehensive Hanagement Information and Accounting System and it shall, preferably, see on IT-Lase.
- 15. The Department shall nominate one modal officer who shall be responsible for the coordinating the operation of all bank accounts under the control of the Department and sending quarterly reports as referred to in para 7.
- 16. The Directorate of Treasuries & Accounts, shall independently, arrange to collect information from the Eank regarding Bank-account-wise consolidated opening balance, receipt and payment during the period and closing balance for each account on quarterly basis for cross verification of the Departmental statements.

All Administrative Departments and the Scheme implementing authorities from State level to field level are requested to follow the abovementioned guidelines where the funds flow directly from Government of India and/or State Government to Districts/field Offices through Bank account for implementation of different development Scheme/Project.

The Committee had submitted its interim report in April, 2017 and the final report on 10.7.2017. Two of the recommendations made by the committee in its reports are reproduced below:

Page No. 40 of Interim Report: "The states be directed to provide the details of the fund earmarked by them for construction of a shelter with the funds of NULM i.e. the quantum of funds received and utilization thereof by the States/ UTs".

Directions sought by Committee from Hon'ble Supreme Court: Directions be given to all States/ UTs to disclose the extent of amount spent by them on the component "Shelter for Urban Homeless", out of the amount released by the Centre for all the seven components of DAY-NULM. The year-wise details may be furnished by all the States/ UTs to the Ministry of Housing and Urban Poverty Alleviation".

In this connection, it would be recalled that the Member Secretary of the Committee had also written a letter to the States/ UTs directing for maintaining a separate account for SUH component.

- Now, the Hon'ble Supreme Court, after going through the Report, vide its Order dated 08.11.2017 in above mentioned case, has, inter-alia, observed that "the Union of India may also have to look into the matter on how to implement the Mission effectively so that crores of rupees that are sanctioned are not frittered away on issues that have no concern directly or indirectly with the NULM".

In pursuance of the recommendations of the Committee and above observations of the Hon'ble Supreme Court, it has been decided by the Ministry that with effect from the FY 2018-19, the States/ UTs shall keep the funds earmarked/allocated for Shelter for Urban Homeless component, out of the funds under DAY-NULM, in a separate account, and furnish the detail of utilization of funds on Shelter for Urban Homeless component, separately, along with the Final Utilization Certificate duly certified by the Auditor, as per the established procedure under GFR 2017.

5. All the States/UTs are, therefore, requested to take note of the above procedure for its strict adherence from the next FY 2018-19.
