

R. Kumar & ANR. Vs Union of India & ORS placed in the file may kindly be referred to.

In the above stated office Memo., at Para-2 & 4, Ministry of Housing & Urban Affairs (UPA Division), Govt. of India clearly directed all state level nodal agencies of States / UTs to keep the funds earmarked / allocated for Shelter for Urban Homeless (SUH) under Dinadayal Antodyay Yojana – National Urban Livelihood Mission (DAY – NULM) in a separate bank account with effect from F.Y. 2018-19 for proper utilization of fund as per the recommendations of the Committee formed by Hon'ble Supreme Court of India and observations of the apex Court of Law.

Accordingly, a proposal for opening a separate bank account for Shelter for Urban Homeless (SUH) under Dinadayal Antodyay Yojana – National Urban Livelihood Mission (DAY – NULM) was sent to the Urban Development & Municipal Affairs Department, Govt. of West Bengal which was duly approved by the Secretary, Urban Development & Municipal Affairs Department and Chairman, SUDA (copy placed).
