

Affordable Housing Project:	Housing Projects where 35 % of the houses are constructed for EWS category
Beneficiary	A beneficiary family will comprise husband, wife and unmarried children. The beneficiary family should not own a pucca house (an all-weather dwelling unit) either in his//her name or in the name of any member of his/her family in any part of India
Carpet Area	Area enclosed within the walls, actual area to lay carpet. This area does not include the thickness of the inner walls.
Central Nodal Agencies	Nodal Agencies identified by Ministry for the purposes of implementation of Credit Linked subsidy component of the mission

# **1. Situation assessment for HFAPoA**

## **1.1 Background**

“Housing for All” Mission for urban area will be implemented during 2015-2022 and this 1.1 Mission will provide central assistance to implementing agencies through States and UTs for providing houses to all eligible families/beneficiaries by 2022.

Mission will be implemented as Centrally Sponsored Scheme (CSS) except for the component 1.2 of credit linked subsidy which will be implemented as a Central Sector Scheme.

A beneficiary family will comprise husband, wife, unmarried sons and/or unmarried daughters. 1.3 The beneficiary family should not own a pucca house either in his/her name or in the name of any member of his/her family in any part of India to be eligible to receive central assistance under the mission.

States/UTs, at their discretion, may decide a cut-off date on which beneficiaries need to be resident 1.4 of the urban area for being eligible to take benefits under the scheme.

Mission with all its component has become effective from the date 17.06.2015 and will be 1.5 implemented upto 31.03.2022.

All 4041 statutory towns as per Census 2011 with focus on 500 Class I cities would be covered in three phases as follows:

Phase I (April 2015 - March 2017) to cover 100 Cities selected from States/UTs as per their willingness.

Phase II (April 2017 - March 2019) to cover additional 200 Cities.

Phase III (April 2019 - March 2022) to cover all other remaining Cities.

Ministry, however, will have flexibility regarding inclusion of additional cities in earlier phases in case there is a resource backed demand from States/UTs.

## **1.2 Approach and Methodology**

The HFAPoA for Gangarampur has been prepared in accordance with the guidelines issued by Ministry of Housing and Urban Poverty Alleviation, Government of India. Overall approach adopted throughout the preparation of this HFAPoA has been based on four key principles,

- well rounded stakeholder consultations,
- continuous community involvement,
- providing innovative solutions and
- coordination & validation.

Methodology adopted for preparation of HFAPoA is demonstrated in the below:

- 1) Taking Initiative for Demand Assessment Survey.
- 2) Conducting Orientation Programme with elected representative and officers of ULB.
- 3) Conducting Orientation programme with Supervisors and Enumerators.

- 4) Conducting Demand survey and complete the work.
- 5) Conducting Data Entry of the survey form and complete the work
- 6) Analysis of the data.
- 7) Filling up the requisite formats.
- 8) Planning of project with elected representatives and officers of ULB.
- 9) Preparing investment requirement and Financial plan
- 10) Finalization of HFAPoA.

### **1.2.1 Stakeholders Consultative Workshop / Meetings**

IHSDP ( a component of JNNURM) envisages continuous involvement of all stakeholders with specific reference to the community members for the preparation of HFAPoA. With an objective to develop a detailed understanding of the provisions and procedures of RAY as stipulated by Ministry of Housing and Urban Poverty Alleviation (MoHUPA), GoI a number of workshops and capacity building programmes were organised by the SUDA, GoWB both at the state level as well as ULB level. ### 1.3. City Profile and Overview

Gangarampur has a history of human civilization. Each historic antiquities of the site found from archeological excavation in the outskirts of Gangarampur reveals that there was a major early historic human settlement dated back to the 1<sup>st</sup> century A.D.

is a historical place at 'Bangarh' a mound which was the Capital of the king 'Ban Raja' (a Pouranik character). The place is surrounded by a circular canal which may be developed as a tourist spot possessing many historical temples.

Ancient histories of this site have already been found by excavation of the mound under the guidance and supervision of Geological Survey of India.

The town situated over the river banks of Punarbhaba and to some extent on the banks of river Brahmani. The newly developed Malda-Balughat state highway (SH-10) is running east –west direction of the town and another state highway Hamjapur (BOP) - Balurghat (SH-10A) is running north south direction of the town forming head quadrants. The Gangarampur town is under the District Dakshin Dinajpur, the head quarter being at Balurghat. The sub divisional head quarter is set up at Buniadpur which is 12 K.m. west from this town.

The town Gangarampur Municipality was established on 24<sup>th</sup> September, 1993 having with a population 41800, along with 3 full mouza and 5 part Mouza under Gangarampur P.S. At present municipal population are 56,175 as per census 2011.

Historically very little is known about the town, except that there is a historical place called Bangarh within the municipality, which was the capital of the King named BAN RAJA.

Gangarampur is a sub-divisional town of the district of Dakshin Dinajpur. The river Punarbhaba crossing this town from north to south. Its geographical location is 20° 30' latitude North and 88° 25' longitude east. Gangarampur became a sub-division in 1991. Earlier, it was part of a Balurghat sub-division in the district of former West Dinajpur ., Baruipur municipality covers an area of 10.29 Sq.Km. only.

Gangarampur Municipality is located at the extreme southern side of Kolkata Metropolitan Area. Railway line has connected this municipality with Kolkata and Siliguri. NH 512 Road is one of the major roads, which has connected the area with Kolkata and SH-10 connected with NH 34 for Siliguri at Raiganj in the District of Uttar Dinajpur.:.




WEST BENGAL AND DISTRICTS

## **1.4. Housing and Physical Infrastructure profile**

### **Housing profile**

50% of the households live in a house/hut with only one room. In context of Gangarampur , 25% of households live in pucca or partially pucca houses. Housing condition in its slums is not in good shape as 80% houses are either Katcha or semi-pucca. Considering the above, municipality has already initiated construction of houses in 50 slums spread over 17 wards on a piecemeal basis leveraging IHSDP ( a component of JNNURM) scheme in a phased manner. In the First phase (2008-2012) total 685 houses were constructed in 30 slums spread over 15 wards. And in the 2<sup>nd</sup> Phase total 467 houses were constructed in 20 slums spread over 16 wards Infrastructure projects like Road, Drain and pipeline work were also targeted in some of the slums. In the 2<sup>nd</sup> phase (2009-ongoing), 467 dwelling units have been

constructed till 2012 along with CC Road, Shallow drain and water supply distribution line. 2<sup>nd</sup> phase of IHSDP is also under process.

The following table gives ward-wise construction of urban poor houses planned during 2007-08 till date under IHSDP and HUP.

## **Land Use**

The total area<sup>1</sup> of the Gangarampur computed on GIS Platform is 1029.00 Ha or 10.29 sq. Km<sup>2</sup>. The different utilities and detailed features of Gangarampur Land use were mapped in GIS and were broadly categorized in line with the UDPFI guidelines.

The important features of the Gangarampur land use that needs to be highlighted include:

- Gangarampur is primarily a residential area with limited industrial activities, so industrial area has been clubbed with commercial area
- Gangarampur has 38 Educational Institutions and 1(One) Technical institutes. All of these have been categorized under Institutional category.
- Components falling under “Others” category comprise of following further categories which are presented in the table below:

Land use pattern of Gangarampur is broadly influenced by the main Road and rail route and the proximity to Kolkata. As a result the main residential, commercial and public-semi-public areas are concentrated along the transport route but mostly concentrated towards north. The agricultural and plantation areas are mostly concentrated towards the southern fringe areas. Archeological Mound Bangarh situated at the north side of the Municipality. Image below shows the land use characteristics of the Gangarampur city.

Other hand Punarbhaba the Main river of this town flows from the north to south at the Western part of the Municipality.

### Housing Typologies

As on September 2015, the population of Gangarampur was 58057 of which number of persons residing in slums are 22331, which is about 38.5% of the total population. As per the socio economic survey undertaken as part of preparation of HFAPoA and validated by ULB and community, a total of 4759 households stay in slums. Out of 4657 household, 771 household living in semi pucca house and 3892 household living in kuchha house. From present Demand Assessment survey for Housing for all (HFA), it is noticed that 4663 under Slum area household covering under this project. Out of these 5657 houses, 3892 houses will be constructed through “Beneficiary-led-Construction” and 965 houses will be constructed through “credit Link Subsidy scheme ” each beneficiary will get 1.5 lakh from central assistance and under “Beneficiary-led-Construction”.

## **Physical Infrastructure profile**

### **Water Supply**

As Gangarampur is situated mostly on fallow land in between Brahmani & Punarbhaba , part of the town is serviced by piped water supply from Rajibpur Water supply and Belbari Water supply scheme. Though the water supply network extends over most of the core city and peripheral areas, it does not meet consumer demand as only 34% of the area within municipal limits are covered with piped water supply system. Apart from the surface water, ground water also serves as another source of water supply in the municipality as around 44% percent is served with hand pumps and 12.5% depend on own tube wells and other sources. The features of water supply in Gangarampur is presented in the table below

Gangarampur Municipality is a water supply deficit municipality with deficit likely to increase up to 2.87 MLD in 2016. Within the areas served with piped water supply, the population does not get water as water supply is intermittent throughout the town and available for only 4 hours a day and water had Iron & Fluoride contents in some slum pockets.

Keeping in consideration of the above gap, Gangarampur Municipality has taken up a water supply project to improve the situation in all 18 wards of the Municipality under JNNURM..

### **Drainage and Sanitation**

The total drainage network of Gangarampur municipality is of 135 Kms. The storm water drains carry sullage and rainwater and ultimately drains into two main drainage channels, namely, i) Dhaldighi Canal located on the southern side of the municipality and ii) Ganesh Talkies Canal located and running besides the Municipal office , which ultimately falls in Punarbhaba River.

The contour map of Gangarampur shows that it is elevated towards the Punarbnhaba , as a result of which a large portion of the area could not drain the sullage water and hence, remains flooded during rainy season. Improper drainage system is a burning problem of Gangarampur Municipality, which leads to water logging condition in several places every year during monsoons. Some of the key places wherein water logging is visible include i) East Halderpara (ward 14), ii) Paulpara (ward 3), iii) Ramkrishna pally (ward 16), ivPWD Para (ward 6), v) West Halderpara (ward 5) etc.

To address the above issue, Municipality has taken an initiative to integrate drainage system of Gangarampur Municipality.

The sanitation system of the town is poor. The table below presents a service level standard of Gangarampur in terms of coverage of the city with respect to sanitation and sewerage.

Above table clearly shows though toilet coverage of the town is reasonably good, but lot of interventions are required to improve sanitation and sewerage facilities as there is no household level drainage facility leading to unhygienic environment in slums.

### Solid Waste Management

Solid Waste Management in Gangarampur Municipality is not as per MSW (Management and handling) rules 2000. Garbage is being collected from door to door by tricycle van from all wards and stored

temporarily in the nearby vat points (primary collection center) managed by Municipality. There is also lack of on time collection and disposal to the existing dumping ground which causes dumping in drains and spread of foul odour in the primary disposal point.

### Road Coverage and Condition

Road network in Gangarampur has grown to a total of 188.45 KM km. While more than 15% of roads are black topped and 75% roads are concrete, around 10% of the road network is still katcha road Due to lack of proper maintenance, the surface conditions of the roads are not good which in turn reduces the speed of moving traffic.

### 1.5. Assessment of Present Status of Slums

With an objective to formulate appropriate Slum Development Model for each of the slums, availability of latest and reliable baseline data on all the slums is instrumental. This baseline data encompassing indicators including socio-economic, geographical/spatial, physical etc. shall help develop an overall portrait of the slums in Gangarampur . This all help in identifying development need for slums and formulating slum specific development strategies.



As on September 2015, Gangarampur had a total of 50 slums spread across all the 18 wards of the municipality. The population of Gangarampur is 58488 of which number of persons residing in slums are 22311 (approx), which is about 38% of the total population. As per the socio economic survey undertaken as part of preparation of HFAPoA and validated by ULB and community, a total of **4657** households stay in slums. Out of **4657** household, Approx 965 household living in semi pucca & Puccaa house and 3892 household living in kuchha house.

Following maps show the location, status (notified/non-notified) and age of all the 50 slums in Gangarampur

**Slum pockets marked on the GIS base map with municipal boundary and ward boundaries**



- Maximum concentration of population has been observed in ward no. 14 .
- There is no gender imbalance in terms of population of male and female in slums of Gangarampur recording almost 1:1 ratio.
- Similarly maximum concentration of households is observed in 11 wards ( 1,2,4,5, 10,11,13,14,15,16 and 18), while, seven wards, number of households comes around less than 150.

Table below represents ward wise distribution of all the slums along with their ownership status, and age.

- Gangarampur has uneven distribution of slums in its 18 wards with 6 wards having or more than 4 slums, while, in 7 & 8 wards there is only one slum in each ward and in Ward No 12 having no Slum.
- Out of total 50 slums, all are Non-notified slums. Distribution of Slums based on status, population and area is provided in Annexure B-1.
- Average age of the slums is around 74 years and the age varies from 15 years to maximum of 100 years. Number of slums existing for more than 100 years is 13and 75 and above years old is 10.

### 1.5.1. Slum Profile and its Location

#### Slum status as per Location

Location wise analysis shows that 50 slums are situated in core area<sup>3</sup> of the municipality, of which all slums are non notified slums.

- Total area under slums is 4.51 sq. km which excluding vacant land, water bodies falling under slums
- Total area under slums in Gangarampur constitutes 38% of the total area of the city with maximum concentration of slums. Around 62% of non-notified slums are located in the fringe area of the city with total area of the slums coming under that area accounting for around 61% of the total slum area of Gangarampur.

#### Land Value Analysis


Owing to geographical nature of the municipality as mentioned in the above section, land values in slums are observed to be of varying nature. Based on information on land values at different areas of Gangarampur received from West Bengal Valuation Board (WBVB), all the slums have been categorised into four zones in order of increasing market value. The zones are: i) Z1 (High), ii) Z2 (Moderately High), iii) Z3 (medium) and iv) Z4 (Low). (Refer annexure B-4 for land values in four zones)

<sup>3</sup> Core Area: Area having a population (based on the previous census) of at least 50,000 persons in the case of a Census Metropolitan Area (CMA), or at least 10,000 persons in the case of a Census agglomeration CA.

- Majority of slums located in Northern most fringe of the municipality have relatively lower land value zone (Z1, Z3 and Z4). This is primarily attributed to the rural characteristics of this part of the municipality with a significant presence of agriculture and plantation area.

Table above shows ward-wise distribution of slums in terms of population density<sup>4</sup>. and it is observed that maximum concentration in terms of population density is visible in slums located in ward nos. 2, 7,8,9,15, 16 and 17. On the contrary, minimum concentration in terms of population density is observed in slums located in ward nos. 3, 4,11,14 etc.

Overall, average population density is relatively higher in notified slums than non-notified slums. Based on analysis with respect to linkage between age and population density in notified and non-notified slums it reveals that

- In case of 40 notified slums, 30 slums are more than 30 years old with average population density being around 5400 per sq. km. Of the remaining 10 slums, 8 slums are more than 25 but less than 30 years old with average population density of around 6100 per sq. km.
- Regarding 24 non-notified slums, 21 slums are more than 30 years old with average population density recording around 4300 per sq. km.

### Land Tenure Status

Security of tenure was assessed on the basis of slum households having patta and possession certificates.

Key observations from the above table are:

- Majority of slum dwellers of Gangarampur enjoy secured tenure status. In notified slums 12% households hold patta and possession certificate with them, whereas, in non-notified slums, 72% households hold patta and possession certificate.

### 1.5.2. Summary of Findings of Demand Survey

Housing for All (HFA) Scheme has since been launched by the Ministry of Housing & Urban Poverty Alleviation (MoHUPA), Govt. of India in Mission mode which envisages provision of Housing for All by 2022 when the Nation completes 75 years of its Independence. The Mission seeks to address the housing requirement of urban poor including slum dwellers through following programme verticals:

- a) Redevelopment of slums with private participation
- b) Promotion of affordable Housing for weaker section through credit linked subsidy
- c) Affordable Housing in partnership with public sectors
- d) Subsidy for beneficiary-led individual house construction.

In compliance with the objective and as per direction of the Ministry of Housing & Urban Poverty Alleviation (MoHUPA) and State Urban Development agency(SUDA), West Bengal was undertake a demand survey through suitable means for accessing the actual demand of housing. For this mission Gangarampur Municipality undertook Demand survey on and completed the survey on 01.10.2015. From this survey, different information have been took off. Summary of findings of survey have been given below:

From the above table, it is noticed that Municipality conducted of survey of 4657household. Out of 4657 households, 4463 households headed by male member194 households headed by female member. Ward-wise details are given in the table.

In summarizing the HFAPoA of Gangarampur Municipality, Gangarampur Municipality takes two verticals for implementation of the project i.e. “Credit Link Subsidy scheme ” and “Beneficiary –led – construction”. For this project, Gangarampur Municipality conducted Demand Assessment survey for getting total requirement of houses in the ULB. From this survey, the total survey form received 2218. From 2218 forms, 2042 forms for Format B. Out of 2042 2027 form received from 64 slums and 15 forms received from non slums. 176 forms for format A received from 3 slums. Out of these 2218 houses, 2042 houses will be constructed through “Beneficiary-led-Construction” and 176 houses will be constructed through “Redevelopment with private participation”.

- Drains

Improper drainage system is one of the emerging challenges of Gangarampur Municipality, which leads to water logging condition in several slums every year during monsoons. None of 64 slums of Gangarampur have connectivity to city wide underground drainage/sewer line. Table below shows the status of connectivity to City-wide Storm-water Drainage System.

As can be observed from the above table:

- Out of 50 slums, 752 households staying in 12 slums of Gangarampur are fully connected with storm water drainage facility.
- Majority of the slums (50 slums) covering 62% of total HHs are partially connected as only part of their respective slum areas are reported to be connected with the facility
- Total of 50 slums are non-notified slums, are not at all connected with any kind of sewer/drainage system.

#### Roads

Accessibility to roads is an important parameter for development of slums. From the figure alongside, following key things can be ascertained

- About 28% households in slums have access to motorable pucca road and another 54% households to non-motorable pucca road.
- Rest of the households have access to katcha road, of which around 23% households have motorable katcha road facility and rest have access to katcha road, but non-motorable.

## 1.6. Tenability Analysis

Having assessed the status of slums with respect to physical location and land use characteristics, all 64 listed slums in Gangarampur Municipality are analysed with regard to their tenability in order to determine prioritization of slums and slum development options i.e. whether planned service provision will be undertaken through in-situ up-gradation /redevelopment or resettlement. The objective of this exercise is to classify slums as Tenable or Untenable and any slums which are classified as Semi-Tenable were further analysed to classify them as Tenable or Untenable. HFA guidelines prescribe the following criteria for classifying the slums as tenable, semi-tenable or un-tenable are provided in the box below:

### **Tenable Slums:**

1. All slum pockets located on non-objectionable and non-hazardous sites as obtained from NBO formats.
2. As per “Model Property Rights to Slum Dwellers Act, 2011”- All slums settlements which do not fall within the definition of untenable settlements are considered as tenable and fit for in-situ redevelopment / improvement.

### **Semi Tenable Slums**

All slum pockets located on sites which are earmarked for non-residential uses as per Master Plan are categorized as semi-tenable for further analysis and review. Finally, the semi tenable slums are either categorized as Tenable or Untenable.

### **Untenable Slums**

- (i) As per NBO format, slum pockets in the following locations may be considered as untenable

Major storm water drains, Other drains, Railway line, Major transport alignment, River or water bodies Bank , River bed and others (hazardous or objectionable) including high tension lines.

However, slums on other drains may be examined for being included in the category of semi tenable or tenable

Slums depending on the exact location of the slum and the possibility of in-situ development through sustainable engineering solutions

- (ii) As per “Model Property Rights to Slum Dwellers Act, 2011”

Those settlements which are on environmentally hazardous sites, ecologically sensitive areas, prohibited areas around heritage sites and land marked for public spaces, utilities, services and infrastructure.

Analyzing the above principals, it is observed that out of 50 slums, certain pocket of no slums may not need to be relocated. However, In addition, the tenability of slum was assessed on the following parameters

- **Land Use:** Gangarampur municipality has a Land Use and Development Control Plan (LUDCP) which prescribes the mixed land use characteristics for all the four identified development control zones. Looking into the mixed land use, location of the slums in Gangarampur is in conformity with the proposed land use.
- **Flooding:** Four slums out of 50slums are prone to flood for more than 5 days and can be made tenable through sustainable engineering solutions like proper drainage system.

Accordingly, all the 50 slums in Gangarampur are considered to be tenable.

## **2. Assessment of Existing and likely Future Housing Shortage**

### **2.1 Existing Housing Shortage (Slums and Non Slums)**

Gangarampur Municipality has been analysed on the basis of information available through Demand Assessment survey, Census Records, Stakeholders' consultation, State level and National level reports and policies.

As prescribed by HFA Guidelines the housing shortage is assessed by adopting two pronged approach. They are:


- I. **Curative Approach:** The housing shortage or deficiency for the existing slums and non slum is worked out at 2218 units and is summarised in the following table:

- II. **Preventive Approach:** The preventive approach is aimed at prevention of new slums by providing for adequate affordable housing for the migrant population and for the persons, who due to lack of affordable housing options may shift to slums. Preventive approach takes into consideration both the existing housing shortage and housing units that may be required in the future.

The Housing for preventive approach is calculated by considering the following parameters in the figure below.



The housing shortage in each of the above components is calculated as follows:

#### A. Assessment of Current Housing Shortage

##### I. Obsolescence Factor:

According to the "Report of the Technical Group on Estimation of Urban Housing Shortage", the households living in the dwelling units aged 80 years or more are deemed to be unfit for habitation". The obsolescence factor is taken into consideration as dilapidated houses in census records.

The following table shows the housing condition of residential houses in the Dakshin Dinajpur District.


