PREFACE

Pradhan Mantri Awas Yojana (PMAY) aims at Providing Housing for All (HFA) by 2022 when the Nation Complete 75 years of its independence.

The urban homeless persons contribute to the economy of the cities and thus the Nation as cheap labour in the informal sector; yet they live with no shelter or social security. The urban homeless service with many challenges like no access to elementary Public Services such as health, education, food, water and sanitation. Pradhan Mantri Awas Yojana (PMAY) also aims at providing a pucca house to every family with water connection, toilet facilities, 24 X 7 electricity supply and access.

The Mission seeks to address the housing requirement of urban poor including slum dwellers through "In Situ" Slum Redevelopment, Affordable Housing through credit linked subsidy, Affordable Housing in partnership and subsidy for beneficiary led individual house. Under the mission, beneficiaries can take advantage under one component only.

Total beneficiaries of the scheme are 679 nos from 50 nos slum and 50 nos of Non Slum projected for the year 2018-19.

Total cost of the project is **Rs. 2748.59 lakhs** as per relevant department & P.W.D. schedule of rates.

City Profile and Overview:

Municipal Vision

Sonamukhi Municipality aims at a Eco-friendly, socially, culturally and economically vibrant town where all citizens live healthy and inspired life, through increasing opportunity to avail basic services and civic amenities by the citizen and improvement of urban infrastructure and management by sufficiently strong and efficient city administration.

HISTORY

Sonamukhi became the third municipality of Bankura district in 1886. With the creation of Bankura town and district in 1881, Sonamukhi became its part in the same year. At the time of creation of the municipality, there were 5 wards and this urban area had a population of 5000 which has increased to 29085 at present (2011 Census). The number of wards have also increased to 15. Even though the population growth has not been very high because of the present economic downturn in the region Sonamukhi was once a prosperous, populous and thriving economy of the region as recorded in history.

A Historical and Cultural Profile -Sonamukhi

Sonamukhi was just a village during the pre Aryan era and gained prominence as a *4rriori* for *Jain* and *Buddhist* cultures during the Pal Dynasty (7th – 10th century). This is possible the time when the town emerged. The name Sonamukhi originated from the name of the village Goddess *Swarnamoyee*.

In the 17th century, Sonamukhi had a flourishing handloom industry and trade. In the first half of the 19th century, the fate of Sonamukhi started to decline. With the initiation of the Permanent Settlement by Lord Cornwallis thousands of farmers lost their land and extreme poverty plagued the society. The market for textile products was completely destructed. The handloom industry lost its entire luster in the early period of the nineteenth century due to its limitless torture and exploitations on the handloom workers by the East India Company. Around the same time a certain section of people who bought land from the poor farmers and appeased East India Company suddenly became rich and declared themselves as Zaminders. These people constructed many temples and structures

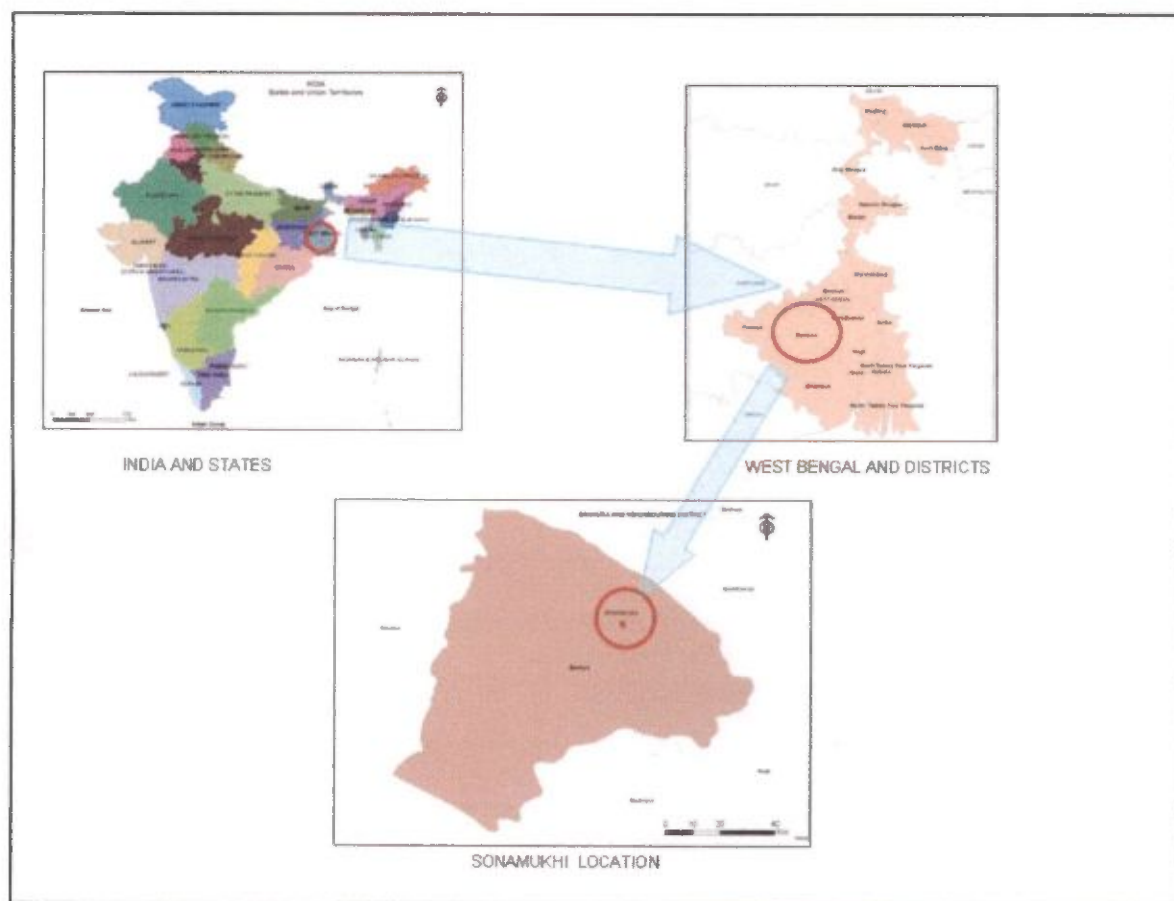
The affluence of the people at different times have been chanelised into art and culture. The presence of number of Shib temples like *Shidheswar Shib*, witness the influence of *jain* religion. The influence of *Sri Chaitanya* is evident from the pujas of *Govindji*, *Shyansunder*, *Gopinath* etc. A number of festivals is celebrated in the town. The most significant of them is the *Kali-Kartik puja*, *Shidheswar Shib Mela*, *Raasyatra*, *Mohotsab* etc.

Year of Establishment:-

Our Municipality constituted on 01/04/1886.

Administrative Boundaries:-

Sonamukhi is a town and a Police station in Bankura District in the Indian state of West Bengal. Sonamukhi is located at 23.3° N, 87.42° E. Sonamukhi is situated in the northeastern part of the Bankura district and is 44 kms away from the District headquarter Bankura. The total area of Sonamukhi municipality is 8.557 sq. Km. comprising 15 wards, 51 slum pockets, 8 Mouzas, 8000 holdings and 29083 populations (Census-2011).



Linkages of Rail, Road, Port and Air:-

The town is well connected with its hinterland by roads. The state highway connects it with Bankura, and Burdwan. The sub divisional town of Bishnupur is also connected by road. The industrial town Durgapur is very close to Sonamukhi connected by roads. There has been an ongoing project of extending the railway from Bankura to Mashagram via Sonamukhi. In September 2005, South-Eastern Railway threw open passenger services on the 41 km long Bankura-Sonamukhi broad gauge section, being the first phase of Bankura-Damodar River Railway Project. BDR Project entails extension from Sonamukhi to Raina (19.8 km) and then on to Masagram, providing direct connectivity to Howrah through Eastern Railway. Work is in progress (in 2007) in the Sonamukhi Raina Section.

Economic Activity:-

The economy of the town is not solely dependent on agriculture. However, it is a good service center for agricultural products. Industries are almost nonexistent except few four mills and rice mill in the surrounding regions. A major portion of people is engaged in cottage industry. Fishing, poultry and handloom are other economic activities in the area.

Demographic Growth and Population Projection

Sonamukhi is not very densely populated place. Except the central congested stretch, other wards contain significant amount of agricultural land and thus less holding. The population of the town is 29083 as per 2011 census. The population growth over the last 2 decades and the population projection is presented in the graph below.

Chart 1: Population Projection

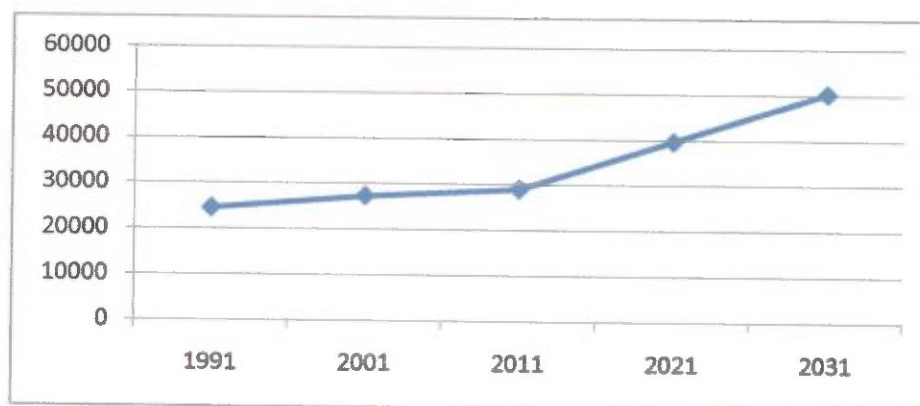

Chart 2: Ward wise Male Female Population Distribution 2001

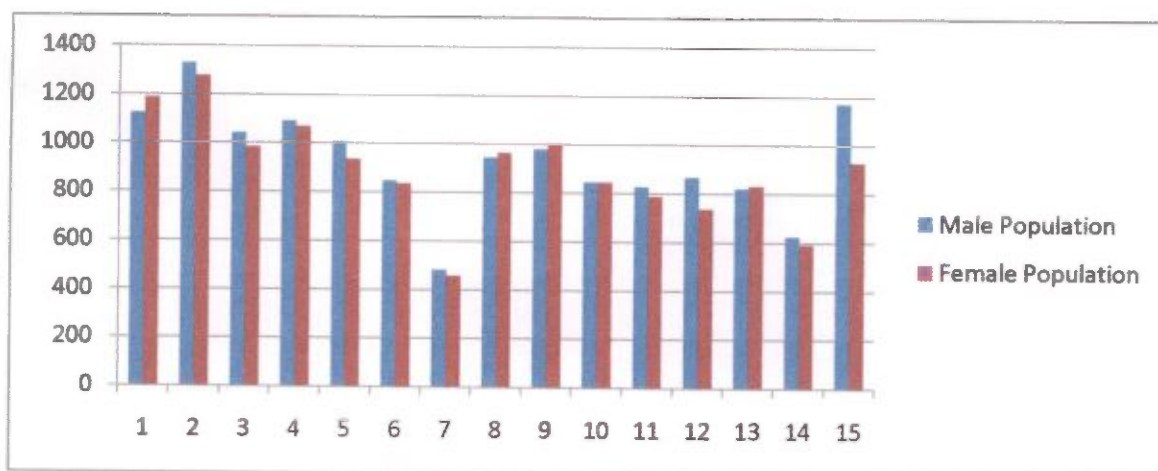


Chart 3: Ward wise Male Female Population Distribution 2011

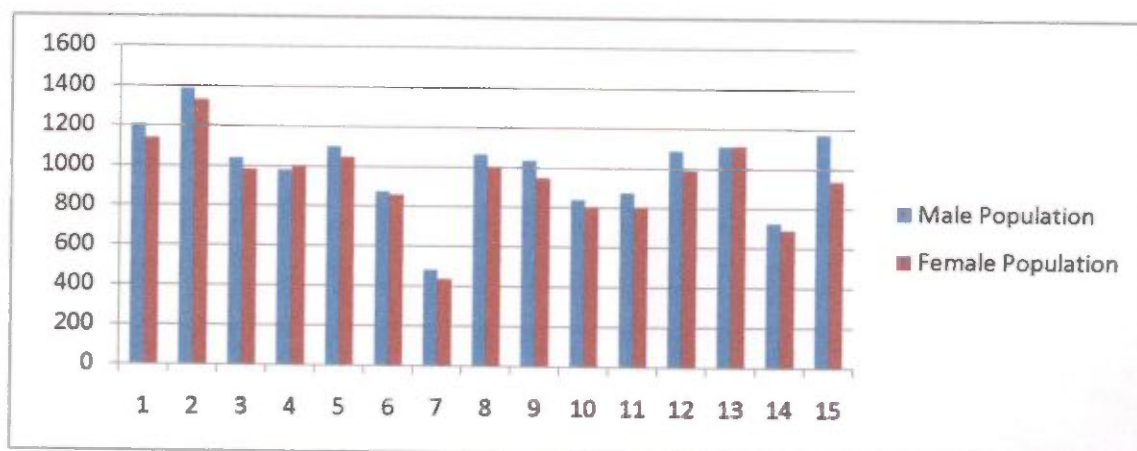

Traditional Arts/Crafts

Sonamukhi Municipality has started functioning from 01-04-1886. This Municipality is a small town. Handloom Works is the main occupation of the inhabitant of this Municipality. The minority population is very negligible near about 1% of the total population. The BPL families are 2852 nos. about 45% of total population are EWS households including BPL, minorities, SC, ST. Sanitation facilities specially in slum areas is very poor. To develop the situation of poor the scheme will be applicable for Sonamukhi Municipality.

Climate

The District experiences a climate which is transitional. Average temperature in the hot season is near about 30° C while at the cold season is 20°C and the average rainfall is 1500 millimeter. The cold season starts from about the middle of November and continues till the end of February. March to May is dry summer intervened by tropical cyclones and storms. June to September is rainy season while October and November are autumn.

Soil and ground quality

Environmental degradation also affects soil fertility, quantity and quality of water, forests, wildlife and fisheries. The degradation of land, through soil erosion, alkali-salinization, water logging, pollution, and reduction in organic matter content has several proximate and underlying causes. The proximate causes include loss of forest and tree cover, unsustainable grazing, excessive use of irrigation, improper use of agricultural chemicals, and disposal of industrial and domestic wastes on productive land.

Condition of heritage structure in the locality

Manmade heritage reflects the prehistory, history, ways of living, and culture, of a region. In the case of India, such heritage is at the core of our national identity. At the same time, considerable economic value, and livelihoods may be derived from conservation of manmade heritage and their sustainable use, through realization of their tourism potential. Heritage sites may be impacted by pollution.

There are a number of heritage building in the municipality especially of terracotta structures, which are both historical, cultural and architectural importance.

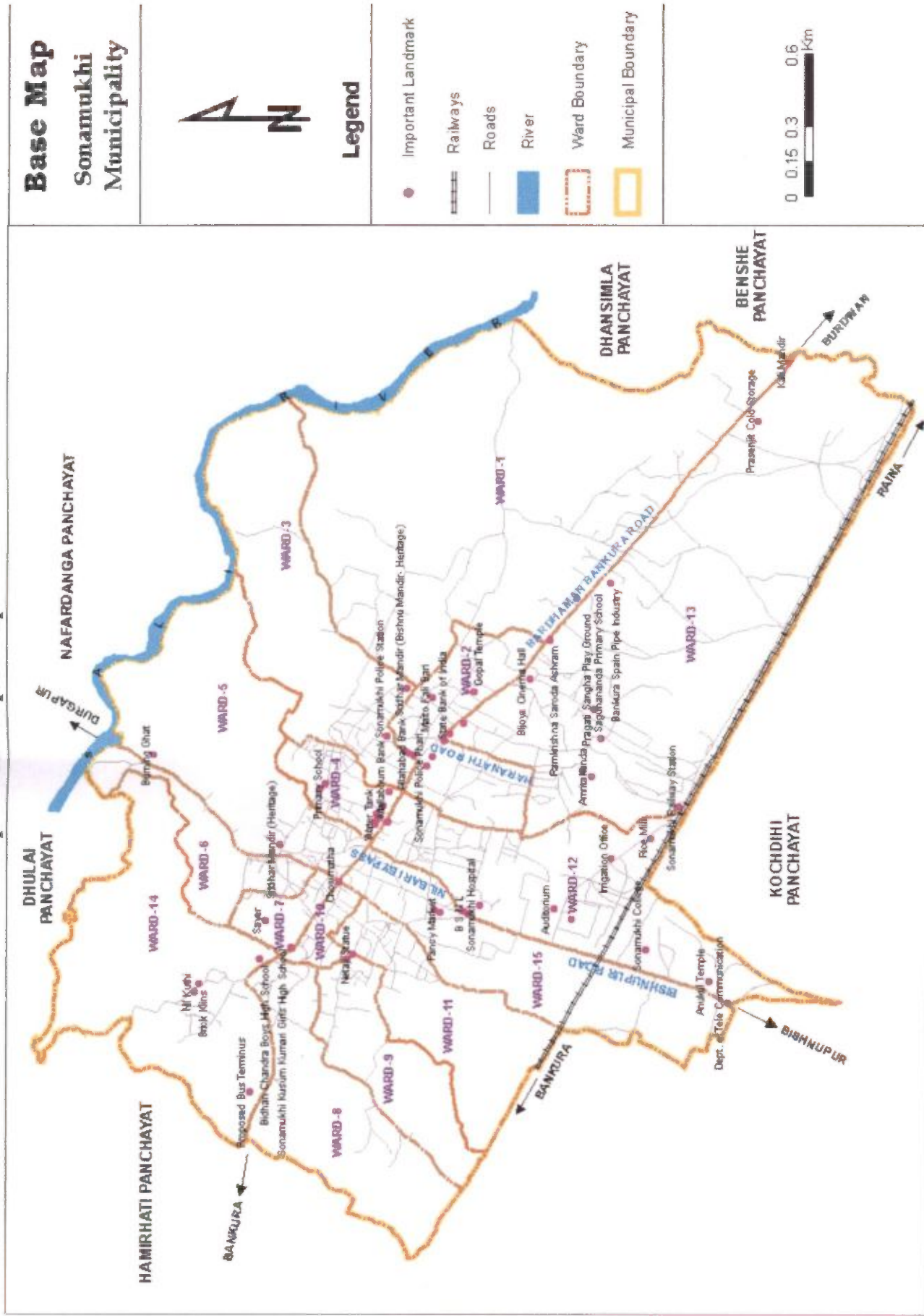

The preparation of HFAPoA broadly involve Slum Development/Rehabilitation Plans based on

- a. Survey of all slums – notified and non-notified;
 - b. Mapping of slums using the state-of-art technology;
 - c. Integration of geo-spatial and socio-economic data; and
 - d. Identification of development model proposed for each slum.
1. Base maps to an appropriate scale would be a pre-requisite for the preparation of Slum Development Plan/Slum-free City Plan. States/UTs may need to proceed in the following steps for the preparation of Slum-free City Plans.
 2. Securing CARTOSAT II/latest satellite images from NRSC/ISRO and preparation of base maps for the whole city and its fringes using the images;
 3. Identification and inventory of all slum clusters of all descriptions in the urban agglomeration with the help of satellite image and other available data;
 4. Inventory of all possible vacant lands in each zone of the urban agglomeration that could be used for slum development/ rehabilitation development purposes;
 5. Development of Slum Map of every slum within the city and its fringes using GIS with CARTOSAT II images, ground level spatial data collected through total station survey, collating spatial information with respect to plot boundaries, network of basic infrastructure like roads, sewerage, storm drainage and water lines, etc and superimposing this on the satellite image and importing them into GIS platform as the first step towards the preparation of Slum Development Plans and Slum Free City Plan.
 6. This may be undertaken with the help of technical partners of NRSC/ ISRO/other technical institutions.
 7. Identification and engagement of Lead NGO/CBO to guide and anchor community mobilization for the purpose of slum survey, (May be more than one NGO/CBO in different slum zones) of the city. These Lead NGOs/CBOs should also be associated in slum survey operations and dialogues for preparation of slum level development plans;
 8. Conduct of Slum Survey based on the detailed formats (with or without changes) prepared by the Ministry of Housing & Urban Poverty Alleviation with the help of National Buildings Organization (NBO) - after due training of trainers, training of survey personnel /canvassers and canvassing. It would be helpful for community mobilization to pick as many canvassers from the sourced slum or nearby slum pockets;
 9. Collection of bio-metric identification data of slum dwellers based on the above survey (subject to guidelines issued by Unique Identity Authority of India (UIDAI));
 10. Entry of data from Slum Surveys in the web-enabled MIS application (to be provided by Ministry of HUPA), compilation and collation of data, preparation of Slum-wise, City and State Slum Survey Database and Baseline Reports. The MIS will assist in developing a robust Slum

HFAPoA and Pradhan Mantri Awas Yojana (Housing for All)

To give pucca house for every family is currently on the global agenda. One of the Millennium Development Goals (MDGs) is to 'achieve significant improvement in the lives of slum dwellers, by 2022'. Similar goals are set forth by Pradhan Mantri Awas Yojana within year 2022, to create pucca house for every family.

ULB undertake a demand survey through suitable means for assessing the actual demand of housing. While validating demand survey, Cities consider possible temporary migration from rural areas to the city just to take advantage of housing scheme and exclude such migrants from list of beneficiaries. On the basis of demand survey and other available data, cities prepare Housing for All Plan of Action (HFAPoA). HFAPoA contain the demand of housing by eligible beneficiaries in the city along with the interventions selected out of four verticals. The information regarding beneficiaries is collected by ULB in suitable. While preparing HFAPoA, ULB and Implementing Agencies also consider the affordable housing stock already available in the city as Census data suggests that large numbers of houses are vacant.

Bank account number and Aadhaar number/Voter ID card/any other unique identification details of intended beneficiaries or a certificate of house ownership from Revenue Authority of beneficiary's native district integrate in the data base of HFAPoA for avoiding duplication of benefit to one individual family. Beneficiaries are validated by ULBs thereby ensuring their eligibility at the time of preparation of the projects and approval of projects.

On the basis of HFAPoA, States/Cities subsequently prepare the Annual Implementation Plans (AIPs) dividing the task upto 2022 in view of the availability of resources and priority. For larger cities, HFAPoA and AIPs is prepared at sub-city (ward/zone etc.) level with the approval of concerned State/UT Government. The result of demand survey, draft HFAPoA and draft AIP is discussed with the local representatives including MLAs and MPs of that area so that their views are adequately factored in while finalizing the plans and beneficiary list.

Cities which have already prepared Slum Free City Plan of Action (SFCPoA) or any other housing plan with data on housing, utilize the existing plan and data for preparing "Housing for All Plan of Action" (HFAPoA). Houses constructed under various schemes should be accounted for while preparing HFAPoA

and Slum Households Information System. (Guidelines and software for development of the MIS will be issued by the Ministry of HUPA);

11. Integration of Slum MIS with GIS Maps to enable the preparation of GIS-enabled Slum Information System that is to be used for the preparation of meaningful Slum Development Plans and Slum-free City Plan using a city-wide/zone-based approach. (Guidelines and software for development of GIS platform and its integration with the MIS will be issued by the Ministry of HUPA);

Introduction to Pradhan Mantri Awas Yojana (PMAY)

Pradhan Mantri Awas Yojana (PMAY), a path breaking scheme for the slum dwellers and urban poor envisages a 'Pucca house to every family' through encouraging States to tackle the problem of slums in a holistic manner. It calls for a multi-pronged approach focusing on:

- Bringing existing slums within the formal system and enabling them to avail of the same level of basic amenities as the rest of the town.
- redressing the failures of the formal system that lie behind the creation of slums.
- Tackling the shortages of urban land and housing that keep shelter out of reach of the urban poor and force them to resort to extra-legal solutions in a bid to retain their sources of livelihood and employment.
- Enactment of a set of reforms at the state and city level related to inclusive planning, regulation and financing, which would ensure that adequate fresh housing stock and services get created on an ongoing basis to address both current and future needs of cities.
- An integrated approach covering shelter, services and livelihoods for poor slum communities.

The duration of Pradhan Mantri Awas Yojana [PMAY] 2015 TO 2022

Eligible Components of the PMAY:

Allotment of Houses

Allotment of dwelling units will be in the name of the female member of the. Alternatively, it can be allotted in the name of husband and wife jointly. Ownership of land required for every Beneficiary.

A EWS beneficiary family will comprise husband, wife and unmarried children. The beneficiary family should not own a pucca house (an all weather dwelling unit) either in his/her name or in the name of any member of his/her family in any part of India to be eligible to receive central assistance under the mission. EWS households are defined as households having an annual income up to Rs.3,00,000 (Rupees Three Lakhs). States/UTs shall have the flexibility to redefine the annual income criteria as per local conditions in consultation with the Centre.

Following infrastructure will be considered for support under PMAY:

1. Water connection & Toilet facilities
3. 24 x 7 Electric facilities & Roads

Need for Projects

This development project models will give benefits in the city. One of the key objectives of developing the Projects is to incentivize innovation and encourage new approaches and solutions that can demonstrably improve the quality and quantity of shelter and services for the poor.

Such innovation could encompass:

- Projects with strong community participation i.e. Slum upgradation/redevelopment projects initiated/spearheaded by the community; or with their demonstrable involvement and participation in design, planning and implementation
- New models of public-private partnerships whereby the private sector can be encouraged to take up affordable housing for the EWS/LIG.
- Innovations in planning, demonstrating integrated livelihoods, shelter and services; or convergence.
- Innovative or cost effective and green building design and technologies.
- Financial innovations in delivering the city/state wide programme.

Aims and Objectives

Vision

The mission seeks to address the housing requirement of urban poor including slum dwellers through following programme verticals:

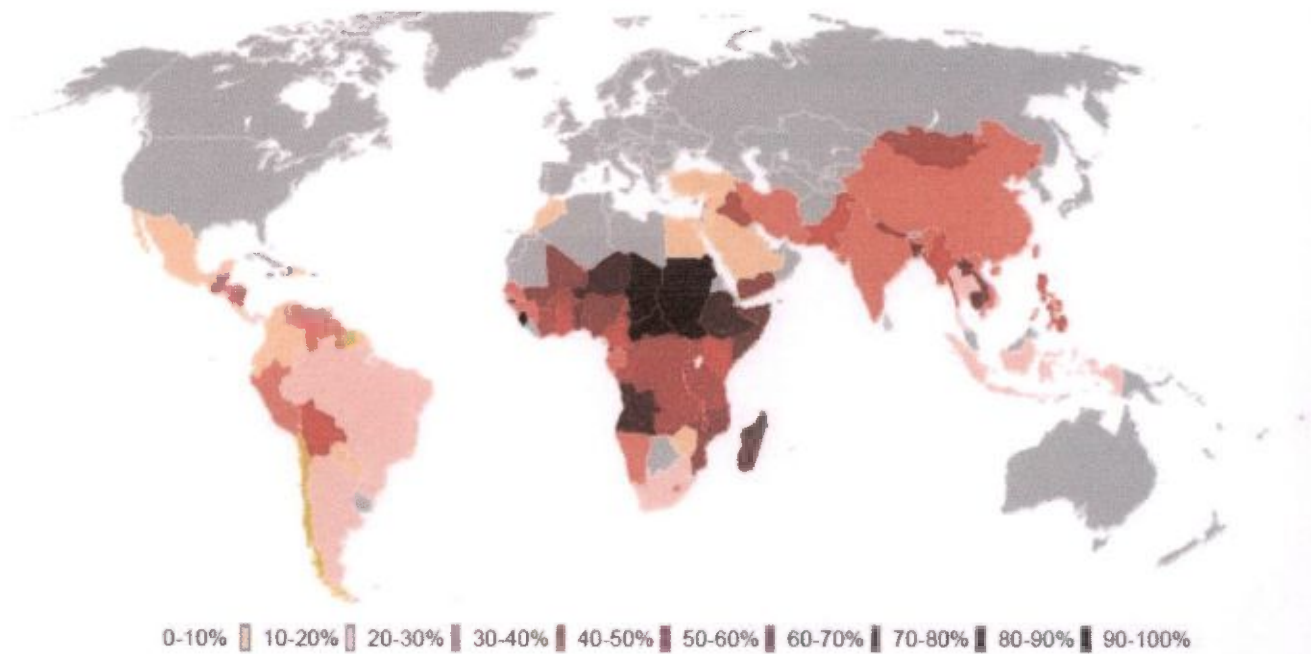
- Slum rehabilitation of Slum Dwellers with participation of private developers using land as a resource
- Promotion of Affordable Housing for weaker section through credit linked subsidy
- Affordable Housing in Partnership with Public & Private sectors
- Subsidy for beneficiary-led individual house construction

Objectives

The project has been designed keeping in mind the following objectives.

- Integrated development of all existing slums, notified or non-notified, i.e., development of infrastructure and housing in the slums/rehabilitation colonies for the slum dwellers/urban poor, including rental housing.
- Development/improvement/maintenance of basic services to the urban poor, including water supply, sewerage, drainage, solid waste management, approach and internal road, street lighting.

- The Creation of affordable housing stock, including rental housing with the provision of civic infrastructure and services, on ownership.
- Encouraging Public Private Partnership by having pay and use toilets and educate the slum dwellers for keeping the environment clean and hygienic.

The Nodal Ministry and National Mission Directorate is Ministry of Housing & Urban Poverty Alleviation, Government of India.

The Nodal Department for West Bengal is Municipal Affairs Dept. (M.A. Department), Government of West Bengal. The state level Nodal Agency is State Urban Development Agency (SUDA) under M.A. Department. State Urban Development Agency was set up in 1991 with a view to ensuring proper implementation and monitoring of the centrally assisted programmes for generating employment opportunities and alleviation of poverty throughout the State. SUDA is a Society registered under the West Bengal Societies Registration Act, 1961.

Definition of Slum for Housing

Different definitions of a slum exist in different statutes and in urban poverty literature. For the purpose of HOUSING SCHEME, it is proposed to adopt the definition given in the 2001 Census, which is as follows:

- All areas notified as 'Slum' by State/Local Government and UT Administration under any Act;
- All areas recognized as 'Slum' by State/Local Government and UT Administration, which have not been formally notified as slum under any Act;

'Slum' or 'Slum Area' – is a compact settlement of at least 20 households (For NE & Special Category States it is 10-15 households) with a collection of poorly built tenements, mostly of temporary nature, crowded together usually with inadequate sanitary and drinking water facilities in unhygienic conditions.

Situation Appraisal

The people living in the slums mostly have kutcha (10) and semi-pucca (186) housing. In certain cases where pucca housing is available, they are usually in dilapidated condition. The kutcha houses are in very poor condition and require extensive repairs. Most of the houses have tiles on roof. While during the survey some of the houses have been noted to be in average condition, the quality of these houses is also speedily deteriorating.

Proposed Intervention

In line with the vision to '**housing for all**', an integrated housing programme is proposed to be

implemented. The target will be all the slum /Non Slum dwellers in the pocket.

Building Plan

The buildings are proposed to cover an area of approximate 32 Sq.mt along with provision of 2 rooms, kitchen and sanitation facility. The layout, size and type design of housing dwelling units depends on the local conditions and the preferences of the beneficiary. The houses, has been designed in accordance with the desire of the beneficiaries, keeping in view the climatic conditions and the need to provide ample space, kitchen, ventilation, sanitary facilities, etc. and the community perceptions, preferences and cultural attitudes.

In line with the scheme, carpet area of the house will be not less than 25 sq. mts and preferably two room accommodation plus kitchen and toilet should be constructed.

Compliance with Municipal Bye laws

All designs & drawings are created keeping in line with the municipal bye laws.

Structural Design

- Following are the general considerations in the analysis/design.
- For all structural elements, M20 grade concrete and Fe 415 grade of steel is used.
- Plinth beams passing through columns are provided as tie beams.
- Pedestals are proposed up to ground level.
- Beam Centre-line dimensions are followed for analysis and design.
- For all the building, walls of 250 mm and 125mm thick with 20 mm External plaster and 12 mm thick internal plaster are considered.
- Seismic loads are considered acting in the horizontal direction along either of the two principal directions.

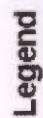

1.5.2 Summery of findings of Demand Survey

Housing for All (HFA) Scheme has since been launched by the Ministry of Housing & Urban Poverty Alleviation (MoHUPA), Gouvt. of India in Mission mode which envisages provision of Housing for All by 2022 when the Nation completes 75 years of its Independence. The Mission seeks to address the housing requirement of urban poor including slum dwellers through following programme verticals:

- a) Redevelopment of slums with private participation
- b) Promotion of affordable Housing for weaker section through credit linked subsidy
- c) Affordable Housing in partnership with public sectors
- d) Subsidy for beneficiary-led individual house construction.

In compliance with the objective and as per direction of the Ministry of Housing & Urban Poverty Alleviation (MoHUPA) and State Urban Development agency(SUDA), West Bengal was undertake a demand survey through suitable means for accessing the actual demand of housing. For this mission Sonamukhi Municipal area undertook Demand survey on 25.09.2015 and completed the survey on 30.09.2015. From this survey, different information have been took off.

As on September 2015, Sonamukhi Municipal area had a total of 51 slums spread across all the 15 wards of the municipality. The population of Sonamukhi Municipal area is 29085 (Census, 2011) of which number of persons residing in slums are 11333 (USHA Survey, 2013) which is about 39% of the total population. As per the USHA survey, a total of 2862 households stay in slums.

1.5.3. Broad infrastructure status in slum areas

Basic Services :(Housing, in front road, drainage, water supply, electricity, etc)

To upgrade the standard of life of slum dwellers, proper housing with sanitation facility is the crying needs of the present days. Development of this basic infrastructure is the first and foremost need for up-gradation of the living standard of slum population. A detailed survey regarding Pocket-wise identification of existing houses in the slum areas have been carried out and total of 2862 nos. of holding have been found in all the slums, out of which 5230 nos of holdings are good and 3255 Nos.(76.13%) houses have been proposed to attention for construction under PMAY Programme intervention.

1.6 Tenability Analysis:

Tenable Slums:

- 1. All slum pockets located on non-objectionable and non-hazardous sites as obtained from NBO formats.
- 2. As per “Model Property Rights to Slum Dwellers Act, 2011”- All slums settlements which do not fall within the definition of untenable settlements are considered as tenable and fit for in-situ redevelopment / improvement.
- **Untenable Slums**
- (i) As per NBO format, slum pockets in the following locations may be considered as untenable
 - Major storm water drains, Other drains, Railway line, Major transport alignment, River or water bodies Bank , River or water bodies Bed and others (hazardous or objectionable) including high tension lines.
 - However, slums on other drains may be examined for being included in the category of semi tenable or tenable
 - Slums depending on the exact location of the slum and the possibility of in---situ development through sustainable engineering solutions
- (ii) As per “Model Property Rights to Slum Dwellers Act, 2011”
- Those settlements which are on environmentally hazardous sites, ecologically sensitive areas, prohibited areas around heritage sites and land marked for public spaces, utilities, services and infrastructure.

2. Assessment of existing and likely future Housing Shortage

2.1 Existing Housing Shortage

Housing Shortage with regard to the Sonamukhi Municipal area has been analyzed on the basis of information available through Demand Assessment survey, Census Records, Stakeholders' consultation, State level and National level reports and policies.

As prescribed by HFA Guidelines the housing shortage is assessed by adopting two pronged approach. They are:

- I. **Curative Approach:** The housing shortage or deficiency for the existing slums and non slum is worked out at 3255 units and is summarized in the following table:

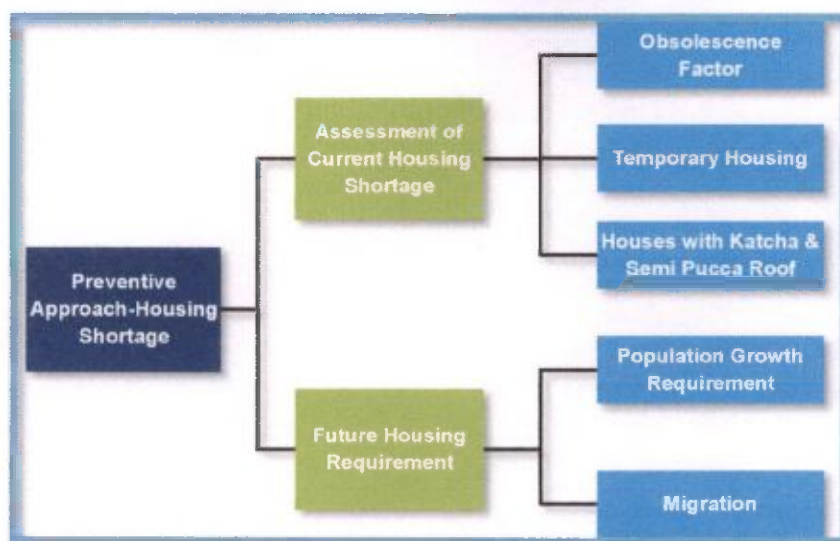

1.2 Preventive Approach: The preventive approach is aimed at prevention of new slums by providing for adequate affordable housing for the migrant population and for the persons, who due to lack of affordable housing options may shift to slums. Preventive approach takes into consideration both the existing housing shortage and housing units that may be required in the future.

2.2. Likely future Housing Shortage

According to the Census 2001, the population of Sonamukhi was 27348 and according to census 2011 Population is 29085. Population density is 3399. It is seen that population is

increasing by decreasing rate. The additional housing Requirement for the Sonamukhi Municipality estimated from 2016 till 2022 is 318.
