A draft on Year-wise Road Map of PMAY Projects within Mission Period (2015-2022)

As per requirement a tentative year wise road map in connection with implementation of PMAY-HFA (U) in different verticals is placed herewith.

State has taken steps to finalize the year wise Road Map of the programme by July 2017. However, it may be mentioned that, in the last two financial years i.e., 2015-16 & 2016-17; 1, 43,544 Dwelling Units in BLC mode were sanctioned by Govt. of India, which are under implementation.

State has also taken a special initiative with all PSBs those who are functioning as PLIs in association with HUDCO & NHB, the Central Nodal Agencies to increase the coverage through CLSS mode.

It may be mentioned that State has decided to cover about 2,50,000 DUs in CLSS mode, about 2,00,000 DUs in AHP mode specially in the 7 Municipal Corporations and their adjoining areas, about 1,50,000 DUs in Enhancement mode and about 2, 50,000 DUs in BLC mode in the remaining Mission period (2017-2022).

Figures of the annexed table marked 'X' and pre-page note was examined and found to be in order. In a nutshell this can be stated that out of the total 74,880 number of dwelling units, sanctioned for the year 2015-16 under PMAY (HFA-U), at present 56,918 number of dwelling units has already been grounded within 108 nos. of ULBs.

So far SUDA has received Rs 633.19 Crore as State Share for construction of 74,880 number of dwelling units, as 1st instalment i.e. equivalent to 40% of total requirement.

Now, if the already grounded dwelling units are to be completed immediately, an amount of Rs 570.06 Crore will be required as State Share.

Finance Department may be moved separately for allocation of Rs 570.06 Crore as State Share, which is due for construction of total 74,880 number of dwelling units as State Share for the year 2015-16. This will facilitate completion of already grounded 56,918 number of dwelling units.

**Sub: Requirement of residual State Share for HFA (U) for the
FY 2015 - 16**

It may be recalled that, for one hundred and eight (108) projects approved in FY 2015-16, a total 74, 880 Dwelling Units were sanctioned. Till date we have received 40% as 1st installment as Central Share from Ministry of Housing and Urban Affairs (MoHUA), GOI, amounting Rs. 449.28 Crores. SUDA has also received the corresponding State Share from Department of Urban Development and Municipal Affairs (UD & MA) amounting to Rs. 633.19 Crores which includes cost of Dwelling Unit and Infrastructure Development.

Utilization Certificates (UCs) in GFR - 19A are being sent to Ministry of Housing and Urban Affairs (MoHUA), GOI, claiming Rs. 449.28 Crores of Central Share and Utilization Certificates in SR - 330A, stating utilization of Rs. 633.19 Crores of State Share including Infrastructure Development are also being submitted to UD & MA Department, GoWB. Copies of the UCs are placed in file for kind perusal.

Repeated requests to MoHUA, GOI has been made for immediate release of 2nd installment of Central Share, considering the present progress of HFA (U). It is also worthwhile to mention that compliances and prerequisites for claiming 2nd installment of Central Share like TPQMA Reports and Action Taken Report (ATR) as desired by GOI has been prepared from our end.

Now, anticipating that the 2nd installment of Central Share amounting Rs. 449.28 Crores will be received shortly and considering the progress (No. of Dwelling Units grounded: 60,360 and average completion of around 2,000 Dwelling Units per month) it is imperative that for completion of 60,360 grounded Dwelling Units Rs. 698.97 Crores $[60,360 \times 1.93 \times 60\%]$ and for completion of Infrastructure Development works Rs. 66.64 Crores $[60,360 \times 0.184 \times 60\%]$ is required, totaling Rs. 765.61 crores.

Director, SUDA has submitted a proposal mentioning requirement of fund for completion of 60,360 number of dwelling units which are under construction under PMAY-HFA (U).

Actually for the initial year that means 2015-16, 74880 dwelling units were sanctioned under this project out of which 60360 no. of dwelling units are already grounded and are in various stages of construction.

SUDA has received 40% of total project cost (first instalment) as Central-Share as well as correspondent matching State-Share.

As per funding pattern of this scheme, 1.93 lakh is provided as State component for each dwelling unit.

Director, SUDA has proposed that for completion of 60360 grounded dwelling units remaining State-Share that means $60360 \times 1.93 \times 60\% = 698.97$ crore + 60% of the entitled infrastructure cost which equals to 66.64 crore may be sanctioned and placed in favour of SUDA.

Claim for release of remaining Central-Share has been submitted to Ministry of Housing and Urban Affairs, GoI.

Finance Department may be requested to consider release of Rs $(698.97 + 66.64)$ crore = 765.61 crore as State-Share so that the construction of the grounded projects can be continued. These are likely to be completed by March 2018.

If approved, file may be moved to Finance Deptt. through Budget wing of MA Branch.

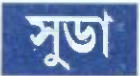
