TECHNICAL SPECIFICATION FOR STATIONARY / PORTABLE COMPACTOR OF 10.5 CUBIC METER CAPACITY

GENERAL DESCRIPTION

A stationary type compactor capable of being transported from one location to another. It is to come as an integral unit incorporating the container and the compaction unit.

The Compactor to be such that can be transported by a specially designed Hook loader / dumper placer unit mounted on a 16T GVW truck chassis.

One hydraulically operated device to receive and unload the waste in to container i.e. Tip cart capacity should be approx. 450 litre.

All Hydraulic Cylinders and allied components and all hydraulic pumps must be from manufacturers of ISO 9001: 2008 certified.

- A compactor container body shall be 10.5 cum so that the same can be lifted by Hook Loader mounted on 16 b) MT GVW chassis for transportation and unloading of compacted garbage at the dumping ground.
- The compactor shall be of front loading type with a hydraulic operated device to receive waste from hand cart c) approx 2 to 3 hand carts / 1 to 2 tricycle vans at a time and unload the same waste in to the container.
- The container shall be provided with leachate collection tray for collection of leachate during compaction of d) garbage & there should be suitable drainage system to the nearby MUNICIPAL drain. The leachate should not drop on road during transportation.
- e) The size of charge chamber of the compactor shall be minimum 2 cum.

Commercial Terms & Conditions:

- 1) Payment terms:
 - a) All payments will be made by the respective Municipal Authority.
 - 80% of contract price of Compactor after receipt of equipment/vehicles at respective Municipal garage.
 - c) 10% of contract price after trial run & commissioning & training of Municipal personnel.
 - d) 5% of the contract price after successful and satisfactory O&M of one year.
 - e) 5% of the contract price after successful and satisfactory O&M of another two years.
- N.B.- Withheld contract price for O&M i.e. 5%+5%=10% may be considered by the authority for release receipt of bank guarantee of equivalent amount valid up to completion of O&M period.
 - 2) Inspection will be done at manufacturing site of bidder.
 - 3) There shall be complete integrated free warranty for an initial period of 36 months.
 - 4) Supply should be completed preferably within 60 days and not beyond 120 days from the date of issue of LoI / Work Order.
 - 5) Delay fine: 2% Penalty for delay beyond contract delivery period will be chargeable on pro rata basis for the number of day of delay on undelivered quantity.
 - 6) Earnest Money to be deposited along with Technical bid and will be retained by the State Urban Development Authority till delivery, successful commissioning and training of Municipal personnel are completed.
 - 7) Bidder registered under NSIC for compactors will be exempted from Earnest money deposit only but all other terms & condition shall have to be abided by as per norms.
 - 8) Price should be for respective Zone, inclusive of all taxes & duties, freight, final registration, comprehensive insurance, trial run & training.
 - 9) Price quoted should be firm and should remain valid up to 120 days from the date of opening of tender.
 - 10) Bank Guarantee towards performance security @ 10% of contract price of compactors to be deposited which shall be retained by respective Urban Local Body for the entire warranty period of 36 months.
 - 11) List of spares & consumables for 3 years maintenance period with individual rate should be mentioned but not to be included in the offered price.
 - 12) Delivery to be made to respective Municipality garage.

TERMS AND CONDITIONS FOR CONTRACTUAL OPERATION AND MAINTENANCE OF STATIONARY/POTABLE COMPACTOR.

Contractual Operational Part

- 1. SCOPE OF WORK & TERMS AND CONDITIONS FOR OPERATION OF PORTABLE COMPACTORS:
 - a. The work consists of Operation of Portable Compactor at different compactor stations within ULB area.
 - b. All the types of Garbage (solid waste) brought at garbage collection point shall have to be loaded & compacted with the help of stationary Compactor placed at the site from 6 a.m to 6 p.m on every day including Sundays & Holidays. The garbage collection sites facilitated with such adequate no. of Compactors containers shall be maintained nuisance free & other mechanical devices which are required for the work to be carried out by providing suitable staff for the purpose.

- c. The sites where above compactors will be installed should be swept clean, if there are any dropping of waste from hand carts /cycle van/bins during loading .The sites should remain disinfected also throughout the day.
- d. The compactor area should be free from garbage . There should not be any garbage outside the compactor.
- e. The agency will be responsible for taking care of the total equipment installed in the Garbage Collection point including electrical supply machineries throughout the day.
- f. The compaction work to be done daily in each collection point failing which the agency will have to pay Rs. 10,000 per day as penalty charge if the conservancy service is delayed or failed due to non-availability / shortage of manpower. However, two day's in fortnight will be allowed as non-operational for periodical maintenance subject to maintaining a minimum of 315 days in a year.
- g. Normal security arrangement to be made by the agency.
- h. Necessary shed over the garbage collection point to house the equipment, container, drainage connection facilities, construction of platform as required, electricity supply will be provided by the ULB.
- i. The successful tenderer will have to comply with all applicable statutory obligations relating to i) the machine and also for ii) deployment of labor applicable in the ULB.
- j. Rate to be quoted for three (3) years of O & M.
- k. Payment will be made as per the ULB payment schedule.
- 1. No service tax will be provided by the ULB.
- m. Sub-contracting for operational only may be allowed. But the entire responsibility will remain with the supplier.
- n. There shall be no penalty during the period when the equipment/vehicles are under repair due to accident. Provided conservancy service is not hampered for which Department will keep one stand by compactor.
- o. Through the work is for 03 years, review will be done after completion of each year by the ULB & the ULB will have the right to terminate the contract with prior notice of one month if the ULB authority desires so after assessing their performance of previous year.

2. SCOPE OF WORK & TERMS AND CONDITIONS FOR OPERATION OF PRIME MOVERS (HOOK LOADER):

- a) The work consists of loading of loaded compactor with Hook Loader, on the Vehicle, transportation and disposal of loaded compactors at the ULB Dumping Ground including placement of empty Compactor at the same point and the same system will continue till the clearing operation is completed.
- c) The compactor container to be removed by the prime movers immediately after completion of compaction as per capacity from the collection point & empty compactor is to be provided at the point.
- d) The prime mover will be operated on all days in a month including Sundays & Holidays from 6 a.m to 6 p.m. However duty hours may be changed as per requirement of the department. In case of break down /accident no extra payment will be made for extra time duty.
- e) Driver must have at least 3 years Heavy driving license & capacity to drive vehicle efficiently in dirty & muddy road such as at the ULB Dumping Ground.
- f) Driver must have his own mobile telephone which will remain open throughout the day so that communication can be made by the department as and when required.
- g) During duty hours if any driver is found intoxicated he will be suspended immediately and the agency will provide his substitute on the next day.
