Sub: DPR of Integrated Solid Waste Management Project of Durgapur MC

The Detailed Project Report (DPR) for implementation of Integrated Solid Waste Management Project of Durgapur Municipal Corporation (Placed at **CP-1 & CP-6**) has been prepared by the ULB itself and Municipal Engineering Directorate (MED) has appraised the DPR (placed at **CP-2 to 5 & CP-7**).

The Salient features of the Project are:

- Primary (Door to Door) Collection Segregation at source
- Secondary Transportation Separate Transportation Chain for Bio-degradable and Non-bio-degradable wastes
- · Optimization of Transportation Facilities including utilization of existing system.
- Further Segregation & Sorting (if required)
- Waste to Compost through Windrow Method with the capacity of 320 Million Ton Per Day (MTPD)
- Development of Land fill site
- Land available 10 acre, owner is ULB
- Population Coverage: all the 563557 no. of population of Durgapur MC
- Project Implementation Period: 2 Years
- Total anticipated Project Cost is Rs. 64.31 Crore

Estimated Cost and Funding Pattern of the Project:

Government of India, in the Guideline of Swachh Bharat Mission (Urban) at Para-7.10 & 7.10.5 and in the Office Memorandum for Revision/Modification of MoUD mentioned that for Solid Waste Management Projects GoI share will be 35% of the total project cost subject to the condition that the State contribution will be minimum 25% funds to match 75% Central Share i.e. $1/3^{rd}$ of Central Share.

Hence, out of the anticipated total project cost of **Rs. 64.31 Crore**, Gol Share will be Rs. 22.51 Crore (35%) and Mandatory State Share will be Rs. 7.50 Crore.

In the earlier sanctioned DPRs under Mission Nirmal Bangla (Urban), the ULB Share approved was 5% of total project cost for below 10 Lakh population ULBs and 10% of total project cost for above 10 Lakh population ULBs and the remaining over Central Share, State Share and ULB Share has been allotted as Additional State Share.
