With reference to the subject and references as mentioned, the Commissioner, Kolkata Municipal Corporation, had submitted that to averting the trouble of using of two 28 year old big carcass vehicles, the Solid Waste Management Department of Kolkata MC had proposed to purchase one new carcass vehicle with tentative initial cost of around Rs. 30 lakh (vide MOA 56.8 dt. 08.01.2018) **(placed at Flag – A).**

The cost was considered in a sanctioned project "Modernization of Solid Waste Management in Ward No. 77 under KMC", approved by the MA & UD Department, Govt. of West Bengal.

On obtaining the approval of Mpl. Commissioner on 29.05.2018 and Hon'ble MMIC/SWM on 05.06.2018, the SWM-II department had placed the proposal before the KMC Works and Tender Committee on 12.06.2018. After getting necessary clearances from the KMC Works Committee, the Dy. Chief Engineer (M)/SWM-II/KMC had invited the tender for purchasing one carcass van of minimum of 10T GVW, BS-IV **(placed at Flag – B).**

Due to non-availability of required number of technically qualified bidders, the 1st (only one bidder had participated) and 2nd call (no bidder had participated) of the tender had to be cancelled, while in the 3rd call of the tender, only one bidder, M/s. HYVA India Pvt. Ltd. had participated, giving a quotation of Rs. 26 lakh, against the departmental estimated value of Rs. 30 lakh. All the details of tenders invited by the Dy. Chief Engineer (M)/SWM-II/KMC had been given in Annexure – I, as mentioned **(placed at Flag – Annexure-I).**

Now, the file is placed for placing it to the **Departmental Tender Committee (DTC)**, for necessary approval of the same, so that the Tender Inviting Authority (TIA) may issue the Supply Order to the agency, if approved.
